1. STATUTORY INFORMATION

Andreas Krause Architects Ltd is a private company, limited by shares, registered in England and Wales. The company's registered number is 07005329 and its registered address is Unit A11 Jack's Place, 6 Corbet Place, London E1 6NN.

2. AVERAGE NUMBER OF EMPLOYEES

The average number of employees during the year was 9 (2018 - 7) .

3. DIRECTOR'S ADVANCES, CREDITS AND GUARANTEES

At balance sheet date the director Mr A. Krause owed the company £22,407 (2018: £54,087). The loan was interest free and the balance was repaid on 30th June 2020.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 30 September 2019.

The members have not required the company to obtain an audit of its financial statements for the year ended 30 September 2019 in accordance with Section 476 of the Companies Act 2006.
