

## **MOSHEN LIMITED – IN ADMINISTRATION SUMMARY OF THE ADMINISTRATION'S PROPOSALS**

In accordance with paragraph 3 and 49 of Schedule B1 of the Act, the Administrator proposes that,

- If no creditors' committee is formed, he be authorised to draw category 2 disbursements in accordance with the recovery policy of this firm which is attached herewith
