Voting

On a resolution at a general meeting on a poll, every member (whether present in person, by proxy or by corporate representative) shall have one vote for every share of which he is the holder. On a vote on a resolution at a general meeting on a show of hands each member (present in person, by proxy or by corporate representative) who would be entitled to vote on a poll at that meeting has one vote.

Any shares held by a member of a Departing Employee's Group shall, irrespective of whether the Board has served a notice requiring such member to transfer their shares in accordance with article 9 1 of the Company's articles of association, cease to confer upon that member the right to be entitled to attend or vote at any general meeting provided that this restriction shall cease in the event that the shares are no longer held by such member (or any other member of the Departing Employee's Group or, if earlier, upon a Sale or an IPO).

Dividends:

Each Ordinary Share shall rank equally for any dividends paid thereon.

Return of capital:

On a return of capital on liquidation, reduction of capital or otherwise, the surplus assets of the Company remaining after payment of its liabilities shall be applied in distributing the balance amongst the holders of the Ordinary Shares (pro-rata to the number of such shares held)
