NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 NOVEMBER 2020

1. GENERAL INFORMATION

Camcon Medical Limited "the company" is a private company limited by shares and is incorporated in England and Wales. The address of the registered office is Lakin Rose Limited, Pioneer House, Vision park, Histon, Cambridge CB24 9NL.

2. ACCOUNTING POLICIES

2.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The following principal accounting policies have been applied:

2.2 GOING CONCERN

The financial statements have been prepared on the going concern basis that assumes the company will continue as a going concern for the foreseeable future. The directors have received assurances from the majority shareholders of their continued support and believe it is appropriate to prepare the financial statements on the going concern basis.

2.3 RESEARCH AND DEVELOPMENT

Research and development expenditure is written off in the year in which it is incurred.

2.4 TAXATION

Tax is recognised in profit or loss except that a charge attributable to an item of income and expense recognised as other comprehensive income or to an item recognised directly in equity is also recognised in other comprehensive income or directly in equity respectively.

The current income tax charge is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the balance sheet date in the countries where the Company operates and generates income.

Deferred tax balances are recognised in respect of all timing differences that have originated but not reversed by the Balance Sheet date, except that:

- The recognition of deferred tax assets is limited to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits; and
- Any deferred tax balances are reversed if and when all conditions for retaining associated tax allowances have been met.

Deferred tax balances are not recognised in respect of permanent differences except in respect of business combinations, when deferred tax is recognised on the differences between the fair values of assets acquired and the future tax deductions available for them and the differences between the fair values of liabilities acquired and the amount that will be assessed for tax. Deferred tax is determined using tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

2.5 FINANCIAL INSTRUMENTS

8. RELATED PARTY TRANSACTIONS

The company has previously received loans from Lord Young of Graffham, a director and significant shareholder. As at 30 November 2020, the amount due to Lord Young of Graffham was £195,000 (2019 - £195,000). The loans are interest free and repayable on demand.

During the year the company received loans from Ki Corporation, a significant shareholder, of £25,000. As at 30 November 2020, the company owed £987,773 (2019 - £913,901) to Ki Corporation Limited. During the year interest of £48,871 was charged on this and previous loans.

During the year, Camcon Auto Limited, a company in which D R Chapchal and Lord Young of Graffham are directors and shareholders, made repayments of £13,631 and received loans of £12,521 from the company. As at 30 November 2020, the amount due from Camcon Auto Limited was £2,102 (2019 £3,612).

9. AUDITORS' INFORMATION

The auditors' report on the financial statements for the year ended 30 November 2020 was unqualified.
