Update of Partnership

Church of England

On 15th March Woodchurch High School hosted a group of Second Year Curates as part of their IME (Initial Ministerial Education), entitled 'School Matters' Aspects covered, Every Child Matters, Social and Emotional Aspects of Learning, as well as seeing how a secondary school operates

9th February, school hosted Wirral SACRE (Standing Advisory Council for Religious Education), and presented an overview of activities undertaken in Religious Studies, as well as the work of the Chaplaincy

6th-10th February, St Mary's Upton have taken two pupils for Work Experience, and have worked in their office as well as assisting in the Bank (the Youth Centre)

Rev L Bannon is also a co-opted member of the Diocesan Board of Education

The Headteacher attends the Wirral Church of England Headteacher Network meetings, run by the Diocesan Director of Education

School has established links with a variety of church primary schools, offering support and training. Schools where collaborative working has included

- Woodchurch C of E Primary School, Wirral
- Christchurch C of E Primary School, Birkenhead
- St Mark's C of E Primary School, Antrobus
- Oxton St Saviour's Primary School, Birkenhead

School has also developed links with the following C of E High Schools in the Diocese in order to share good practice and expertise

- Bishop's High School, Chester
- · Hartford High School, Hartford
- Sir Thomas Boteler School, Warrington

The Senior Leadership Team has benefitted from the support of Robert Haigh, consultant for the DBE During his sessions, Robert has worked with the SLT in supporting the thinking around the distinctiveness of a Church school

We were sorry that Nigel Brook resigned as a Trustee due to increased work commitments

Nigel's contribution was invaluable and he provided support and challenge Following conversations between Nigel and myself, it would seem to be a natural end to the partnership when we gain Academy Status

David Jenkins continues to be an excellent Chair of the premises Committee and we greatly appreciate his work in helping us to resolve some of the issues around the defects list

Liverpool Hope University

Woodchurch High School's contribution to the education of those who aspire to become qualified teachers is a well established part of the life of the school. In the past ten years I have worked as professional mentor with a variety of providers including Liverpoool Hope University but we have always accommodated more trainees on placements from Hope University than from any other HEI or other training programme

From October 2008 to July 2010 47% of those on PGCE placements came from Liverpool Hope. From October 2010 up to July 2011 that increased to 56%, an increase which reflected a growing commitment to ITE in the school as part of our Training School Specialism. More departments were getting involved in subject mentoring and Liverpool Hope supported the initiative by providing training for aspiring mentors. Hence the numbers of trainees has increased per semester from the mid teens pre 2010 to the mid twenties.

This year the long standing relationship with Liverpool Hope University has been reaffirmed by Woodchurch becoming one of the designated Training Colleges chosen to work together with a new model for ITE at Liverpool Hope. As a consequence 80% of our trainees on placement this academic year are from Liverpool Hope. We are still accommodating trainees from other programmes but they are fewer in number and subject mentors in Science and ICT are an example of two subject areas who had previously worked only with other ITE providers. The professional placement tutors, Mary Stevenson and Joy Schmack have been given 65 hours across the two semesters to work with Woodchurch High School. They have already helped me observing the first semester trainee cohort and Mary held a twilight session for established mentors as well as those wanting to get involved. Mark Turner and Tim Shelton both attended that session and are now embarking on taking on the responsibilities of subject mentors with second semester trainees from Liverpool Hope in the Religious Education Department.

Liverpool Hope University continues to endorse the work of the WITT programme in Wirral Schools, which is accommodated and run from Woodchurch High School and offers CPD sessions across the two semesters to 15 Wirral schools involved in ITE work. In addition our initiative to provide paired placements to trainees supports the University's endeavour to work with fewer schools who can accept multiple placements. This academic year we have also offered trainees the opportunity to work alongside and take on the role of a Teaching Assistant during their placement. Mr John Murphy the external moderator/ advisor from Liverpool Hope visited. Woodchurch High School in November 2011 and commented on how that particular initiative was regarded as an example of good practice in ITE.

In conclusion therefore, the relationship between Woodchurch High School and Liverpool Hope University goes from strength to strength, even in these uncertain times for Initial Teacher Training

In further supporting our partnership with Liverpool Hope University, we were delighted to welcome to Woodchurch High School 11 trainee teachers from

Chonnam University in South Korea The students spent two days in school observing lessons in a variety of curriculum areas. This initiative is the desire on the part of the Korean government to develop a greater measure of creativity in the day to day learning and teaching practices across the country and teaching force.

During their visit, the students were able to observe the various teaching methods employed by the staff at Woodchurch High School which directly involve pupils in their learning whilst maintaining high standards of achievement

Mr Cumberland continues to support the school as Vice Chair of Governors We greatly appreciate his skill and expertise, particularly in curriculum development and more recently during the redundancy procedures
