Encourage NW provides 2 x 6month term of activities, workshops and a programme of performances in the performing and visual, mainly classical arts. In 2015 the programme and activities have mainly been focused on the Merseyside and Wirral regions and lesser so in the Greater Manchester area as this is where our main membership resides 90% of our members are older women with the majority living alone or are widowed or single. The programme encourages this particular group to join in activities together and forms social groups for them to attend museums, galleries, theatres etc. Most of our membership would be unlikely to attend such events on their own or late at nights so our programme runs mainly during daylight hours

Most of our partner organisations are based in Liverpool or Manchester City centres, but events have taken place (and transport provided) to enable members to travel around the wider region in to Lancashire and Cheshire to other art and historical establishments

Each year members from the Manchester and Liverpool areas meet up for an annual Encourage Christmas celebration which is always very well attended and gives members a chance to exchange, views, ideas and plans with the steering group and volunteer coordinators Many of our members also now volunteer for various arts bodies around both cities including the Tate, Lowry and Liverpool Empire as well as community arts providers

We also provide ad hoc opportunities for members to meet and discuss specific activities with representatives from arts bodies within the programme, this is much appreciated by both our members and particularly our network of partners who provide activities, performances and workshops for us such as galleries, museums, NT establishments, theatres and travelling arts organisations such as English National Ballet, Welsh National Opera and various orchestras.
