**UPON the Applicants application by notice dated**

**AND UPON the Applicants confirming that notice of the application has been given to the Secretary of State in accordance with IR r. 7.10C(6)**

**AND UPON reading the evidence filed**

**IT IS ORDERED THAT:**

**Transfer**

1. The County Court proceedings listed in the Schedules to this Order be transferred to the High Court for the purposes of this application only and forthwith after the making of this Order be transferred back to the County Court from which they came.

**Removal of the Respondent from his office**

2. Pursuant to section 108 of the Insolvency Act 1986 ("the Act"), the Respondent be removed with immediate effect from office as a liquidator of:
  - 2.1. the companies listed in Schedule A and C to this Order in creditors' voluntary liquidation;  
and



- 2.2. the companies listed in Schedule B and D to this Order in members' voluntary liquidation.
3. Pursuant to section 172(2) and IR r. 7.10B(2), the Respondent be removed with immediate effect from office as liquidator of the company listed in Schedule E to this Order in compulsory winding up.
4. Pursuant to section 298 of the Act and IR r. 7.10B(2), the Respondent be removed with immediate effect from office as trustee in bankruptcy of the individual listed in Schedule F to this Order.

**Appointment of the First Applicant to offices in place of the Respondent**

5. Pursuant to section 108 of the Act, the First Applicant be appointed with immediate effect as joint liquidator (the Second Applicant already holding that office) of:
  - 5.1. the companies listed in Schedule C to this Order in creditors' voluntary liquidation; and
  - 5.2. the companies listed in Schedule D to this Order in members' voluntary liquidation.
6. Pursuant to section 168(3) and 168(5) and IR r. 7.10B(2), the First Applicant be appointed with immediate effect as joint liquidator (the Second Applicant already holding that office) of the company listed in Schedule C to this Order in compulsory winding up.
7. Pursuant to section 298 and 303(2) of the Act and IR r. 7.10B(2), the First Applicant be appointed with immediate effect as joint trustee in bankruptcy (the Second Applicant already holding that office) of the individual listed in Schedule F to this Order.

**Appointment of the Second Applicant to offices in place of the Respondent**

8. Pursuant to section 108 of the Act, the Second Applicant be appointed with immediate effect as joint liquidator (the First Applicant already holding that office) of:
  - 8.1. the companies listed in Schedule A to this Order in creditors' voluntary liquidation; and
  - 8.2. the companies listed in Schedule B to this Order in members' voluntary liquidation.

**Notifications**

9. Service of this application on the Respondent is dispensed with.
10. The Applicants shall notify the Secretary of State of this Order as soon as reasonably practicable after it is made.
11. The Applicants shall ensure that a sealed copy of this Order and every Order which may be made as a result of the Application is lodged with the court having jurisdiction over each case affected by such orders for filing on the court file relating to that case.
12. Within 28 days of this Order, the Applicants shall give notice of this Order to all the creditors of the companies and individuals listed in the Schedules to this Order by way of advertisement in the *London Gazette*.

13. All creditors of the companies and individuals listed in the Schedules to this Order shall have permission to apply within 28 days of the said advertisement in the *London Gazette* to vary or discharge this Order insofar as it affects the company, or companies or bankrupts' estates of which they are a creditor. Any such application shall be made on 3 clear days' notice to the Applicants.
14. The provisions contained in IR r. 4.49B(5), r. 4.49C(3) and r. 6.78A(4) shall not apply and neither the Respondent nor the Applicants are required to produce any progress reports on the Respondent ceasing to act as an office holder pursuant to this Order. Each of the insolvencies in the Schedules to this Order shall retain their original reporting dates.

#### Costs

15. The costs of this application shall be borne by the Applicants and neither the Applicants nor the Respondent shall have recourse to the insolvency estates of any of the companies and individuals listed in the Schedules to this Order for the purposes of satisfying their costs of this application.
