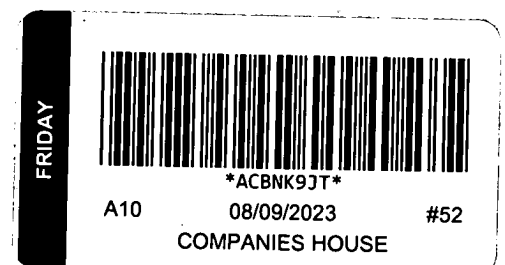

**NOTES TO THE FINANCIAL STATEMENTS – FOR THE YEAR ENDED 31 DECEMBER 2022****1. CORPORATE INFORMATION**

Entain Services Limited ('the Company') is a private company limited by shares incorporated and domiciled in England and Wales within the United Kingdom. The address of its registered office and principal place of business is disclosed in the Directors' Report.

The financial statements of the Company for the year ended 31 December 2022 were authorised for issue in accordance with a resolution of the directors.

**2. BASIS OF PREPARATION**

These accounts are an amended version and replace the original accounts. They have been prepared at the same date as the original accounts and are now the statutory accounts for the year ended 31 December 2022.

These financial statements were prepared in accordance with The Companies Act 2006 as applicable to companies using Financial Reporting Standard 101 Reduced Disclosure Framework (FRS 101) and in accordance with applicable accounting standards. The financial statements are prepared under the historical cost convention. Following cessation of trade, the financial statements are now presented in the functional currency of GBP.

The Company acquired 100% of the ordinary share capital of Rousset Capital Limited, a Company incorporated in England and Wales, on 1 January 2012.
