**Basis of preparing the financial statements**

The financial statements have been prepared on a going concern basis. At the balance sheet date the company's liabilities exceeded its assets by £158,555 (2015: £157,446). Included within liabilities are amounts owed to fellow group companies amounting to £166,943 (2015: £167,343). The director has confirmed that these companies will not seek repayment of these balances if it proved to be prejudicial to the company.

**Accounting convention**

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015).
