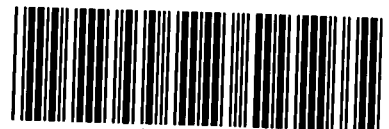

During the year the average number of employees was 4 (2021: 4).


