1 INTRODUCTION

- 1.1 Steve Markey and Paul Masters were appointed Joint Liquidators of Ingleby (1845) Limited ("the Company") by the members on 11 October 2018.
- 1.2 Steve Markey and Paul Masters are authorised to act as insolvency practitioners in the UK by the Institute of Chartered Accountants in England and Wales under office holder numbers 14912 and 8262, respectively.
- 1.3 There has been no change in office holder since the date of Liquidation.

2.2 The directors' sworn declaration of solvency referred to a directors' loan accounts of £1,040,800. These loans were repaid, in full, after the declaration of solvency was sworn and the funds were paid into the Company's bank account.

- 2.3 The directors' sworn declaration of solvency referred to a balance at bank of £132,162.
- A balance of £1,172,932 was received from the Company's former bankers and the account was closed. The difference in the balance received was due to the repayment of the directors' loans as referred to above.

2.5 There were no unrealisable assets.

Disbursements

Information we collect and hold about you

By requesting details of your claim in this insolvency, we may collect Personal Data from you, particularly if you are a consumer creditor, a sole trader or are lodging a claim in your personal capacity.

Personal Data is information relating to a living individual. Whenever Personal Data is processed, collected, recorded, stored or disposed of it must be done within the terms of the General Data Protection Regulation ("the GDPR"). Examples of Personal Data include but may not be limited to your name, address, telephone number and email contact details.

If you do not provide us with the information we require, this may adversely affect our ability to deal with your claim, but we would ask you not to submit more Personal Data than we request from you.

Legal justification for processing your Personal Data

The processing of your Personal Data by us is necessary to enable us to comply with legal obligations under the Insolvency Act 1986 and associated legislation which we are subject to as Insolvency Practitioners.

How we use your information

All information you supply to us is required to enable us to comply with our duties under the Insolvency Act 1986 and associated legislation. It will be used to enable us to assess the extent of the insolvent entity's liabilities, to allow you to vote on any decision procedures, to enable us to communicate with you, to process your claim and to pay any dividends which may be due to you from the insolvent estate.

Who we share your information with
