Hoylake Village Life Community Interest Company Annual Report for the year ended 29 September 2019

Welcome to our Annual Report for the year to 29 September 2019.

This Report provides an overview of the activities and financial performance of HVL for the period.

HVL's only source of income continued to be from our Hoylake Community Cinema project.

In October 2018 moved to the much larger premises at Hoylake Old Town Hall, which was an overwhelming success. The new facility allowed us to increase capacity to 170 seats, have a much larger cinema screen, high quality audio and larger bar.

Whilst some of the costs of equipment were met with available HVL funds, the bulk of the cost were borne by HVL directors in the form of a repayable 'loans'. Many of the subsequent screenings throughout the year were full houses. The volunteer team grew to 15 people, all of whom devoted an enormous amount of time to the project. It is estimated we had over 1,500 audience members during the year.

In March 2019 we were thrilled to learn that the £3.64 million Coastal Communities Funding bid for the Hoylake Beacon Arts Village project, which HVL had developed along with owners Hylgar Properties Ltd. over the preceding four years, had been successful. HVL's Coastal Revival Funding bid for £37,500 for feasibility and consultancy work was also approved on the same day. However an ultimately rejected complaint from a member of the public, supported by a ward councillor with whom the complainant was in business, meant the funding did not come through within the report period and is therefore not shown in these accounts. This was extremely disappointing and caused significant strain on our resources but we continued to liaise with MHLG and WMBC to resolve the issue throughout the year.

The final Community Cinema screening was held on 27 September 2019 and the first phase of construction work for the new cinema and arts centre was scheduled to begin shortly afterwards.

During the period HVL Directors had further meetings with officers and members of Wirral Council and also met with Nicklaus Joint Venture Group (NJVG) with a view to influencing their proposed Hoylake Golf Resort project, following the evident public preference for HVL's alternative **Eco Golf Resort and Wildlife and Wetlands**Centre proposals. However in July 2019 Wirral Council made the decision not to proceed with a £26 million loan to NJVG which resulted in putting the project on hold. HVL continued dialogue with NJVG with the aim of influencing the project should it go ahead.

HVL continued to grow the Hoylake social media channels, helping to promote local businesses and organisations.

In line with our 'Sustainable Vision for Hoylake Beach' project which began in 2011, we also continued throughout the period to lobby the council to obtain up-to-date specialist scientific advice about the geomorphological changes on Hoylake Beach, which have led to a significant increase in vegetation in recent years, in the run up to the impending expiry of the Beach Management Agreement between WMBC and Natural England, with the aim that future beach management will be based on a more up to date evidence base than has been done in the past.

The directors and supporters of HVL continue to work towards improving the environmental and economic sustainability of the town.
