Notes

1 Accounting policies

The Company financial statements have been prepared and approved by the Directors in accordance with UK Accounting Standards and applicable law (UK Generally Accepted Accounting Practice).

The accounting policies set out below have, unless otherwise stated, been applied consistently to all periods presented in these financial statements.

Basis of preparation

The financial statements have been prepared in accordance with applicable accounting standards, and under the historical cost convention.

Going concern

The financial statements have been prepared on a going concern basis, notwithstanding the fact that the Company has net liabilities of £1,625,000 at 30 June 2015. This is because the Directors are satisfied that the Group's ultimate parent Company, Sturrock and Robson International B.V. will grant it access to a Group wide credit facility should this be required. The Directors consider that this should enable the Company to continue in operational existence for the foreseeable future by meeting its liabilities as they fall due for payment. The Directors acknowledge that there can be no certainty that this line of credit will be granted should it be required although, at the date of approval of these accounts, they have no reason to believe that it will not do so.

The Company is exempt by virtue of s400 of the Companies Act 2006 from the requirement to prepare group financial statements. These financial statements present information about the Company as an individual undertaking and not about its group.

FRS 1 allows the Company the exemption from the requirement to prepare a cash flow statement on the grounds of its size.

Investments

The investment in a subsidiary undertaking is stated at cost, net of any accumulated impairment. Investments are impaired to their net realisable value when their net realisable value is lower than their carrying value. Impairment of investments is assessed when impairment indicators are present.

Taxation

The charge for taxation is based on the result for the period and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes.

Deferred tax is recognised, without discounting, in respect of all timing differences between the treatment of certain items for taxation and accounting purposes which have arisen but not reversed by the balance sheet date, except as otherwise required by FRS 19.

6 Taxation (continued)

Reductions in the UK corporation tax rate from 23% to 21% (effective from 1 April 2014) and 20% (effective from 1 April 2015) were substantively enacted on 2 July 2013. In the Budget on 8 July 2015, the Chancellor announced additional planned reductions to 18% by 2020. This will reduce the company's future current tax charge accordingly. Any deferred tax assets or liabilities at 30 June 2015 have been calculated based on the rate of 20% substantively enacted at the balance sheet date.

7 Dividend income

No dividends were received in the current financial year.

In the prior year, the Company's subsidiary, Reach Engineering & Diving Services Limited declared and paid a dividend of £14,084 per share. A total dividend of £1,000,000 was declared and paid to the Company.
