

DIRECTORS' REPORT FOR THE YEAR ENDED 31 MARCH 2022

The directors present their report and financial statements for the year ended 31 March 2022.

Principal Activities

The principal activity of the company in the year under review was that of a community interest company.

Landance is a community interest company without share capital and was incorporated on 2nd July 2010.

Statement of director's responsibilities

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable law and regulations.

Director's Statement

During the year ending March 2022 director Ella Huhne (married name Denny) ran a project based in Lyme Regis, culminating in two dance and poetry performances in September 2021. These free evening performances moved along the seafront exploring climate change and our relationship with the sea. The performances were developed into an abstract dance piece.

The effects of Covid and the isolation experienced by everyone over the previous months meant that working together with the young dancers was a good experience as well as restricting, we wore masks whenever we were working indoors to protect them. We also decided to limit audience numbers so that there were not too many people crowding around the dancers during the performances. Unfortunately the choreographer, who is based in Italy, was not able to come over due to Covid so he worked with us remotely.

Six days collaborating on site along the seafront in Lyme Regis and in The Marine Theatre enabled the creative team to develop the performances, followed by a day off then 2 days of rehearsals then two evenings of performances after that. The poet worked alongside 5 dancers, the director/designer, a sound and lighting technician, an assistant designer and assistant in sound and lighting. Two of the young dancers were also fulfilling roles as assistant choreographer and assistant producer during the development and preparation of the project. Everyone involved, including the assistants, was paid a fee to create and perform this work.

The 2021 Lyme Regis project also offered free virtual school and open poetry workshops run by the project poet Vanessa Kisuule and hosted by Dorset Library Service in July 21.

The project was funded by Arts Council England, Dorset Performing Arts Fund, Dorset Community Foundation, Dorset Council, Dorset Library Service, Activate & Pavilion Dance South West, with in kind support from The Marine Theatre, B-sharp, Arts Development Company & Plymouth University shared extensive film research into the seabed at Lyme.

The company's finances are in good health, with fees and invoices paid.

The 2021 Lyme Regis project for which the 2020 research and development was run offered free accessible performances to members of the community in and around Lyme Regis in the late summer and free school and open workshops hosted by Dorset Library Service in July 2021.

During the year ending March 2022 director Ella Huhne (married name Denny) ran a project based in Lyme Regis, culminating in two dance and poetry performances in September 2021. These free evening performances moved along the seafront exploring climate change and our relationship with the sea. The performances were developed into an abstract dance piece.

The effects of Covid and the isolation experienced by everyone over the previous months meant that working together with the young dancers was a good experience as well as restricting, we wore masks whenever we were working indoors to protect them. We also decided to limit audience numbers so that there were not too many people crowding around the dancers during the performances. Unfortunately the choreographer, who is based in Italy, was not able to come over due to Covid so he worked with us remotely.

Six days collaborating on site along the seafront in Lyme Regis and in The Marine Theatre enabled the creative team to develop the performances, followed by a day off then 2 days of rehearsals then two evenings of performances after that. The poet worked alongside the 5 dancers, the director/designer, a sound and lighting technician, an assistant designer and assistant in sound and lighting. Two of the young dancers also fulfilled roles as assistant choreographer and assistant producer during the development and preparation of the project. Everyone involved, including the assistants, was paid a fee to create and perform this work.

The project also offered free virtual school and open poetry workshops run by the project poet Vanessa Kisuule and hosted by Dorset Library Service in July. The project was funded by Arts Council England, Dorset Performing Arts Fund, Dorset Community Foundation, Dorset Council, Dorset Library Service, Activate & Pavilion Dance South West, with in kind support from The Marine Theatre, B-sharp, Arts Development Company & Plymouth University shared extensive film research into the seabed at Lyme.

Poetry workshop participants benefited from Vanessa's enthusiasm and skill at engaging with people of all ages and will have a more open and dynamic attitude to writing and creating poetry on the future. Local aspiring young artists were able to create performances alongside highly experienced professionals, gaining valuable experience and confidence as valued team members.

Youth dancer Elfin: 'I feel I have taken a great amount of knowledge that I can use within myself as well as to further my own career in dance and performance. Living rurally, and from a family on a very low income, opportunities as a youth dancer, aiming to progress and develop all areas of knowledge and experience within the industry is difficult and limited - so to have had this experience so close to home was an incredible opportunity.'

Sammy, costume design assistant: 'I hope to increase my confidence and costume skills for future work with Landance and continue to have more creative input and responsibility in the future'.

I feel we achieved my aim for these performances to amplify the beauty of the sea & coast, inspiring positive action to preserve our environment & offering a new experience to local people of all ages from all walks of life to enjoy together.

Feedback was requested from participants in the poetry workshops for local schools, at primary and secondary level as well as an open workshop for adults which were run by Vanessa Kisuule and hosted by Dorset Library service online, this was positive about Vanessa's work and her positive approach.

Collated Library workshop feedback asking for positives & negatives:

Primary, 30+ children: Helped students to use more creative ideas for poetry - it can be modern, relative & fun. Would have liked to hear more of Vanessa's own poetry.

Primary, 35 children: The way the children were inspired to write. Always better in person...

Secondary School, 6 classes, approx. 170?: engagements, chat, the tasks, The students would have loved a bit

more of a personal intro/ a performance.

Open workshop feedback:

Vanessa's energy and writing prompts.

the creative prompts and hearing Vanessa's perspectives, would have liked more time:)

Doing the free write and haiku

Performances:

Audience feedback: feedback cards asked for 3 words response. They were overwhelmingly positive, we received 85 cards (184 inc group members in each card):

"powerful, challenging, provocative", "moving, emotive, beautiful", "incredible, heartfelt, intense", "arresting, dynamic, thought provoking"

'As parent of a youth dancer in the performance, it was a great experience for someone living so rurally which in itself presents such huge limitations for a young aspiring performer'

I think the performance will have left a long term memory in audiences' minds, seeing their local area, through artists' eyes, the powerful impact of dance and words performed live in urban sites. In the last section of the performance Vanessa performed her poem from the roof of a building in front of the gardens, the audience were led to the beach watching her with their backs to the sea (unfortunately the film maker did not manage to film her for this), they then turned round to see the dancers heads and shoulders only showing, deep in the sea.

'To watch and listen to the poet in the gardens and turn to find figures emerging from the sea was breathtaking.' The audience gasped at this point in both performances.

Event summary:

This project combined free online workshops with the project poet, Vanessa Kisuule, for local schools and for adults, hosted by Dorset Library Service. It also ran free dance performances along the seafront at Lyme Regis for people living in Lyme and the surrounding area.

Artistic Outcomes:

The events introduced local people to live contemporary dance in a very familiar space, enabling them to see it through artist's eyes and the poet's voice. They created poetry with Vanessa Kisuule in the online workshops and experienced live dance performances, which included Vanessa and her poetry.

Local young artists were able to gain experience and confidence as paid members of the creative team and as performers, working within a professional and supportive collaborative framework. They created two live dance performances for members of the local community to enjoy.

Key Achievements:

- Approximately 200 people attended online poetry workshops. Engaged with good submission of ideas.
- Approximately 300 people attended the live dance performances. Feedback was very positive
- 5 young artists worked alongside professionals, gaining experience and confidence.
- A creative team was forged, which collaborated in 2022 to develop a project for Swanage in 2023.

Evaluation – Methodology:

Feedback: Workshops: teachers and adult participants asked by the Library, audience members by the stewards with cards, artists and assistants on line by the project manager.

Evaluation – Summary:

Evaluation comments were very favourable. Suggestions for improvement were constructive.

Key Learning:


- Workshop leader to engage participants with her own work as well as tasks.
- Give a good structure within which creative collaborators can make work, not too prescriptive or too open.
- Offer an insight into Landance working practice to any new member of the creative team joining a project.
- Create time for members of the creative team to get used to working together and on site.
- Hire a quiet space to rehearse as well as work on site.
- Don't work with one of the members of the creative team online, everyone needs to be there. Due

to Covid the choreographer was in Italy for the duration and only able to work on line, the whole
team found this very difficult creatively.
