**UPON** the insolvency application issued on 26 August 2020 by Andrew MacKenzie and Julian Pitts as joint administrators of Burningnight Limited (in administration) ("**the Administrators**") seeking an extension of the period of administration of Burningnight Limited (in administration) ("**the Application**")
