

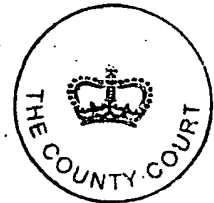

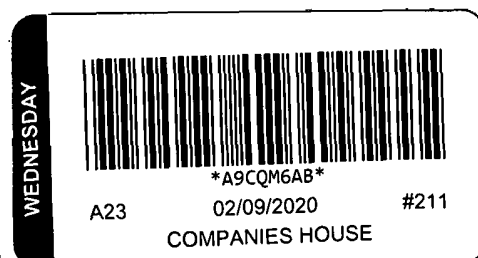
AND UPON the Court Recording, in compliance with Rule 7.20 of the Insolvency Rules 2016 that:
