BEFORE DISTRICT JUDGE SHORTHOSE ON 21 FEBRUARY ZOLY

UPON there being no attendance and the Court reading the First Applicant's witness statement and exhibit dated 18 January 2018

AND UPON reading the Consent to Act of Richard Patrick Brewer and the Agreements of Alexander Kinninmonth, Matthew Wild, Duncan Beat and Nigel Fox

AND UPON READING THE DOCUMENTS marked on the Court file as having been read

#### IT IS ORDERED THAT:

- Each of the cases listed in Schedule A to D (attached to this order) be transferred to the High Court of Justice, Business and Property Courts in Birmingham, Company and Insolvency List, solely for the purpose only of making this Order. Immediately upon this Order taking effect the County Court Cases be transferred back to the relevant Court or Hearing Centre.
- 2. DAVID SMITHSON (Outgoing Office-Holder) be removed from office with immediate effect in respect of each of the cases listed in Schedules A to D attached to this order ("block transfer cases") forthwith.
- 3. RICHARD PATRICK BREWER (**Replacement Office-Holder**) be appointed as replacement Office-Holder in respect of each of the block transfer cases listed Schedule A to D from the date of this Order.
- 4. David Smithson be removed and replaced in each of the cases contained in Schedules A to D from the date of this Order, without being required to (i) apply to the Secretary of State for release or discharge as appropriate pursuant to s174(4)(b) and s173(2)(b) of the Insolvency Act 1986 as the case may be, or (ii) file a receipts and payment account.
- 5. The creditors in each of the block transfer cases listed in Schedules B to D and the members of each of the companies listed in Schedule A be notified of this order by way of one composite notice ("the Advertisement") to be published in the Gazette within 14 days of receipt of the sealed Order.
- 6. David Smithson be discharged from liability as office-holder 21 days after the publication of a notice in the Gazette as provided for by paragraph 4 of this Order.
- 7. Where the appointments referred to in this Order are joint appointments, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.
- 8. Without incurring any additional expense for any of the said estates, the relevant Applicant, Respondent or Replacement Office-Holder shall notify each creditor and the members of each of the companies listed in Schedule A of this Application and this Order by way of notice at the same time as the next routine report that shall be due to the creditors of each estate, such notice to contain the following matters:
  - 8.1. An explanation of the effect of the Order;
  - 8.2. Express reference to the liberty to apply contained in paragraph 10 below;
  - 8.3. In the case of Liquidations, where Liquidation Committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided under rule 6.25 of the Insolvency (England and Wales) Rules 2016 has not already been provided as part of the report, it is open to that committee to require the relevant Applicant, Respondent or Replacement Office-Holder to provide an account of the administration of the estate, including:
    - 8.3.1. A summary of receipts and payments;
    - 8.3.2. A statement that he has reconciled his accounts.
  - 8.4 In the case of Liquidations where no Liquidation Committees have been appointed, an explanation that, to the extent that such information as aforesaid has not already been provided as part of the report, it is open to any creditor to apply to court for an Order that the relevant Applicant, Respondent or Replacement Office-Holder do provide an account of the administration of the estate, including:
    - 8.4.1. A summary of receipts and payments;
    - 8.4.2. A statement that he has reconciled his accounts.

- 8.5. Notification that if any Applicant, Respondent or Replacement Office-Holder has been required to provide the information referred to in sub-paragraphs 8.3 and 8.4 above, whether by a Liquidation Committee or by Court Order on the application of any creditor(s), the costs of any appointed office-holder of so complying will, unless there are good reasons to the contrary, be paid as an expense of the winding up as the case may be; and
- 8.6. In the case of Liquidations, notification to each creditor of his right under regulation 11(2) of the Insolvency Regulations 1994 to require the appointed office-holders to supply a statement of receipts and payments free of charge.
- 8.7. In the case of the Administrations, the provision of all such information as might reasonably be required with regard to the conduct of the Administration.
- 9. The Respondents shall, when the next routine report is due to the creditors of each appointment, give written notice of the making of this Order to each such creditor, such notice to include the following matters:
  - 9.1 an explanation as to the effect of the Order; and
  - 9.2. express reference to the liberty to apply as set out in the Order.
- Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies or listed in Schedules A to D who has an objection to this Order shall have 21 days from the date of the Advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in Schedules A to D until further or other Order by the court.
- 11 The replacement officeholder shall give notice to the Secretary of State, the Registrar of Companies in respect of the liquidations, administrations and the voluntary arrangement listed in Schedules A to D of the terms of this Order as soon as reasonably practicable.
- 12 The outgoing officeholder shall file a copy of this order with each of the courts listed in Schedules B and D.
- 13. Nothing in this order shall release the outgoing officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Schedules A to D.
- 14. In the case of the administrations listed in Schedule D, the Outgoing Office-Holder be released forthwith from any and all liability past, present or future in respect of any act(s) and/or omissions in relation to his conduct as outgoing Office-Holder of the estates. Such release (or discharge) to take effect 21 days from the date of the Advertisement save in respect of any claim notified to the Outgoing Office-Holder pursuant to the Insolvency Act 1986 and/pursuant to such other provision as may apply o or prior to the notice date.
- 15. Where David Smithson is removed and replaced as Administrator and those administrations are subsequently converted into CVLs, the Replacement Office-Holder in each case, as set out in Schedule D, shall also replace David Smithson as Liquidator.
- 16. The Outgoing Office-Holder delivers up to the Replacement Office-Holder and the Respondents (as appropriate) all the documents, material and articles which are listed in Schedule E of this Order.
- 17. Subject to paragraph 19 below, in the event that, as a result of the implementation of the Order RSM Restructuring Advisory LLP ("RSM") incurs any additional cost in respect of the administration of those estates where the First Applicant was the office-holder (that is to say over and above those costs incurred in the ordinary course of the administration of those estates), those costs shall be borne by RSM and shall not be charged as an expense of the administration of those estates.
- 18. Nothing contained in paragraphs 17 or 19 shall prejudice the Applicants, the Respondents or the Replacement Office-Holders from:
  - 18.1 Charging to each individual estate the cost of obtaining an Insolvency Practitioner's licence bond in respect of that estate; and

- 18.2. Apportioning between the said estates equally the cost of the Advertisement to be placed under paragraph 9 above.
- 19 The costs of this Application (including VAT) shall be met by RSM.
- 20. The Respondents have the right to apply to the court to amend this Order to include any appointments held by the First Applicant which have been inadvertently omitted from the Application.
