- The Lender may without discharging or in any way affecting the security created by this Debenture or any remedy of the Lender grant time or other indulgence or abstain from exercising or enforcing any remedies, securities, guarantees or other rights which it may now or in the future have from or against the Borrower and may make any arrangement, variation or release with any person or persons without prejudice either to this Debenture or the liability of the Borrower for the Borrower's Obligations
- The Lender shall have a full and unfettered right to assign the whole or any part of the benefit of this Debenture and the expression "the Lender" shall include its successors and assigns and the Lender shall be entitled to disclose any information to any actual or prospective assignee, successor or participant
- The provisions of this Debenture shall be severable and if at any time any one or more such provisions is or becomes invalid illegal or unenforceable the validity, legality and enforceability of the remaining provisions shall not in any way be impaired as a result
- The rights and remedies of the Lender provided by this Debenture are cumulative and are not exclusive of any rights, powers or remedies provided by law and may be exercised from time to time and as often as the Lender may deem expedient
- This Debenture is in addition to any other security now or in the future held by the Lender for the Borrower's Obligations and shall not merge with or prejudice such other security or any contractual or legal rights of the Lender.
- 15.6 This Debenture may be executed in more than one counterpart each of which shall be deemed to constitute an original
- 15.7 If the rule against perpetuities applies to any trust created by this Debenture, the perpetuity period shall be 125 years (as specified by section 5(1) of the Perpetuities and Accumulations Act 2009

- 16.1 A demand notice or other communication to the Borrower in connection with this Debenture -
 - 16 1 1 shall be in writing and,
 - shall be left at the Borrower's registered or principal office for the time being or a place of business of the Borrower last known to the Lender or sent to such address by facsimile or first class post
- Any such demand, notice or other communication will if given or made in accordance with this Clause, be deemed to have been duly given or made as follows -
 - 16 2 1 If sent by prepaid first class post on the second Business Day after the date of posting, or
 - 16 2 2 if delivered by hand on delivery at the address provided for in this Debenture, or
 - 16 2 3 If sent by facsimile at the time of transmission

provided however that if it is delivered by hand or sent by facsimile on a day which is not a Business Day or after 4 00 p m on a Business Day it will instead be deemed to have been given or made on the next Business Day

17 GOVERNING LAW AND JURISDICTION

This Debenture shall be governed by and construed in accordance with the laws of England and Wales and the Borrower submits to the non-exclusive jurisdiction of the courts of England and Wales

18 LAND REGISTRY

The Borrower certifies that this Debenture does not contravene its memorandum and articles of association and has been executed in accordance with such documents and applies to the Chief Land Registrar for a restriction to be entered on the register of its title to registered properties charged by this Debenture that

"No disposition of the registered estate by the proprietor of the registered estate is to be registered without a written consent signed by the Proprietor for the time being of the charge dated

19 **DELIVERY**

20 AVOIDANCE OF PAYMENTS

- No assurance, security or payment which may be avoided or adjusted under any enactment relating to bankruptcy or insolvency or under Part VI of the Insolvency Act 1986 or similar legislation binding on the Borrower in a jurisdiction other than England and Wales and no release, settlement or discharge given or made by the Lender on the faith of any such assurance, security or payment shall prejudice or affect the right of the Lender to recover from the Borrower (including the right to recover any monies which it may have been compelled by due process of law to refund under the provisions of the Insolvency Act 1986 and any costs payable by it or otherwise incurred in connection with such process) or to enforce the security created by or in connection with this Debenture to the full extent of all monies and liabilities secured by this Debenture

"Business Day" means a day (not being a Saturday or Sunday) on which banks in London are open for general business,

"Insolvent" means any of the follows -

- 21.1.1 the appointment of a receiver or administrative receiver over the whole or a substantial part of the Borrower's assets or any legal process if taken, or enforced upon any of the Borrower's assets, and any such action is not lifted or discharged within 14 days,
- 21 1 2 any step is taken by the Borrower or any other person to appoint an administrator in relation to the Borrower.
- 21 1 3 the Borrower becomes insolvent or stops or suspends payment of its debts or is (or is deemed to be) unable to pay its debts as they fall due or proposes or enters into any agreement or composition for the benefit of its creditors generally;
- 21 1 4 a petition is presented (other than a petition which is in the Lender's opinion frivolous or vexatious and which is withdrawn or stayed within 14 days) or an order is made for the winding-up or dissolution of the Borrower or the appointment of a liquidation in respect of the Borrower, or
- 21 1 5 the Borrower ceases or threatens to cease to carry on the whole or a substantial part of its business

 - 21 2 5 a person means an individual, firm, corporation, society, unincorporated association, state and administrative and governmental and other entities whether or not a separate legal entity.
- 21.3 Headings are for ease of reference only and are not to affect the interpretation of this Debenture
