  - b "Academy Financial Year" means the academic year from 1<sup>st</sup> of September to 31<sup>st</sup> of August in any year,
  - c "the Academy Trust" means the company intended to be regulated by these Articles and referred to in Article 2,
  - d "Academy Directors" means the Directors appointed pursuant to Articles 51 (and "Academy Director" shall mean any one of those directors),
  - e "Advisory Body" means the advisory body established by the Academy Trust for each academy, where required by the Relevant Funding Agreement, whose role is to provide advice to the Academy Trust in relation to the functioning of the relevant Academy (and "Advisory Bodies" shall mean more than one of those advisory bodies),
  - f "Additional Directors" means the Directors appointed pursuant to Article 61 and 61A,
  - g "the Articles" means these Articles of Association of the Academy Trust,
  - h "Chief Executive Officer" means such person as may be appointed by the Directors as the Chief Executive Officer of the Academy Trust,
  - "Chief Inspector" means Her Majesty's Chief Inspector of Education, Children's Services and Skills or his successor,
  - "Chief Operating Officer" means such person as may be appointed by the Directors as the chief operating officer of the Primary Academies (if any),

- k "clear days" in relation to the period of a notice means the period excluding the day when the notice is given or deemed to be given and the day on which it is given or on which it is to take effect,
- I "Clerk" means the clerk to the Directors or any other person appointed to perform the duties of the clerk to the Directors and the company secretary, in so far as there is one, including a joint, assistant or deputy clerk,
- m "the Directors" means save as otherwise defined at Article 6.9 the directors of the Academy Trust (and "Director" means any one of those directors),
- n "financial expert" means an individual, company or firm who is authorised to give investment advice under the Financial Services and Markets Act 2000.
- o "Further Directors" means the Directors appointed pursuant to Article 62,
- p "Head Teachers" means the head teachers of the Academies (and "Head Teacher" means any one of these head teachers),
- q "Local Authority Associated Persons" means any person associated with any local authority within the meaning given in section 69 of the Local Government and Housing Act 1989,
- r "Local Governing Bodies" means the committees appointed pursuant to Articles 100-101 and 104 (and "Local Governing Body" means any one of these committees),
- s "Member" means a member of the Academy Trust and someone who as such is bound by the undertaking contained in Article 8,
- t "the Memorandum" means the Memorandum of Association of the Academy Trust,
- u "Office" means the registered office of the Academy Trust,
- v "Parent Directors" means the Directors appointed pursuant to Articles 53 56 inclusive.
- w "Primary Academies" means such of the Academies that are primary schools (if any) (and "Primary Academy" shall mean any one of those schools),
- x "Principal Regulator" means the body or person appointed as the Principal Regulator under the Charities Act 2011,

- y "Relevant Funding Agreements" means the agreement or agreements entered into by the Academy Trust and the Secretary of State under section 1 of the Academies Act 2010 for the establishment of each Academy, including any variation or supplemental agreements thereof,
- z "the seal" means the common seal of the Academy Trust if it has one,
- aa "Secondary Academies" means all the Academies that are secondary schools (and "Secondary Academy" shall mean any one of those schools),
- bb "Secretary of State" means the Secretary of State for Education or successor,
- cc "teacher" means a person employed under a contract of employment or a contract for services or otherwise engaged to provide his services as a teacher at one or more Academies,
- dd "the United Kingdom" means Great Britain and Northern Ireland,
- ee words importing the masculine gender only shall include the feminine gender. Words importing the singular number shall include the plural number, and vice versa,
- ff subject as aforesaid, words or expressions contained in these Articles shall, unless the context requires otherwise, bear the same meaning as in the Companies Act 2006, as appropriate,
- gg any reference to a statute or statutory provision shall include any statute or statutory provision which replaces or supersedes such statute or statutory provision including any modification or amendment thereto
- The company's name is Midsomer Norton Schools Partnership (and in this document it is called "the Academy Trust")
- 3 The Academy Trust's registered office is to be situated in England and Wales

#### **OBJECTS**

- The Academy Trust's objects ("the Objects" and each "an Object") are specifically restricted to the following
  - (a) the advancement for the public benefit of education in the United

Kingdom, in particular but without prejudice to the generality of the foregoing by establishing, maintaining, carrying on, managing and developing academies, including without limitation the Academies, offering a broad and balanced curriculum, and

- (b) to promote for the benefit of the inhabitants of Midsomer Norton and the surrounding area the provision of facilities for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances or for the public at large in the interests of social welfare and with the object of improving the condition of life of the said inhabitants
- In furtherance of the Objects but not further or otherwise the Academy Trust may exercise the following powers -
  - (a) to draw, make, accept, endorse, discount, execute and issue promissory notes, bills, cheques and other instruments, and to operate bank accounts in the name of the Academy Trust,
  - (b) to raise funds and to invite and receive contributions provided that in raising funds the Academy Trust shall not undertake any substantial permanent trading activities and shall conform to any relevant statutory regulations,
  - (c) to acquire, alter, improve and (subject to such consents as may be required by law) to charge or otherwise dispose of property,
  - (d) subject to Article 6 below to employ such staff, as are necessary for the proper pursuit of the Objects and to make all reasonable and necessary provision for the payments of pensions and superannuation to staff and their dependants,
  - (e) to establish or support, whether financially or otherwise, any charitable trusts, associations or institutions formed for all or any of the Objects,
  - (f) to co-operate with other charities, other independent and maintained schools, voluntary bodies and statutory authorities operating in furtherance of the Objects and to exchange information and advice with them,

- (g) to pay out of funds of the Academy Trust the costs, charges and expenses of and incidental to the formation and registration of the Academy Trust,
- (h) to establish, maintain, carry on, manage and develop the Academies at locations to be determined by the Directors,
- to offer scholarships, exhibitions, prizes and awards to pupils and former pupils, and otherwise to encourage and assist pupils and former pupils,
- (j) to provide educational facilities and services to students of all ages and the wider community for the public benefit,
- (k) to carry out research into the development and application of new techniques in education in particular in relation to the areas of curricular specialisation of each of the Academies and to their approach to curriculum development and delivery and to publish the results of such research, and to develop means of benefiting from application of the experience of industry, commerce, other schools and the voluntary sector to the education of pupils in academies,
- (I) subject to such consents as may be required by law and/or by any contract entered into by or on behalf of the Academy Trust to borrow and raise money for the furtherance of the Objects in such manner and on such security as the Academy Trust may think fit,
- (m) to deposit or invest any funds of the Academy Trust not immediately required for the furtherance of its Objects (but to invest only after obtaining such advice from a financial expert as the Directors consider necessary and having regard to the suitability of investments and the need for diversification),
- (n) to delegate the management of investments to a financial expert, but only on terms that
  - (i) the investment policy is set down in writing for the financial expert by the Directors,
  - (II) every transaction is reported promptly to the Directors,
  - (iii) the performance of the investments is reviewed regularly with the Directors,

- (iv) the Directors are entitled to cancel the delegation arrangement at any time,
- (v) the investment policy and the delegation arrangement are reviewed at least once a year,
- (vi) all payments due to the financial expert are on a scale or at a level which is agreed in advance and are notified promptly to the Directors on receipt, and
- (vii) the financial expert must not do anything outside the powers of the Directors,
- (o) to arrange for investments or other property of the Academy Trust to be held in the name of a nominee company acting under the control of the Directors or of a financial expert acting under their instructions, and to pay any reasonable fee required,
- (p) to provide indemnity insurance to cover the liability of Governors which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default, breach of trust or breach of duty of which they may be guilty in relation to the Academy Trust Provided that any such insurance shall not extend to any claim arising from any act or omission which the Governors knew to be a breach of trust or breach of duty or which was committed by the Governors in reckless disregard of whether it was a breach of trust or breach of duty or not and provided also that any such insurance shall not extend to the costs of any unsuccessful defence to a criminal prosecution brought against the Governors in their capacity as Governors,
- (q) to establish subsidiary companies to carry on any trade or business for the purpose of raising funds for the Academy Trust,
- (r) to do all such other lawful things as are necessary for or are incidental to or conducive to the achievement of the Objects
- The income and property of the Academy Trust shall be applied solely towards the promotion of the Objects
- None of the income or property of the Academy Trust may be paid or transferred directly or indirectly by way of dividend bonus or otherwise by way

of profit to any member of the Academy Trust Nonetheless a member of the Academy Trust who is not also a Director may

- a) benefit as a beneficiary of the Academy Trust,
- b) be paid reasonable and proper remuneration for any goods or services supplied to the Academy Trust,
- be paid rent for premises let by the member of the Academy Trust if the amount of the rent and other terms of the letting are reasonable and proper, and
- d) be paid interest on money lent to the Academy Trust at a reasonable and proper rate, such rate not to exceed 2 per cent per annum below the base lending rate of a UK clearing bank selected by the Directors, or 0.5%, whichever is the higher
- A Governor may benefit from any indemnity insurance purchased at the Academy Trust's expense to cover the liability of the Governors which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default or breach of trust or breach of duty of which they may be guilty in relation to the Academy Trust Provided that any such insurance shall not extend to any claim arising from any act or omission which the Governors knew to be a breach of trust or breach of duty or which was committed by the Governors in reckless disregard to whether it was a breach of trust or breach of duty or not and provided also that any such insurance shall not extend to the costs of any unsuccessful defence to a criminal prosecution brought against the Governors in their capacity as directors of the Academy Trust
- A company, which has shares listed on a recognised stock exchange and of which any one Director holds no more than 1% of the issued capital of that company, may receive fees, remuneration or other benefit in money or money's worth from the Academy Trust
- A Director may at the discretion of the Directors be reimbursed from the property of the Academy Trust for reasonable expenses properly incurred by him or her when acting on behalf of the Academy Trust, but excluding expenses in connection with foreign travel

## 6 6 No Director may

- (a) buy any goods or services from the Academy Trust,
- (b) sell goods, services, or any interest in land to the Academy Trust,
- (c) be employed by, or receive any remuneration from the Academy Trust (other than the Chief Executive Officer and the Chief Operating Officer whose employment and/or remuneration is subject to the procedure and conditions in Article 6 8),
- (d) receive any other financial benefit from the Academy Trust, unless
  - (i) the payment is permitted by Article 6.7 and the Directors follow the procedure and observe the conditions set out in Article 6.8, or
  - (ii) the Directors obtain the prior written approval of the Charity Commission and fully comply with any procedures it prescribes

## 6.7 Subject to Article 6.8, a Director may

- a) receive a benefit from the Academy Trust in the capacity of a beneficiary of the Academy Trust,
- b) be employed by the Academy Trust or enter into a contract for the supply of goods or services to the Academy Trust, other than for acting as a Director
- c) receive interest on money lent to the Academy Trust at a reasonable and proper rate not exceeding 2% per annum below the base rate of a clearing bank to be selected by the Directors, or 0.5%, whichever is the higher, and/or
- (e) receive rent for premises let by the Director to the Academy Trust if the amount of the rent and the other terms of the lease are reasonable and proper
- 6 8 The Academy Trust and its Directors may only rely upon the authority provided by Article 6 7 if each of the following conditions is satisfied
  - (a) the remuneration or other sums paid to the Director do not exceed an

## amount that is reasonable in all the circumstances

- (b) the Director is absent from the part of any meeting at which there is discussion of
  - his or her employment, remuneration, or any matter concerning the contract, payment or benefit, or
  - his or her performance in the employment, or his or her performance of the contract, or
  - any proposal to enter into any other contract or arrangement with him or her or to confer any benefit upon him or her that would be permitted under Article 6.7, or
  - iv) any other matter relating to a payment or the conferring of any benefit permitted by Article 6 7
- (c) the Director does not vote on any such matter and is not to be counted when calculating whether a quorum of Directors is present at the meeting
- (d) save in relation to employing or contracting with the Chief Executive Officer and Chief Operating Officer the other Directors are satisfied that it is in the interests of the Academy Trust to employ or to contract with that Director rather than with someone who is not a Director. In reaching that decision the Directors must balance the advantage of employing a Director against the disadvantages of doing so (especially the loss of the Director's services as a result of dealing with the Director's conflict of interest).

- (f) a majority of the Directors then in office have received no such payments or benefit

- 8 Every member of the Academy Trust undertakes to contribute such amount as may be required (not exceeding £10) to the Academy Trust's assets if it should be wound up while he or she is a member or within one year after he or she ceases to be a member, for payment of the Academy Trust's debts and liabilities before he or she ceases to be a member, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributories among themselves
- If the Academy Trust is wound up or dissolved and after all its debts and liabilities (including any under section 2 of the Academies Act 2010) have been satisfied there remains any property it shall not be paid to or distributed among the members of the Academy Trust, but shall be given or transferred to some other charity or charities having objects similar to the Objects which prohibits the distribution of its or their income and property to an extent at least as great as is imposed on the Academy Trust by Article 6 above, chosen by the members of the Academy Trust at or before the time of dissolution and if that cannot be done then to some other charitable object

- No alteration or addition shall be made to or in the provisions of the Articles without the written consent of the Secretary of State
- No alteration or addition shall be made to or in the provisions of the Articles which would have the effect (a) that the Academy Trust would cease to be a company to which section 60 of the Companies Act 2006 applies, or (b) that the Academy Trust would cease to be a charity

#### **MEMBERS**

- The first Members of the Academy Trust shall be the subscribers to the Memorandum of Association (and such Members shall also be Directors)
- 12A Notwithstanding Article 16, subsequent Members of the Academy Trust shall be
  - a) the Directors, save for Further Directors and Directors appointed by the Secretary of State under Articles 60-63 and pursuant to the terms of the Relevant Funding Agreement, and
  - b) any person who is interested in the Objects and approved as a Member by the Directors
- The Members of the Academy Trust may also include 1 person appointed by the Secretary of State, in the event that the Secretary of State appoints a person for this purpose, and the Secretary of State shall have the right from time to time by written notice to the Office to remove any Member appointed by him and to appoint a replacement Member to fill a vacancy whether resulting from such removal or otherwise

## **GENERAL MEETINGS**

- The Directors may call general meetings and, on the requisition of Members pursuant to the provisions of the Companies Act 2006, shall forthwith proceed to convene a general meeting in accordance with that Act. If there are not within the United Kingdom sufficient Directors to call a general meeting, any Director or any Member of the Academy Trust may call a general meeting.

## NOTICE OF GENERAL MEETINGS

21 General meetings shall be called by at least fourteen clear days' notice but a general meeting may be called by shorter notice if it is so agreed by a majority in number of Members having a right to attend and vote and together representing not less than 90% of the total voting rights at that meeting

The notice shall specify the time and place of the meeting and the general

nature of the business to be transacted and, in the case of an Annual General Meeting, shall specify the meeting as such. The notice shall also state that the Member is entitled to appoint a proxy.

The notice shall be given to all the Members, to the Directors and, in the case of Annual General Meetings only, to the auditors

The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any person entitled to receive notice shall not invalidate the proceedings at that meeting

## PROCEEDINGS AT GENERAL MEETINGS

- 23 No business shall be transacted at any meeting unless a quorum is present A Member counts towards the quorum by being present either in person or by proxy. Two persons entitled to vote upon the business to be transacted, each being a Member or a proxy of a Member or a duly authorised representative of a Member organisation shall constitute a quorum.
- If a quorum is not present within half an hour from the time appointed for the meeting, or if during a meeting a quorum ceases to be present, the meeting shall stand adjourned to the same day in the next week at the same time and place or to such time and place as the Directors may determine
- The chairman, if any, of the Directors or in his absence some other Director nominated by the Directors shall preside as chairman of the meeting, but if neither the chairman nor such other Director (if any) be present within fifteen minutes after the time appointed for holding the meeting and willing to act, the Directors present shall elect one of their number to be chairman and, if there is only one Director present and willing to act, he shall be the chairman
- If no Director is willing to act as chairman, or if no Director is present within fifteen minutes after the time appointed for holding the meeting, the Members present and entitled to vote shall choose one of their number to be chairman
- A Director shall, notwithstanding that he is not a Member, be entitled to attend and speak at any general meeting
- The chairman may, with the consent of a majority of the Members at a meeting at which a quorum is present (and shall if so directed by the

meeting), adjourn the meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business which might properly have been transacted at the meeting had the adjournment not taken place. When a meeting is adjourned for fourteen days or more, at least seven clear days' notice shall be given specifying the time and place of the adjourned meeting and the general nature of the business to be transacted. Otherwise it shall not be necessary to give any such notice

- A resolution put to the vote of the meeting shall be decided on a show of hands unless before, or on the declaration of the result of the show of hands, a poll is duly demanded. Subject to the provisions of the Companies Act 2006, a poll may be demanded.
  - (a) by the chairman, or
  - (b) by at least two Members having the right to vote at the meeting, or,
  - (c) by a Member or Members representing not less than one-tenth of the total voting rights of all the Members having the right to vote at the meeting
- 30 Unless a poll is duly demanded a declaration by the chairman that a resolution has been carried or carried unanimously, or by a particular majority, or lost, or not carried by a particular majority and an entry to that effect in the minutes of the meeting shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against such resolution

The demand for a poll shall not prevent continuance of a meeting for the transaction of any business other than the question on which the poll is demanded. If a poll is demanded before the declaration of the result of a show of hands and the demand is duly withdrawn, the meeting shall continue as if the demand had not been made.

- No notice need be given of a poll not taken immediately if the time and place at which it is to be taken are announced at the meeting at which it is demanded. In other cases at least seven clear days' notice shall be given specifying the time and place at which the poll is to be taken.
- A resolution in writing agreed by such number of Members as required if it had been proposed at a general meeting shall be as effectual as if it had been passed at a general meeting duly convened and held provided that a copy of the proposed resolution has been sent to every Member. The resolution may consist of several instruments in the like form each agreed by one or more Members.

adjourned meeting at which the person named in the instrument proposes to vote, or

## **DIRECTORS**

- The number of Directors shall be not less than three but (unless otherwise determined by ordinary resolution) shall not be subject to any maximum
- Subject to Articles 48-49 and Article 53, the Academy Trust shall have the following Directors
  - a up to 5 Directors, appointed under Article 50,

- b the Chief Executive Officer,
- c the Chief Operating Officer,
- d up to 2 persons appointed under Article 51 who are believed by the Directors to have relevant skills in some or all of the following disciplines. Human Resources, financial, premises, Information and Communication Technology and educational issues ("Specialist Directors"),
- e up to 2 Academy Directors, comprising up to 1 chairman appointed from one of the Local Governing Bodies of the Primary Academies and up to 1 chairman appointed from one of the Local Governing Bodies of the Secondary Academies pursuant to the provisions of Article 52, but subject to Article 52A, and
- f any Additional Directors, if appointed under Article 61, 61A or 67A,
- g any Further Directors, if appointed under Article 62 or Article 67A, and
- h up to 2 Directors, if appointed by the Secretary of State in accordance with the terms of any of the Relevant Funding Agreements following the provision of a notice by the Academy Trust to terminate the Relevant Funding Agreement
- 46A Each Director, except for Further Directors and Directors appointed by the Secretary of State, must be a Member or must have agreed in writing, following an invitation by the other Directors, to become a Member and must become one without delay
- The Academy Trust may also have any Co-opted Director appointed under Article 58 and subject to Article 50B
- The first Directors shall be those persons named in the statement delivered pursuant to sections 9 and 12 of the Companies Act 2006

#### APPOINTMENT OF DIRECTORS

## PARENT DIRECTORS

Parent members of an Advisory Body or Local Governing Body shall be either elected or appointed in accordance with the terms of reference determined by the Directors from time to time. However, in the event that no such parent members are appointed, then the Academy Trust shall be required to have a minimum of two Parent Directors.
- Where the Academy Trust is required to have, Parent Directors according to Article 53, the Parent Directors shall be elected or appointed as determined by the Directors. A Parent Director must be a parent of a registered pupil or student at one or more of the Academies at the time when he is elected or appointed.
- Where the Directors have determined that a vacancy in the office of Parent Director is to be filled by election but the number of parents standing for

election is less than the number of vacancies, the number of Parent Directors required shall be made up of Parent Directors appointed by the Directors

- Where the Directors have determined that a vacancy in the office of Parent Director is to be filled by election, the Directors shall make all necessary arrangements for, and determine all other matters relating to, an election of the Parent Directors, including any question of whether a person is a parent of a registered pupil or student at one of the Academies. Any election of the Parent Directors which is contested shall be held by secret ballot
- In appointing a Parent Director, the Directors shall appoint a person who is the parent of a registered pupil or student at an Academy or where it is not reasonably practical to do so, a person who is the parent of a child of compulsory school age

57 The Chief Executive Officer shall be a Director for as long as he remains in office as such

#### CHIEF OPERATING OFFICER

57A The Chief Operating Officer shall be a Director for as long as he remains in office as such

#### CO-OPTED DIRECTORS

The Directors may appoint Co-opted Directors for such term as they shall determine. A 'Co-opted Director' means a person who is appointed to be a Director by being Co-opted by Directors who have not themselves been so appointed. The Directors may not co-opt an employee of the Academy Trust as a Co-opted Director if the resultant number of Directors employed by the Academy Trust would exceed one third of the total number of Directors including the Chief Executive Officer and the Chief Operating Officer.

## APPOINTMENT OF ADDITIONAL DIRECTORS

59 The Secretary of State may give a warning notice to the Directors where he is satisfied—

- that the standards of performance of pupils at an Academy are unacceptably low, or
- ii) that there has been a serious breakdown in the way an Academy is managed or governed, or
- that the safety of pupils or staff of the an Academy is threatened (whether by a breakdown of discipline or otherwise)
- For the purposes of Article 59 a 'warning notice' is a notice in writing by the Secretary of State to the Academy Trust delivered to the Office setting out
  - a) the matters referred to in Article 59,
  - b) the action which he requires the Directors to take in order to remedy those matters, and
  - c) the period within which that action is to be taken by the Directors ('the compliance period')
- The Secretary of State may appoint such Additional Directors as he thinks fit if the Secretary of State has
  - a) given the Directors a warning notice in accordance with Article 59, and
  - b) the Directors have failed to comply, or secure compliance, with the notice to the Secretary of State's satisfaction within the compliance period
- The Secretary of State may also appoint such Additional Directors where following an Inspection by the Chief Inspector in accordance with the Education Act 2005 (an "Inspection") an Academy receives an Ofsted grading (being a grade referred to in The Framework for School Inspection or any modification or replacement of that document for the time being in force) which amounts to a drop, either from one Inspection to the next Inspection or between any two Inspections carried out within a 5 year period, of two Ofsted grades. For the purposes of the foregoing the grade received by Norton Hill School and Somervale School shall be regarded as the grade received by the respective Academy.
- The Secretary of State may also appoint such Further Directors as he thinks fit if a Special Measures Termination Event (as defined in the Funding

## Agreement) occurs in respect of an Academy

Within 5 days of the Secretary of State appointing any Additional or Further Directors in accordance with Articles 61, 61A or 62 any Directors appointed under Article 50 and holding office immediately preceding the appointment of such Directors, shall resign immediately and the Members' power to appoint Directors under Article 50 shall remain suspended until the Secretary of State removes one or more of the Additional or Further Directors

#### **TERM OF OFFICE**

- Subject to Article 64A, The term of office for any Director shall be four years save that this time limit shall not apply to the Chief Executive Officer, Chief Operating Officer, Academy Directors and any Co-opted Directors
- On the second anniversary and each following anniversary of the adoption of these Articles, one quarter (or the number nearest one quarter) of the Directors must retire, those longest in office retiring first and the choice between any of equal service being made by drawing lots
- Subject to remaining eligible to be a particular type of Director, any Director may be re-appointed or re-elected

## RESIGNATION AND REMOVAL

- A Director shall cease to hold office if he resigns his office by notice to the Academy Trust (but only if at least three Directors will remain in office when the notice of resignation is to take effect)

- A person shall be disqualified from holding or continuing to hold office as a Director where he has, at any time, been convicted of any criminal offence, excluding any that have been spent under the Rehabilitation of Offenders Act 1974 as amended, and excluding any offence for which the maximum sentence is a fine or a lesser sentence except where a person has been convicted of any offence which falls under section 178 of the Charities Act 2011
- After the first Academy has opened, a person shall be disqualified from holding or continuing to hold office as a Director if he has not provided to the chairman of the Directors a criminal records certificate at an enhanced disclosure level under section 113B of the Police Act 1997. In the event that the certificate discloses any information which would in the opinion of either the chairman or the Chief Executive Officer confirm their unsuitability to work with children that person shall be disqualified. the Chief Executive Officer or the Chief Operating Officer Notwithstanding this Article, the Directors may, where the Clerk fails to attend a meeting of theirs, appoint any one of their number or any other person to act as Clerk for the purposes of that meeting

#### CHAIRMAN AND VICE-CHAIRMAN OF THE DIRECTORS

- The Directors shall each school year elect a chairman and a vice-chairman from among their number. A Director who is employed by the Academy Trust shall not be eligible for election as chairman or vice-chairman.

No alteration of the Articles and no such direction shall invalidate any prior act of the Directors which would have been valid if that alteration had not been made or that direction had not been given. The powers given by this Article shall not be limited by any special power given to the Directors by the Articles and a meeting of Directors at which a quorum is present may exercise all the powers exercisable by the Directors.
- In addition to all powers hereby expressly conferred upon them and without detracting from the generality of their powers under the Articles the Directors shall have the following powers, namely
  - a) to expend the funds of the Academy Trust in such manner as they shall consider most beneficial for the achievement of the Objects and to invest in the name of the Academy Trust such part of the funds as they may see fit and to direct the sale or transposition of any such investments and to expend the proceeds of any such sale in furtherance of the Objects, and
  - b) to enter into contracts on behalf of the Academy Trust

- In the exercise of their powers and functions, the Directors may consider any advice given by the Chief Executive Officer and any other executive officer
- Any bank account in which any money of the Academy Trust is deposited shall be operated by the Directors in the name of the Academy Trust. All cheques and orders for the payment of money from such an account shall be signed by at least two signatories authorised by the Directors.

## **CONFLICTS OF INTEREST**

- Any Director who has or can have any direct or indirect duty or personal interest (including but not limited to any Personal Financial Interest) which conflicts or may conflict with his duties as a Director shall disclose that fact to the Directors as soon as he becomes aware of it. A Director must absent himself from any discussions of the Directors in which it is possible that a conflict will arise between his duty to act solely in the interests of the Academy Trust and any duty or personal interest (including but not limited to any Personal Financial Interest)
- 98 For the purpose of Article 97, a Director has a Personal Financial Interest in the employment or remuneration of, or the provision of any other benefit to, that Director as permitted by and as defined by Articles 6 5-6 9

#### THE MINUTES

The minutes of the proceedings of a meeting of the Directors shall be drawn up and entered into a book kept for the purpose by the person acting as Clerk for the purposes of the meeting, and shall be signed (subject to the approval of the Directors) at the same or next subsequent meeting by the person acting as chairman thereof

## **COMMITTEES**

- 100 Subject to these Articles, the Directors
  - a) may appoint separate committees to be known as Local Governing Bodies for each Academy, and
  - b) may establish any other committee
- 101 Subject to these Articles, the constitution, membership and proceedings of

any committee shall be determined by the Directors. The establishment, terms of reference, constitution and membership of any committee of the Directors shall be reviewed at least once in every twelve months. The membership of any committee of the Directors may include persons who are not Directors, provided that (with the exception of the Local Governing Bodies) a majority of members of any such committee shall be Directors. Except in the case of a Local Governing Body, no vote on any matter shall be taken at a meeting of a committee of the Directors unless the majority of members of the committee present are Directors.

- The functions and proceedings of the Local Governing Bodies shall be subject to regulations made by the Directors from time to time

#### **DELEGATION**

- The Directors may delegate to any Director, committee (including any Local Governing Body), the Chief Executive Officer, the Chief Operating Officer or any other holder of an executive office, such of their powers or functions as they consider desirable to be exercised by them. Any such delegation may be made subject to any conditions the Directors may impose, and may be revoked or altered.
- 106 Where any power or function of the Directors has been exercised by any committee (including any Local Governing Body), any Director, the Chief Executive Officer, the Chief Operating Officer or any other holder of an executive office, that person or committee shall report to the Directors in respect of any action taken or decision made with respect to the exercise of that power or function at the meeting of the Directors immediately following the taking of the action or the making of the decision

# CHIEF EXECUTIVE OFFICER, CHIEF OPERATING OFFICER AND HEAD TEACHERS

The Directors shall appoint the Chief Executive Officer, the Chief Operating Officer and the Head Teachers of the Academies The Directors may delegate such powers and functions as they consider are required by the

Chief Executive Officer, the Chief Operating Officer and the Head Teachers for the internal organisation, management and control of the Academies (including the implementation of all policies approved by the Directors and for the direction of the teaching and curriculum at the Academies)

#### MEETINGS OF THE DIRECTORS

- Subject to these Articles, the Directors may regulate their proceedings as they think fit
- 109 The Directors shall hold at least three meetings in every school year Meetings of the Directors shall be convened by the Clerk In exercising his functions under this Article the Clerk shall comply with any direction
  - a) given by the Directors, or
  - b) given by the chairman of the Directors or, in his absence or where there is a vacancy in the office of chairman, the vice-chairman of the Directors, so far as such direction is not inconsistent with any direction given as mentioned in (a)
- Any three Directors may, by notice in writing given to the Clerk, requisition a meeting of the Directors, and it shall be the duty of the Clerk to convene such a meeting as soon as is reasonably practicable
- 111 Each Director shall be given at least seven clear days before the date of a meeting
  - a) notice in writing thereof, signed by the Clerk, and sent to each Director at the address provided by each Director from time to time, and
  - b) a copy of the agenda for the meeting,

provided that where the chairman or, in his absence or where there is a vacancy in the office of chairman, the vice-chairman, so determines on the ground that there are matters demanding urgent consideration, it shall be sufficient if the written notice of a meeting, and the copy of the agenda thereof are given within such shorter period as he directs

The convening of a meeting and the proceedings conducted thereat shall not be invalidated by reason of any individual not having received written notice

of the meeting or a copy of the agenda thereof

- A resolution to rescind or vary a resolution carried at a previous meeting of the Directors shall not be proposed at a meeting of the Directors unless the consideration of the rescission or variation of the previous resolution is a specific item of business on the agenda for that meeting
- 114 A meeting of the Directors shall be terminated forthwith if -
  - (a) the Directors so resolve, or
  - (b) the number of Directors present ceases to constitute a quorum for a meeting of the Directors in accordance with Article 117, subject to Article 119
- 115 Where in accordance with Article 114 a meeting is not held or is terminated before all the matters specified as items of business on the agenda for the meeting have been disposed of, a further meeting shall be convened by the Clerk as soon as is reasonably practicable, but in any event within seven days of the date on which the meeting was originally to be held or was so terminated
- 116 Where the Directors resolve in accordance with Article 114 to adjourn a meeting before all the items of business on the agenda have been disposed of, the Directors shall before doing so determine the time and date at which a further meeting is to be held for the purposes of completing the consideration of those items, and they shall direct the Clerk to convene a meeting accordingly
- 117 Subject to Article 119 the quorum for a meeting of the Directors, and any vote on any matter thereat, shall be any three Directors, or, where greater, any one third (rounded up to a whole number) of the total number of Directors holding office at the date of the meeting. If the Secretary of State has appointed Additional or Further Directors then a majority of the quorum must be made up of Additional or Further Directors.
- The Directors may act notwithstanding any vacancies in their number, but, if the numbers of Directors is less than the number fixed as the quorum, the continuing Directors may act only for the purpose of filling vacancies or of calling a general meeting

- 119 The quorum for the purposes of
  - a appointing a Parent Director under Articles 56,
  - b any vote on the removal of a Director in accordance with Article 66,
  - c any vote on the removal of the chairman of the Directors in accordance with Article 90,

shall be any two-thirds (rounded up to a whole number) of the persons who are at the time Directors entitled to vote on those respective matters

- Subject to these Articles, every question to be decided at a meeting of the Directors shall be determined by a majority of the votes of the Directors present and voting on the question. Every Director shall have one vote
- Subject to Articles 117-119, where there is an equal division of votes, the chairman of the meeting shall have a casting vote in addition to any other vote he may have
- 122 The proceedings of the Directors shall not be invalidated by

any vacancy among their number, or

any defect in the election, appointment or nomination of any Director

- A resolution in writing, signed by all the Directors entitled to receive notice of a meeting of Directors or of a committee of Directors, shall be valid and effective as if it had been passed at a meeting of Directors or (as the case may be) a committee of Directors duly convened and held. Such a resolution may consist of several documents in the same form, each signed by one or more of the Directors.
- 124 Subject to Article 125, the Directors shall ensure that a copy of
  - a the agenda for every meeting of the Directors,
  - b the draft minutes of every such meeting, if they have been approved by the person acting as chairman of that meeting,
  - c the signed minutes of every such meeting, and

- d any report, document or other paper considered at any such meeting,
- are, as soon as is reasonably practicable, made available at every Academy to persons wishing to inspect them
- 125 There may be excluded from any item required to be made available in pursuance of Article 124, any material relating to
  - a a named teacher or other person employed, or proposed to be employed, at any Academy,
  - b a named pupil or named student at, or candidate for admission to, any Academy, and
  - c any matter which, by reason of its nature, the Directors are satisfied should remain confidential
- Any Director shall be able to participate in meetings of the Directors by telephone or video conference provided that
  - a he has given notice of his intention to do so detailing the telephone number on which he can be reached and/or appropriate details of the video conference suite from which he shall be taking part at the time of the meeting at least 48 hours before the meeting, and,
  - b the Directors have access to the appropriate equipment if after all reasonable efforts it does not prove possible for the person to participate by telephone or video conference the meeting may still proceed with its business provided it is otherwise quorate

#### PATRONS AND HONORARY OFFICERS

The Directors may from time to time appoint any person whether or not a Member of the Academy Trust to be a patron of the Academy Trust or to hold any honorary office and may determine for what period he is to hold such office

#### THE SEAL

The seal, if any, shall only be used by the authority of the Directors or of a committee of Directors authorised by the Directors The Directors may

determine who shall sign any instrument to which the seal is affixed and unless otherwise so determined it shall be signed by a Director and by the Clerk or by a second Director

#### **ACCOUNTS**

Accounts shall be prepared in accordance with the relevant Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and Parts 15 and 16 of the Companies Act 2006 and shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

## ANNUAL REPORT

The Directors shall prepare its Annual Report in accordance with the Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

#### ANNUAL RETURN

The Directors shall comply with their obligations under Part 24 of the Charities Act 2006 (or any statutory re-enactment or modification of that Act) with regard to the preparation of an annual return to the Registrar of Companies and in accordance with the Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and to the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

#### **NOTICES**

- Any notice to be given to or by any person pursuant to the Articles (other than a notice calling a meeting of the Directors) shall be in writing or shall be given using electronic communications to an address for the time being notified for that purpose to the person giving the notice. In these Articles, "Address" in relation to electronic communications, includes a number or address used for the purposes of such communications.
- A notice may be given by the Academy Trust to a Member either personally or by sending it by post in a prepaid envelope addressed to the Member at his registered address or by leaving it at that address or by giving it using

electronic communications to an address for the time being notified to the Academy Trust by the Member. A Member whose registered address is not within the United Kingdom and who gives to the Academy Trust an address within the United Kingdom at which notices may be given to him, or an address to which notices may be sent using electronic communications, shall be entitled to have notices given to him at that address, but otherwise no such Member shall be entitled to receive any notice from the Academy Trust

- A Member present, either in person or by proxy, at any meeting of the Academy Trust shall be deemed to have received notice of the meeting and, where necessary, of the purposes for which it was called
- 135 Proof that an envelope containing a notice was properly addressed, prepaid and posted shall be conclusive evidence that the notice was given Proof that a notice contained in an electronic communication was sent in accordance with guidance issued by the Institute of Chartered Secretaries and Administrators shall be conclusive evidence that the notice was given A notice shall be deemed to be given at the expiration of 48 hours after the envelope containing it was posted or, in the case of a notice contained in an electronic communication, at the expiration of 48 hours after the time it was sent

## INDEMNITY

Subject to the provisions of the Companies Act 2006 and Article 6.3 every Director or other officer or auditor of the Academy Trust shall be indemnified out of the assets of the Academy Trust against any liability incurred by him in that capacity in defending any proceedings, whether civil or criminal, in which judgment is given in favour or in which he is acquitted or in connection with any application in which relief is granted to him by the court from liability for negligence, default, breach of duty or breach of trust in relation to the affairs of the Academy Trust

#### **RULES**

The Directors may from time to time make such rules or bye laws as they may deem necessary or expedient or convenient for the proper conduct and management of the Academy Trust and for purposes of prescribing classes of and conditions of membership, and in particular but without prejudice to the

generality of the foregoing, they may by such rules or bye laws regulate

- the admission and classification of Members of the Academy Trust (including the admission of organisations to membership) and the rights and privileges of such Members, and the conditions of membership and the terms on which Members may resign or have their membership terminated and the entrance fees, subscriptions and other fees or payments to be made by Members,
- b the conduct of Members of the Academy Trust in relation to one another, and to the Academy Trust's servants,
- c the setting aside of the whole or any part or parts of the Academy Trust's premises at any particular time or times or for any particular purpose or purposes,
- d the procedure at general meetings and meetings of the Directors and committees of the Directors and meetings of the Local Governing Bodies in so far as such procedure is not regulated by the Articles, and,
- e generally, all such matters as are commonly the subject matter of Academy Trust rules
- The Academy Trust in general meeting shall have power to alter, add or to repeal the rules or bye laws and the Directors shall adopt such means as they think sufficient to bring to the notice of Members of the Academy Trust all such rules or bye laws, which shall be binding on all Members of the Academy Trust Provided that no rule or bye law shall be inconsistent with, or shall affect or repeal anything contained in the Articles

#### AVOIDING INFLUENCED COMPANY STATUS

- Notwithstanding the number of Members from time to time, the maximum aggregate number of votes exercisable by Local Authority Associated Persons shall never exceed 19 9% of the total number of votes exercisable by Members in general meeting and the votes of the other Members having a right to vote at the meeting will be increased on a pro-rata basis
- 140 No person who is a Local Authority Associated Person may be appointed as a

Director if, once the appointment had taken effect, the number of Directors who are Local Authority Associated Persons would represent 20% or more of the total number of Directors. Upon any resolution put to the Directors, the maximum aggregate number of votes exercisable by any Directors who are Local Authority Associated Persons shall represent a maximum of 19 9% of the total number of votes cast by the Directors on such a resolution and the votes of the other Directors having a right to vote at the meeting will be increased on a pro-rata basis

- No person who is a Local Authority Associated Person is eligible to be appointed to the office of Director unless his appointment to such office is authorised by the local authority to which he is associated
- If at the time of either his becoming a Member of the Academy Trust or his first appointment to office as a Director any Member or Director was not a Local Authority Associated Person but later becomes so during his membership or tenure as a Director he shall be deemed to have immediately resigned his membership and/or resigned from his office as a Director as the case may be
- If at any time the number of Directors or Members who are also Local Authority Associated Persons would (but for Articles 139 to 142 inclusive) represent 20% or more of the total number of Directors or Members (as the case may be) then a sufficient number of the Directors or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned as Directors or Members (as the case may be) immediately before the occurrence of such an event to ensure that at all times the number of such Directors or Members (as the case may be) is never equal to or greater than 20% of the total number of Directors or Members (as the case may be) Directors or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned in order of their appointment date the most recently appointed resigning first
- The Members will each notify the Academy Trust and each other if at any time they believe that the Academy Trust or any of its subsidiaries has become subject to the influence of a local authority (as described in section 69 of the Local Government and Housing Act) 1989
