



Regulation 9(4) of the Model Articles shall be amended so that the second sentence is deleted and replaced by the following wording "Where such notice of waiver is given after the meeting has been held, that does not affect the validity of the meeting, or of any business conducted at it"

3 Conflicts of interest

- Regulation 14(3) of the Model Articles shall be deleted and the following wording inserted in its place
 - "(3) This paragraph applies when-
 - (a) the company by ordinary resolution disapplies the provision of the articles which would otherwise prevent a director from being counted as participating in the decision-making process,
 - (b) the director's interest cannot reasonably be regarded as likely to give rise to a conflict of interest,
 - (c) the directors authorise the conflict in accordance with section 175(5), or
 - (d) the director's conflict of interest arises from a permitted cause "

Termination of director's appointment

- 4.1 A new sub-paragraph (g) shall be inserted after sub-paragraph (f) of Regulation 18 of the Model Articles in the following terms
 - "(g) he is, without the permission of the directors, absent for more than six consecutive months from meetings of directors held during that period and the directors resolve that his office be vacated"

5 Waiver of Distributions

Regulation 35 of the Model Articles shall be amended so that the words "in writing" in the first sentence of that Regulation shall be deleted and replaced with the words "by way of a deed"
