1 Definitions and interpretation

1 1 In these Articles the following words and phrases shall have the following meanings unless the context otherwise requires

Act means the Companies Act 2006 including any statutory

Articles means these Articles of Association,

Charities Act means the Charities Act 2011 including any statutory

modification, consolidation or re-enactment thereof for the

time being in force;

Charity means The Legatum Institute Foundation;

Charity Commission means the Charity Commission for England and Wales;

Chief Executive Officer means the principal executive officer of the Charity as

defined by Article 7,

clear days in relation to a period of notice means a period excluding

the day when the notice is given or deemed to be given and the day for which it is given or on which it is to take effect,

connected person has the meaning given in the Charities Act (and a person

connected with a Director shall be construed

accordingly);

Director

means a director of the Charity and includes any person occupying the position of director, by whatever name called. The Directors are charity trustees as defined in the Charities Act,

document

Member

means a person who is a subscriber to the Memorandum or who is admitted to membership in accordance with the Articles;

Objects

means the objects of the Charity as set out in Article 4,

Ordinary Resolution

means a resolution (of the Members or, if applicable, a class of the Members) that is passed

- if a written resolution, by Members representing a simple majority of the total voting rights of eligible Members;
- (ii) on a show of hands at a meeting, by a simple majority of the votes cast by those entitled to vote,
- (III) on a poll at a meeting, by Members representing a simple majority of the total voting rights of Members who (being entitled to do so) vote in person, by proxy or (if applicable) in advance,

proxy notice

has the meaning given in Article 17,

Restricted Business

means any matter concerning

- (i) approval of the Charity's annual budget and business plan,
- (ii) any exercise of the power contained in Article 5.21 (including the review of any arrangements made under that Article),

- (iii) dissolution or merger with another entity;
- (iv) changes to the membership structure of the Charity, including but not limited to the creation of new classes of membership and the variation of the rights or duties attaching to a particular class of membership.
- (v) changes to the name of the Charity, or
- (vi) alteration of the Articles

Secretary

means any person appointed to perform the duties of the secretary of the Charity,

Special Resolution

means a resolution (of the Members or, if applicable, a class of the Members) passed

- if a written resolution, by Members representing not less than 75% of the total voting rights of eligible Members,
- (ii) on a show of hands at a meeting, by a majority not less than 75% of the votes cast by those entitled to vote,
- (III) on a poll at a meeting, by Members representing not less than 75% of the total voting rights of the Members who (being entitled to do so) vote in person, by proxy or (if applicable) in advance,

United Kingdom

means the United Kingdom of Great Britain and Northern Ireland,

writing

means the representation or reproduction of words, symbols or other information in a visible form by any method or combination of methods, whether sent or supplied in electronic form or otherwise

- 1 2 Unless the context otherwise requires, words or expressions contained in these Articles shall bear the same meaning as in the Act but excluding any statutory modification thereof not in force when these Articles become binding on the Charity
- 1.3 All words importing the singular number shall include the plural and vice versa and words importing the masculine gender shall include the feminine.
- 1 4 Headings in the Articles are used for convenience only and shall not affect the construction or interpretation of the Articles
- 1 5 The Model Articles shall not apply to the Charity

CHARITY DETAILS

2 Name

The name of the Charity is The Legatum Institute Foundation

3 Registered office

The registered office of the Charity is to be situated in England and Wales

OBJECTS AND POWERS

4 Objects

The Charity's objects are to advance the education of the public in national and international political, social and economic policy, including the promotion of research in any of those areas and the publication of the useful results of such research

5 Powers

The Charity has power to do anything lawful which is calculated to further the Objects, or any of them, or is conducive or incidental to doing so. In particular, and without limiting the foregoing, the Charity's powers include power.

- 5 1 to publish or distribute information;
- to hold exhibitions, meetings, lectures, classes, seminars or courses either alone or with others.
- 5 3 to cause to be written, printed or otherwise reproduced and circulated, gratuitously or otherwise, periodicals, magazines, books, leaflets or other documents, films, recorded tapes or materials reproduced on electronic media,
- to foster and undertake research into any aspect of the Objects and its work and to disseminate and exchange the results of any such research,
- to accept any gift or transfer of money or any other property whether or not subject to any special trust,
- to raise funds, provided that in doing so the Charity shall not undertake any substantial permanent taxable trading and shall comply with any relevant statutory regulations,
- 5 7 to purchase or form trading companies alone or jointly with others,
- to buy, take on lease or exchange, hire or otherwise acquire and hold any real or personal estate,

- 5 9 to maintain, alter or equip for use any real or personal estate;
- 5 10 to erect, maintain, improve, or alter any buildings in which the Charity for the time being has an interest,
- 5.11 subject to such consents as may be required by law to sell, lease or otherwise dispose of all or any part of the real or personal estate belonging to the Charity;
- 5 12 subject to such consents as may be required by law to borrow or raise money and to give security for loans or grants,
- 5 13 to make grants or loans of money, to give guarantees and become or give security for the performance of contracts and to grant powers of attorney by way of security for the performance of obligations,
- 5 14 to co-operate, including exchanging information and advice, and enter into arrangements with other bodies, international, national, local or otherwise,
- to establish or support any charitable trusts, associations, companies, institutions or other bodies formed for any of the charitable purposes included in the Objects,
- 5 16 to acquire or merge with any other charity formed for any of the Objects,
- 5 17 to enter into partnership, joint venture or other arrangement with any body with objects similar in whole or part to the Objects,
- to affiliate to or accept affiliation from any body with objects similar in whole or part to the Objects,
- 5 19 to set aside funds for special purposes or as reserves against future expenditure in accordance with a written reserves policy,
- 5 20 to deposit or invest funds with all the powers of a beneficial owner, but to invest only after obtaining advice from a financial expert (as defined in Article 5 21) and having regard to the suitability of investments and the need for diversification,
- 5 21 to delegate the management of investments to a financial expert but only on terms that
 - 5 21.1 the investment policy is set down in writing for the financial expert by the Directors,
 - 5 21 2 make provision for appropriate and regular reporting obligations to the Directors or to a committee authorised by the Directors to receive such reports in respect of all transactions,
 - 5 21.3 the performance of the investments is reviewed regularly with the Directors,
 - 5 21 4 the Directors shall be entitled to cancel the delegation arrangement at any time;
 - 5 21 5 the investment policy and the delegation arrangement are reviewed at least once a year,

- 5 21 6 all payments due to the financial expert are on a scale or at a level which is agreed in advance and are notified promptly to the Directors on receipt, and
- 5 21 7 the financial expert must not do anything outside the powers of the Directors,

and financial expert means a person who is reasonably believed by the Directors to be qualified to give advice in relation to investments by reason of his ability in and practical experience of financial and other matters relating to investments,

- to arrange for investments or other property of the Charity to be held in the name of a nominee (being a corporate body registered or having an established place of business in the United Kingdom) under the control of the Directors or of a financial expert (as defined in Article 5.21) acting under their instructions and to pay any reasonable fee required,
- to insure and arrange insurance cover of every kind and nature in respect of the Charity, its property and assets and take out other insurance policies to protect the Charity, its employees, volunteers or members as required,
- 5 24 to provide indemnity insurance to cover the liability of the Directors or any other officer of the Charity
 - which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default, breach of trust, or breach of duty of which he may be guilty in relation to the Charity but not extending to.
 - (a) any liability resulting from conduct which the Directors knew, or must reasonably be assumed to have known, was not in the interests of the Charity, or where the Directors did not care whether such conduct was in the best interests of the Charity or not,
 - (b) any liability to pay the costs of unsuccessfully defending criminal prosecutions for offences arising out of the fraud or dishonesty or wilful or reckless misconduct of the Directors,
 - (c) any liability to pay a fine or regulatory penalty
 - 5.24.2 to make contributions to the assets of the Charity in accordance with the provisions of section 214 of the Insolvency Act 1986 but not extending to any liability to make such a contribution where the basis of the Director's liability is his knowledge prior to the insolvent liquidation of the Charity (or reckless failure to acquire that knowledge) that there was no reasonable prospect that the Charity would avoid going into insolvent liquidation,
- to employ and pay any person or persons to supervise, organise, carry on the work of and advise the Charity provided that the Charity may only employ a Director to the extent permitted in Article 6 and subject to compliance with the conditions set out there,
- 5 26 subject to the provisions of Article 6 to pay reasonable annual sums or premiums for or towards the provision of pensions for officers or employees for the time being of the Charity or their dependants.

- 5 27 to enter into contracts to provide services to or on behalf of other bodies.
- 5 28 to establish subsidiary companies to assist or act as agents for the Charity,
- 5 29 to act as trustee of any trust,
- 5 30 to make any charitable donation either in cash or assets,
- 5 31 to obtain any Act of Parliament or other order or authority or to promote, support or oppose legislative or other measures or proceedings or to petition the Crown, Parliament or other public persons or bodies in the United Kingdom in respect of any matter affecting the interests of the Charity;
- to pay out of the funds of the Charity the costs, charges and expenses of and incidental to the formation and registration of the Charity as a company and as a charity.

APPLICATION, PAYMENT OR DISTRIBUTION OF THE CHARITY'S PROPERTY AND INCOME AND LIMITED LIABILITY OF MEMBERS

6 Application of income and property

- The income and property of the Charity shall be applied solely towards the promotion of the Objects
- None of the income or property of the Charity may be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise by way of profit to Members of the Charity This does not prevent a Member who is not also a Director of the Charity receiving
 - 6 2 1 a benefit from the Charity in the capacity of a beneficiary of the Charity,
 - 6 2.2 reasonable and proper remuneration for any goods or services rendered to the Charity,
 - 623 interest on money lent to the Charity at a reasonable and proper rate note exceeding either 2% below the base lending rate prescribed for the time being by a clearing bank in London selected by the Directors or 3%, whichever is the greater,
 - 6 2 4 reasonable and proper rent for premises demised or let to the Charity,
 - 6 2.5 any premium in respect of insurance to cover any of the liabilities specified in Article 5

A Member who is also a Director may only receive a benefit, directly or indirectly, in accordance with Article 6.3 below

6.3 A Director (or connected person)

- 6 3 1 shall be entitled to be paid reasonable out-of-pocket expenses properly incurred when acting on behalf of the Charity,
- 6.3 2 may receive an indemnity from the Charity in accordance with Article 38;
- 6 3 3 may benefit from insurance cover, including indemnity insurance, purchased at the expense of the Charity in accordance with Article 5,

subject thereto no Director may receive any payment or other material benefit, directly or indirectly, from the Charity unless

- 6 3 4 the payment is expressly permitted in Article 6 4 below and the conditions set out in Article 6 5 are followed, or
- 6 3 5 the Directors obtain the prior written approval of the Charity Commission
- 6.4 A Director (or a connected person) may directly or indirectly
 - 6 4 1 receive a benefit in the capacity of a beneficiary of the Charity,
 - 6.4.2 receive fees, remuneration or other benefit in money or money's worth under a contract for the supply of goods or services to the Charity other than for acting as a Director.
 - receive interest on money lent to the Charity at a reasonable and proper rate not exceeding either 2% per annum below the base lending rate prescribed for the time being by a clearing bank in London selected by the Directors or 3%, whichever is the greater,
 - 6 4 4 receive reasonable and proper rent for premises demised or let to the Charity.
- 6 5 The authority in Article 6 4 above is subject to the following conditions being satisfied
 - 6.5.1 the remuneration or other sums paid to or for the benefit of the Director (or connected person) do not exceed an amount which is reasonable in all the circumstances.
 - prior to any payment being made to the Director (or connected person) or for his benefit (other than in his capacity as a beneficiary) an appropriate written contract is concluded between the Director (or connected person) and the Charity containing the full details of his duties and obligations to the Charity the amount of remuneration payable to him and all other relevant terms and conditions and copies of all such contracts are retained by the Charity for inspection by any authorised person,
 - the other Directors are satisfied that it is in the interests of the Charity to contract with that Director (or connected person) rather than with someone who is not a Director (or connected person). In reaching that decision the Directors shall balance the advantage of contracting with the Director (or connected person) against the disadvantages of doing so (including the loss of the Director's services as a result of dealing with the Director's conflict of interests),

- a majority of the Directors then in office are not in receipt of such payments or benefits (and, for the purposes of this Article 6.5, a Director shall be treated as being in receipt of such payments or benefits if a person connected with that Director is in receipt of such payments or benefits); and
- the provisions of Article 7 below are observed in relation to any discussions of the Directors concerning that Director's (or that connected person's) interest, his remuneration or any variation of his remuneration

7 Payment of Chief Executive Officer who is also a Director

The Chief Executive Officer may be remunerated by fees, remuneration, salary, pension contributions or receive other benefits in money or money's worth from the Charity albeit that they are a Director on condition that

- the duties carried out or services provided by the remunerated Chief Executive Officer are actually required by the Charity for the attainment of the Objects.
- the nature and level of the fees or remuneration paid to the Chief Executive Officer is reasonable in relation to the services they have provided and the resources of the Charity,
- 7.3 prior to any payment being made to them, an appropriate written contract is concluded between the Chief Executive Officer and the Charity containing the full details of their duties and obligations to the Charity, the amount of remuneration payable to them and all other relevant terms and conditions and that copies of all such contracts are retained by the Charity for inspection by any authorised person, and
- 7.4 the provisions of Article 8.6 are observed in relation to any discussions of the Directors concerning the Chief Executive Officer's interest, their remuneration or any variation to their remuneration

8 Conflicts of interests and duties

- 8.1 Unless Article 8.3 applies, a Director must declare the nature and extent of
 - any direct or indirect interest he has in a proposed transaction or arrangement with the Charity, and
 - any duty or any direct or indirect interest he has which conflicts or may conflict with the interests of the Charity or his duties to the Charity
- 8 2 A declaration required by Article 8.1 shall be made.
 - 8 2.1 at a meeting of the Directors, or
 - 8 2 2 by notice in writing to the other Directors in accordance with the Act,

in either case before the Charity enters into any proposed transaction or arrangement to which it relates

- There shall be no need for a Director to declare any interest or duty of which the other Directors are already aware (or ought reasonably to be aware)
- 8 4 If a Director's interest or duty can not reasonably be regarded as likely to give rise to a conflict of interests or a conflict of duties with or in respect of the Charity, the Director is entitled to participate in the decision-making process, to be counted in the quorum and to vote in relation to the matter. Any uncertainty about whether a Director's interest or duty is likely to give rise to a conflict shall be determined by a majority decision of the other Directors taking part in the decision-making process
- 8 5 If a Director's interest or duty gives rise (or could reasonably be regarded as likely to give rise) to a conflict of interests or a conflict of duties with or in respect of the Charity, that Director (the **conflicted Director**) may participate in the decision-making process and may be counted in the quorum and vote unless
 - the decision could result in the conflicted Director (or a connected person) receiving a benefit other than
 - 8 5 1 1 any benefit received in his, her or its capacity as a beneficiary of the Charity (as permitted under Article 6 4 1) and which is available to the beneficiaries of the Charity generally,
 - the payment of premiums in respect of indemnity insurance effected in accordance with Article 5 24;
 - 8 5 1 3 payment under the indemnity set out at Article 38, and
 - 8 5 1.4 reimbursement of expenses in accordance with Article 6.3.1; or
 - a majority of the other Directors participating in the decision-making process decide to the contrary,

in which case the conflicted Director must comply with Article 8 6

- 8.6 If the conflicted Director is required to comply with this Article 8.6, the conflicted Director must
 - take part in the decision-making process only to such extent as, in the view of the other Directors, is necessary to inform the debate,
 - 8 6.2 not be counted in the quorum for that part of the process, and
 - 8 6 3 withdraw during the vote and have no vote on the matter,

and, in the case of a resolution in writing circulated in accordance with Article 30 15, any Director who has already voted may, on being notified of the conflict, withdraw his vote

8 7 Where a conflicted Director has complied with his obligations under the Articles in respect of the conflict

- 8 7 1 the conflicted Director shall not be in breach of his duties to the Charity by withholding confidential information from the Charity if to disclose it would result in a breach of any other duty or obligation of confidence owed by him, and
- 8.7 2 the conflicted Director shall not be accountable to the Charity for any benefit expressly permitted under the Articles which he (or a connected person) derives from any office or employment or from any transaction or arrangement

9 Limited liability of Members

The liability of the Members is limited to £1, being the amount that each Member undertakes to contribute to the assets of the Charity in the event of the same being wound up while he is a Member, or within one year after he ceases to be a Member, for

- 9.1 payment of the debts and liabilities of the Charity contracted before he ceases to be a Member,
- 9.2 payment of the costs, charges and expenses of winding up, and
- 9 3 adjustment of the rights of the contributories among themselves

10 Surplus assets

- 10.1 If on the winding-up or dissolution of the Charity there remains, after the satisfaction of all its debts and liabilities, any property whatever of the Charity (the Charity's surplus assets), the same shall not be paid to or distributed among the Members of the Charity, but shall be given or transferred in accordance with this Article
- The Members of the Charity may at any time before, and in expectation of, its dissolution resolve that the Charity's surplus assets shall on or before the dissolution of the Charity be applied or transferred in any of the following ways
 - 10 2.1 directly for one of more of the Objects,
 - 10 2 2 to any one or more charities for purposes which are similar to the Objects; or
 - 10 2 3 to any one or more charities for use for particular purposes falling within the Objects
- Subject to any such resolution of the Members of the Charity, the Directors of the charity may at any time before and in expectation of its dissolution resolve that the Charity's surplus assets shall on or before dissolution of the Charity be applied or transferred in any of the following ways:
 - 10.3 1 directly for one of more of the Objects.
 - 10 3 2 to any one or more charities for purposes which are similar to the Objects, or

- 10 3 3 to any one or more charities for use for particular purposes falling within the Objects
- 10.4 In the event of no resolution being passed by the Members or the Directors in accordance with this Article on the winding-up or dissolution of the Charity, the Charity's surplus assets shall be applied for charitable purposes as directed by the Court or the Charity Commission
- 10.5 If the Charity is a trustee of any trusts at the time it is wound up or dissolved, the Charity shall procure the appointment of a new trustee or trustees of those trusts in the place of the Charity

MEMBERSHIP

11 Members

- 11.1 The Members shall be the first named subscribers to the Memorandum and such other persons as the Members shall admit to membership of the Charity. No other persons shall be admitted to membership of the Charity.
- 11.2 Membership is not transferable
- 11.3 The Charity shall maintain a register of Members

12 Classes of membership

Subject to the requirements of Article 30 12, the Directors may establish different classes of membership and prescribe their respective privileges and duties and set the amounts of any subscriptions

13 Single Member arrangements

Where the Charity has only one Member

- 13.1 the quorum for a general meeting shall be one Member present in person or by proxy,
- the Member can take any decision which may be taken by the Charity in general meeting and which shall have effect as if agreed by the Charity in general meeting, provided that the Member shall (unless that decision is taken by way of a written resolution) provide the Charity with a written record of that decision

14 Termination of membership

Membership is terminated if

14.1 the Member dies or, if it is an organisation, ceases to exist;

- the Member retires by written notice to the Charity provided that after such retirement the number of Members is not less than one.
- any sum due from the Member to the Charity has been wholly or partly outstanding for at least six months and the Charity serves notice in writing on the Member terminating the membership. In such circumstances the termination of membership shall take effect from the date and time when the notice is served.
- 14.4 in the case of a Director of the Charity, the Member ceases to be a Director

MEETINGS OF MEMBERS

15 General meetings

- 15.1 The Directors may call general meetings
- On the requisition of Members pursuant to the Act the Directors shall forthwith proceed to convene a general meeting in accordance with the provisions of the Act. If there are not within the United Kingdom sufficient Directors to call a general meeting, any Director or any Member may call a general meeting in accordance with the provisions of the Act.

16 Notice of general meetings

- 16.1 General meetings shall be called by at least 14 clear days' notice
- A general meeting may be called by shorter notice if it is so agreed by a majority in number of the Members having a right to attend and vote at the meeting, being a majority together representing not less than 90% of the total voting rights at that meeting of all the Members
- The notice shall specify the place, the day and the time of meeting, the general nature of the business to be transacted and a statement pursuant to the Act informing the Member of his rights regarding proxies
- Subject to the provisions of the Articles and to any restrictions imposed on any classes of membership, notice of general meeting shall be given in any manner authorised by these Articles to
 - every Member except those Members who (having no registered address within the United Kingdom) have not supplied to the Charity an address within the United Kingdom for the giving of notices to them,
 - the auditor for the time being of the Charity, and
 - 16.4 3 each Director,

and no other person shall be entitled to receive notice of general meetings

- The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any person entitled to receive notice shall not invalidate the proceedings at that meeting
- A Member present at any meeting of the Charity either in person or by proxy shall be deemed to have received notice of the meeting and, where requisite, of the purposes for which it was called

17 Proxies

- 17.1 A Member is entitled to appoint another person as his proxy to exercise all or any of his rights to attend and to speak and vote at a general meeting of the Charity
- 17.2 Proxies may only validly be appointed by a notice in writing (a proxy notice) which:
 - 17.2 1 states the name and address of the Member appointing the proxy,
 - 17.2.2 Identifies the person appointed to be that Member's proxy and the general meeting in relation to which that person is appointed,
 - 17.2.3 is signed by or on behalf of the Member appointing the proxy, or is authenticated in such manner as the Directors may determine, and
 - 17 2 4 is delivered to the Charity in accordance with the Articles and any instructions contained in the notice of the general meeting to which they relate
- 17.3 The Charity may require proxy notices to be delivered in a particular form, and may specify different forms for different purposes
- 17.4 Proxy notices may specify how the proxy appointed under them is to vote (or that the proxy is to abstain from voting) on one or more resolutions
- 17.5 Unless a proxy notice indicates otherwise, it must be treated as
 - allowing the person appointed under it as a proxy discretion as to how to vote on any ancillary or procedural resolutions put to the meeting, and
 - appointing that person as a proxy in relation to any adjournment of the general meeting to which it relates as well as the meeting itself

17 6 Proxy notices may

17 6 1 In the case of an instrument in writing be deposited at the office or at such other place within the United Kingdom as is specified in the notice convening the meeting or in any instrument of proxy sent out by the Charity in relation to the meeting not less than 48 hours (not counting any part of a day that is not a working day) before the time for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote, or

- 17.6.2 In the case of an appointment in electronic form, where an address has been specified for the purpose of receiving documents in electronic form
 - 17 6 2 1 in the notice convening the meeting, or
 - 17.6 2 2 in any instrument of proxy sent out by the Charity in relation to the meeting, or
 - 17 6 2 3 In any invitation in electronic form to appoint a proxy issued by the Charity in relation to the meeting,

be received at such address not less than 48 hours before (not counting any part of a day that is not a working day) the time for holding the meeting or adjourned meeting at which the person named in the proxy notice proposes to vote;

- in the case of a poll taken more than 48 hours after it is demanded, be deposited or received as aforesaid after the poll has been demanded and not less than 24 hours before (not counting any part of a day that is not a working day) the time appointed for the taking of the poll, or
- 17.6.4 In the case of a poll which is not taken forthwith but taken not more than 48 hours after it was demanded, be delivered at the meeting at which the poll was demanded to the chairman or to the Secretary or to any Director,

and a proxy notice which is not deposited, delivered or received in a manner so permitted shall be invalid.

- 17.7 A person who is entitled to attend, speak or vote (either on a show of hands or on a poll) at a general meeting remains so entitled in respect of that meeting or any adjournment of it, even though a valid proxy notice has been delivered to the Charity by or on behalf of that person
- An appointment under a proxy notice may be revoked by delivering to the Charity a notice in writing given by or on behalf of the person by whom or on whose behalf the proxy notice was given
- 17.9 A notice revoking a proxy appointment only takes effect if it is delivered before the start of the meeting or adjourned meeting to which it relates

18 Representation of organisations at general meetings

- Where an organisation is a Member of the Charity, it may authorise any person to act as its representative at any meeting of the Charity. Such a representative shall, subject to Article 18.2, be entitled to exercise on behalf of the Member organisation the same powers as the organisation could exercise if it were an individual Member of the Charity.
- Written notice of the representative's authority shall be given to the Charity, failing which the Charity shall not be required to accept the right of the representative to exercise the organisation's rights at meetings. Any such notice given to the Charity shall be conclusive evidence that the representative is entitled to represent the organisation and that his or her

- authority has not been revoked. The Charity shall not be required to consider whether the representative has been properly authorised by the organisation.
- 18.3 The Charity shall be entitled to regard the representative as eligible to represent the Member organisation until written notice to the contrary is received by the Charity

19 Organisation at general meetings

- 19.1 No business shall be transacted at any general meeting unless a quorum is present
- 19.2 Save in cases where the Charity has a single Member, two persons entitled to vote upon the business to be transacted, each being a Member or a proxy for a Member or a duly authorised representative of a Member organisation, shall be a quorum.
- 19.3 There shall be a chairman of every general meeting.
 - 19 3 1 The chairman, if any, of the Directors shall chair every general meeting of the Charity
 - 19.3 2 If at any meeting the chairman is not present within ten minutes after the time appointed for the holding of the meeting and willing to act, the Directors present shall elect one of their number to chair the meeting
 - 19.3.3 If there is only one Director present and willing to act, he shall chair the meeting.
 - 19.3.4 If at any meeting no Director is willing to act as chairman or if no Director is present within ten minutes after the time appointed for the holding of the meeting, the Members present shall choose one of their number to chair the meeting.
- 19.4 If within thirty minutes from the time appointed for the meeting a quorum is not present, or if during a meeting a quorum ceases to be present, the meeting
 - 19 4.1 if convened on the requisition of Members, shall be dissolved;
 - 19.4 2 in any other case, shall be adjourned to the same day in the next week, at the same time and place, or to such other day and at such other time and place as the Directors may determine.
- 19.5 In relation to adjournment of meetings:
 - the chairman may, with the consent of any meeting at which a quorum is present (and shall if so directed by the meeting), adjourn the meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place,
 - when a meeting is adjourned for fourteen days or more, the Charity shall give at least seven clear days' notice of it to the same persons to whom notice of the Charity's general meetings is required to be given, and containing the same information which such notice is required to contain,

otherwise it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting.

20 Attendance and speaking at general meetings

- A person is able to exercise the right to speak at a general meeting when that person is in a position, during the meeting, to communicate to all those attending the meeting any information or opinions which that person has on the business of the meeting
- 20.2 A person is able to exercise the right to vote at a general meeting when.
 - 20.2.1 that person is able to vote, during the meeting, on resolutions put to the vote at the meeting, and
 - 20 2 2 that person's vote can be taken into account in determining whether or not such resolutions are passed at the same time as the votes of all the other persons attending the meeting
- The Directors may make whatever arrangements they consider appropriate to enable those attending a general meeting to exercise their rights to speak or vote at it
- In determining attendance at a general meeting, it is immaterial whether any two or more Members attending it are in the same place as each other
- Two or more persons who are not in the same place as each other attend a general meeting if their circumstances are such that if they have (or were to have) rights to speak and vote at that meeting, they are (or would be) able to exercise them

DECISIONS OF MEMBERS

21 Voting at general meetings

- A resolution put to the vote of a general meeting shall be decided on a show of hands unless before, or on the declaration of the result of, the show of hands a poll is duly demanded
- 21.2 Unless a poll is duly demanded, a declaration by the chairman and an entry to that effect in the minutes of proceedings of the Charity that a resolution has on a show of hands been carried or carried unanimously, or by a particular majority, or lost, shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against such resolution

22 Votes of members

- 22.1 Every Member, whether an individual or organisation, shall have one vote
- 22 2 Where a Member

- 22 2.1 is an individual and appoints more than one proxy, the exercise by the Member and/or his proxies taken together shall not give more extensive voting rights to that Member than could be exercised by the Member in person,
- 22.2 2 is an organisation and authorises more than one representative, the exercise by the representatives taken together shall not give more extensive voting rights to that Member than could be exercised by the Member if it were an individual attending in person
- No objection shall be raised to the qualification of any voter except at the meeting or adjourned meeting at which the vote objected to is tendered, and every vote not disallowed at the meeting shall be valid. Any objection made in due time shall be referred to the chairman whose decision shall be final and conclusive.

23 Written resolutions

- 23.1 Save for a resolution to remove a Director before the expiration of his period of office or to remove an auditor before the expiration of his term of office, any resolution of the Members may be proposed and passed as a written resolution in accordance with the Act
- A written resolution shall lapse if it is not passed before the end of 28 days beginning with the date on which the resolution is circulated in accordance with the Act.

DIRECTORS

24 Directors

- 24.1 Unless otherwise determined by Ordinary Resolution, the maximum number of Directors shall be eight and the minimum number of Directors shall be three
- 24.2 A Director may not appoint an alternate director or anyone to act on his behalf at meetings of the Directors

25 Appointment of Directors

- Any person who is willing to act as a Director, and is permitted by law to do so, may be appointed to be a Director by Ordinary Resolution
- No appointment of a Director may be made which would cause the number of Directors to exceed any number fixed as the maximum number of Directors
- 25 3 Subject to Articles 26 and 27 a Director shall hold office until his retirement in accordance with Article 28

26 Removal of Directors

The Charity may by Ordinary Resolution of which special notice has been given to the Charity in accordance with the Act remove any Director before the expiration of his period of office notwithstanding anything in these Articles or in any agreement between the Charity and such Director.

27 Disqualification or vacation of office of Directors

The office of Director shall be vacated if

- 27.1 the Director ceases to be a Director by virtue of any provision of the Act or becomes prohibited by law from being a Director,
- 27.2 the Director is disqualified from acting as a charity trustee by virtue of the Charities Act,
- 27.3 the Director becomes bankrupt or makes any arrangement or composition with his creditors generally,
- 27.4 a registered medical practitioner who is treating the Director gives a written opinion to the Charity stating that the Director has become physically or mentally incapable of acting as a director and may remain so for more than three months.
- 27 5 a court makes an order which wholly or partly prevents the Director from personally exercising any powers or rights which he would otherwise have and the Directors resolve that his office be vacated;
- 27.6 the Director resigns his office by written notice to the Charity provided at least three Directors remain in office after the resignation takes effect,
- the Director is absent from all Directors' meetings without leave for one year and the Directors resolve that his office be vacated;
- 27.8 the Director is directly or indirectly interested in any contract with the Charity and fails to declare the nature of his interest as required by the Act or the Articles and the Directors resolve that the office be vacated,
- 27.9 the Director is deemed by HM Revenue & Customs not to be a fit and proper person to be a manager of the Charity and the Directors resolve that his office be vacated,
- 27 10 the Director fails to agree to a reasonable request by the Directors that the Director signs a declaration that they are a fit and proper person to act as such and the Directors resolve that his office be vacated,
- 27 11 the Director's conduct leads to the Directors deciding to make a serious incident report to the Charity Commission and the Directors resolve that his office be vacated, or
- 27 12 the Director fails to agree to a reasonable request by the Directors for a Disclosure and Barring Service (DBS) check (or equivalent).

28 Retirement of Directors

- Once in every 12 month period, one third of the Directors or if their number is not three or a multiple of three, the number nearest to one third shall retire from office
- The Directors to retire by rotation shall be those who have been longest in office since their last appointment or re-appointment, but as between persons who became appointed or were last re-appointed on the same day those to retire shall (unless they otherwise agree among themselves) be determined by a secret ballot of all the Directors
- 28.3 Subject to Article 28.4, a person retiring from the office of Director shall be eligible for reappointment either by the Directors or by the Members
- 28.4 No Director shall serve for a consecutive period of more than nine years

29 Powers and duties of the Directors

- 29 1 Subject to the provisions of the Act and the Articles and to any directions given by Special Resolution, the business of the Charity shall be managed by the Directors who may exercise all the powers of the Charity
- 29.2 No alteration of the Articles and no direction given by Special Resolution shall invalidate anything which the Directors have done before the making of the alteration or the passing of the resolution
- 29.3 A meeting of the Directors at which a quorum is present may exercise all powers exercisable by the Directors.

30 Proceedings and decisions of the Directors

- 30.1 Subject to the provisions of the Articles, the Directors may regulate their proceedings as they think fit
- 30.2 The Directors shall, no later than the first day of November in each year, prepare a draft budget and business plan for the following year for approval by the Members in accordance with Article 30.12
- 30.3 The Directors shall meet as regularly as is necessary to conduct the business of the Charity
- 30 4 A meeting of the Directors
 - 30 4 1 may be called by any Director, and
 - 30 4 2 shall, at the request of a Director, be called by the Secretary (if any)
- 30.5 Notice of any meeting of the Directors must indicate
 - 30 5 1 its proposed date, time and subject matter,

- 30 5 2 where it is to take place, and
- 30 5 3 If it is anticipated that Directors participating in the meeting will not be in the same place, how it is proposed that they should communicate with each other during the meeting
- 30.6 In fixing the date and time of any meeting of the Directors, the person calling it shall try to ensure, subject to the urgency of any matter to be decided by the Directors, that as many Directors as practicable are likely to be available to participate in it
- 30.7 Notice of a meeting of the Directors must be given to each Director in writing
- 30.8 Notice of a meeting of the Directors need not be given to Directors who waive their entitlement to notice of that meeting, which they may do by giving notice to that effect to the Charity seven days before or after the date on which the meeting is held. Where such notice is given after the meeting has been held, that does not affect the validity of the meeting, or of any business conducted at it.
- 30.9 Directors are to be treated as having waived their entitlement to notice of a meeting if they have not supplied the Charity with the information necessary to ensure that they receive the notice before the meeting takes place
- 30 10 Any Director may participate in a meeting of the Directors by means of video conference, telephone or any suitable electronic means agreed by the Directors whereby all persons participating in the meeting can communicate with all the other participants and participation in such a meeting shall constitute presence in person at that meeting.
- 30 11 In relation to the quorum for a meeting of the Directors
 - 30 11 1 no decision other than a decision to call a meeting of the Directors or a general meeting shall be taken by the Directors unless a quorum participates in the decision-making process,
 - 30.11 2 the quorum for decision-making by the Directors may be fixed from time to time by a decision of the Directors, provided it shall not be less than two, and unless otherwise fixed it is two;
 - 30 11 3 If the total number of Directors for the time being is less than the quorum required for decision-making by the Directors, the Directors shall not take any decision other than a decision
 - 30 11.3 1 to appoint further Directors, or
 - 30 11 3.2 to call a general meeting so as to enable the Members to appoint further Directors,
 - 30.11 4 a Director shall not be counted in the quorum present at a meeting in relation to a resolution on which he is not entitled to vote

30 12 Questions arising at a meeting shall be decided by a majority of votes, save that any decision concerning Restricted Business shall not be taken unless first approved by resolution of the Charity in general meeting

30 13

- 30 13 1 At their first meeting the Directors shall elect a chairman from among their number and shall determine the period for which he or she is to hold office, although he or she shall always be eligible for re-election
- 30 13 2 If at any meeting the chairman is not present within ten minutes after the time appointed for holding the same, or if there is no chairman, the Directors present shall choose one of their number to chair the meeting
- 30 13 3 In the case of an equality of votes, the chairman shall have a second or casting vote. But this does not apply if, in accordance with the Articles, the chairman is not to be counted as participating in the decision-making process for quorum, voting or agreement purposes. No Director in any other circumstances shall have more than one vote.
- 30 14 All acts done by any meeting of the Directors or of a committee, or by any person acting as a Director, shall, notwithstanding that it be afterwards discovered that
 - 30.14 1 there was some defect in the appointment of any such Director or person acting as a Director, or
 - 30 14 2 they or any of them were disqualified, or
 - 30 14 3 they or any of them were not entitled to vote on the matter,

be as valid as if every such person had been duly appointed and was qualified to be a Director

- 30.15 A resolution in writing, signed by all the Directors entitled to receive notice of a meeting of the Directors and to vote upon the resolution shall be as valid and effectual as if it had been passed at a meeting of the Directors duly convened and held and may consist of several documents in like form each signed by one or more Directors
- 30 16 Subject to the Articles, the Directors may make any rules which they think fit about how they take decisions, and about how such rules are to be recorded or communicated to the Directors

31 Delegation by the Directors

- The Directors may delegate any of their powers to any committee consisting of one or more Directors.
- The Directors shall determine the terms of any delegation to such a committee and may impose conditions, including that

- the relevant powers are to be exercised exclusively by the committee to whom the Directors delegate,
- 31.2 2 no expenditure may be incurred on behalf of the Charity except in accordance with a budget previously agreed with the Directors.
- 31.3 Subject to and in default of any other terms imposed by the Directors:
 - 31 3 1 the chairman shall be an ex-officio member of every committee appointed by the Directors,
 - 31 3 2 the members of a committee may, with the approval of the Directors, appoint such persons, not being Directors, as they think fit to be members of that committee,
 - a committee may elect a chairman of its meetings, if no such chairman is elected, or, if at any meeting the chairman is not present within ten minutes after the time appointed for holding the same, the members present may choose one of their number to chair the meeting.
 - 31.3 4 a committee may meet and adjourn as it thinks proper,
 - 31 3 5 questions arising at any meeting shall be determined by a majority of votes of the committee members present, and
 - 31 3 6 In the case of an equality of votes the chairman of the committee shall have a second or casting vote,

and subject thereto committees to which the Directors delegate any of their powers shall follow procedures which are based as far as they are applicable on those provisions of the Articles which govern the taking of decisions by the Directors.

- 31.4 The terms of any delegation to a committee shall be recorded in the minute book
- 31.5 The Directors may revoke or alter a delegation
- 31.6 All acts and proceedings of committees shall be reported to the Directors fully and promptly
- 32 Delegation of day to day management
- 32.1 The Directors may delegate day to day management and administration of the Charity to one or more managers on such terms and conditions as the Directors think fit
- 32.2 In respect of each manager the Directors shall
 - 32.2.1 provide a description of the manager's role, and
 - 32 2 2 set the limits of the manager's authority
- 32.3 The managers shall report regularly and promptly to the Directors on the activities undertaken in accordance with their role

32.4 The Directors may revoke any delegation in whole or in part, or alter its terms and conditions

SECRETARY AND MINUTES

33 Secretary

- 33.1 Subject to the provisions of the Act, any Secretary shall be appointed by the Directors for such term at such remuneration and on such conditions as the Directors may think fit. Any Secretary so appointed by the Directors may be removed by them.
- 33.2 A Secretary who is also a Director may not be remunerated save as permitted in accordance with the Articles

34 Minutes

- 34.1 The Directors shall ensure that the Charity keeps records, in writing, comprising
 - 34 1 1 minutes of all proceedings at general meetings,
 - 34 1 2 copies of all resolutions of Members passed otherwise than at general meetings,
 - 34 1 3 details of appointments of officers made by the Directors, and
 - 34 1 4 minutes of meetings of the Directors and committees of the Directors, including the names of the Directors present at the meeting.
- 34.2 The Directors shall ensure that the records comprising 34.1.1 and 34.1.2 above shall be kept for at least 10 years from the date of the meeting or resolution, as the case may be

ACCOUNTS AND AUDIT

35 Accounts

- 35.1 The Directors shall comply with the requirements of the Act and of the Charities Act for keeping financial records, the audit or other scrutiny of accounts (as required) and the preparation and transmission to the Registrar of Companies and the Charity Commission, as the case may be, of
 - 35 1 1 annual reports,
 - 35 1 2 annual returns, and
 - 35 1.3 annual statements of account

- Accounting records relating to the Charity shall be made available for inspection by any Director at any reasonable time during normal office hours and may be made available for inspection by Members who are not Directors if the Directors so decide
- 35.3 The Directors shall supply a copy of the Charity's latest available statement of account to any Director or Member on request, and within two months of the request to any other person who makes a written request and pays the Charity's reasonable costs of complying with the request

36 Audit

Auditors shall be appointed and their duties regulated as required in accordance with the Act and the Charities Act

COMMUNICATION

37 Means of communication

- 37.1 Subject to the Articles, the Charity may deliver a notice or other document to a Member
 - 37 1 1 by delivering it by hand to an address as provided in accordance with paragraph 4 of schedule 5 to the Act,
 - 37.1 2 by sending it by post or other delivery service in an envelope (with postage or delivery paid) to an address as provided in accordance with paragraph 4 of schedule 5 to the Act;
 - 37.1 3 by fax to a fax number notified by the Member in writing,
 - 37 1 4 In electronic form to an address notified by the Member in writing,
 - 37 1 5 by a website, the address of which shall be notified to the Member in writing, or
 - 37 1.6 by advertisement in at least two national newspapers
- 37.2 This Article does not affect any provision in any relevant legislation or the Articles requiring notices or documents to be delivered in a particular way

37 3 If a notice or document

- 37 3 1 is delivered by hand, it is treated as being delivered at the time it is handed to or left for the Member
- 37 3 2 is sent by post or other delivery service in accordance with Article 37 1 2 above it is treated as being delivered.
 - 37 3.2 1 24 hours after it was posted, if first class post was used, or

37.3.2 2 48 hours after it was posted or given to delivery agents, if first class post was not used,

provided it can be proved that a notice or document was delivered by post or other delivery service by showing that the envelope containing the notice or document was

- 37 3.2 3 properly addressed, and
- 37 3 2 4 put into the postal system or given to delivery agents with postage or delivery paid
- 37.3 3 is sent by fax, providing that the Charity can show that it was sent to the fax number provided by the Member, it is treated as being delivered at the time it was sent.
- 37 3.4 is sent in electronic form, providing that the Charity can show that it was sent to the electronic address provided by the Member, it is treated as being delivered at the time it was sent
- 37.3 5 is sent by a website, it is treated as being delivered when the material was first made available on the website, or if later, when the recipient received (or is deemed to have received) notice of the fact that the material was available on the website.
- 37.4 If a notice is given by advertisement, it is treated as being delivered at midday on the day when the last advertisement appears in the newspapers

INDEMNITY

38 Indemnity

Subject to the provisions of the Act, but without prejudice to any indemnity to which the person concerned may otherwise be entitled, every Director or other officer of the Charity (other than any person (whether an officer or not) engaged by the Charity as auditor) shall be indemnified out of the assets of the Charity against any liability incurred by him for negligence, default, breach of duty or breach of trust in relation to the affairs of the Charity, provided that this Article shall be deemed not to provide for, or entitle any such person to, indemnification to the extent that it would cause this Article, or any element of it, to be treated as void under the Act

RULES AND BYELAWS

39 Rules or byelaws

- 39 1 The Directors may from time to time make such rules or byelaws as it may deem necessary or convenient for the proper conduct and management of the Charity or for the purpose of prescribing classes and conditions of membership of either the Charity or any group established to support the Charity. In particular but without prejudice to the generality of the above, they may by such rules or byelaws regulate
 - 39 1.1 the rights and privileges of Members and the conditions of membership,
 - 39 1.2 the conduct of Members in relation to one another and to the Charity's employees and volunteers,
 - 39 1.3 the setting aside of the whole or any part or parts of the Charity's premises at any particular time or times or for any particular purpose or purposes, and
 - 39 1 4 the procedure at general meetings and meetings of the Directors and committees in so far as such procedure is not regulated by these Articles
- 39.2 The Charity in general meeting shall have power by Special Resolution to alter or repeal the rules or byelaws and to make additions to them
- 39.3 The Directors shall adopt such means as they deem sufficient to bring to the notice of Members of the Charity all such rules or byelaws which, so long as they shall be in force, shall be binding on all Members of the Charity provided nevertheless that no rule or byelaw shall be inconsistent with, or shall affect or repeal anything contained in the Articles
