
SPECIAL RESOLUTION

- 1 That the articles of association of the Company be amended to include a new article 19 4 as follows.

"Article 19 4

Notwithstanding anything to the contrary contained in these articles, the holder for the time being of a majority of the issued voting shares in the capital of the Company may, by written notice to the Company, at any time and from time to time (a) remove and/or (b) appoint (whether as an additional director to the board or in place of any serving director or company secretary so removed) any person as a director or company secretary of the Company. Any written notice of the removal or appointment of a director or company secretary given in accordance with this Article 19 4 will have effect immediately upon its delivery to the Company at its registered office (which may be effected by email addressed to the Company Secretary or any serving director of the Company) "
