

1 Statutory information

CEPORT LIMITED is a private company, limited by shares, registered in England and Wales, registration number 07436572. The registered office is 100 HIGH STREET, BARKINGSIDE, ESSEX, IG6 2DR.

2 Compliance with accounting standards

3 Accounting policies

Basis of preparation

The accounts have been prepared under the historical cost convention as modified by the revaluation of certain fixed assets.

Turnover

Turnover represents the value, net of VAT and discounts, of goods provided to customers and work carried out in respect of services provided to customers.

Stocks

Stocks and work-in-progress are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items. Cost includes all direct expenditure and an appropriate proportion of fixed and variable overheads.
