allegedly dishonestly assisted a director of the Claimant in breaching his duties to it insofar as it is against the Company or of any appeal therefrom

(B) in the absence of any award of the Court arising out of the litigation referred to in undertaking (A) being satisfied within 28 days, immediately present a Petition to the Court seeking the compulsory winding up of the Company

(C) inform the Registrar of Companies of the title and Court reference number of the proposed Petition immediately after issue

(D) inform the Registrar of Companies immediately on the outcome of the hearing of the said Petition

(E) within 21 days of any Order compulsorily winding up the Company serve a copy of that Order on the Registrar of Companies

(F) inform the Registrar of Companies immediately on the conclusion of the claim against the Company if by any other means

AND UPON the solicitors for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

① Permission to amend the Claim as filed

② Rescission of the amended Claim form is dispensed with



③ the name of the above named Grosvenor Park Intelligent Investments Limited be restored to the Register of Companies



④ if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 07447971 Limited



⑤ an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the



Company is thereupon to be deemed to have continued in existence as if its name had not been struck off



6) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"



7) the hearing fixed for the 25 November 2022 at 2:00 pm be vacated
