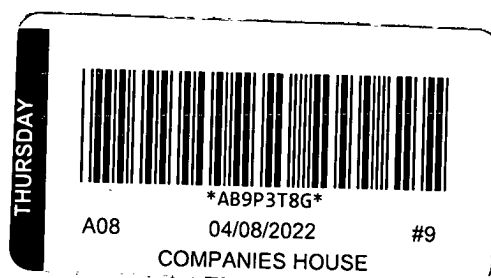


### Post balance sheet events

## **Statement of Directors' Responsibilities**

- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements; and,
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Company will continue in business.

The Directors are responsible for keeping adequate accounting records that are sufficient to show and explain the Company's transactions and disclose with reasonable accuracy at any time the financial position of the Company and enable them to ensure that the financial statements comply with the Companies Act 2006. They have general responsibility for taking such steps as are reasonably open to them to safeguard the assets of the Company and to prevent and detect fraud and other irregularities.



## Notes to the Financial Statements

### 1 Accounting policies

BBC Earth Productions (Africa) Limited is a company incorporated in the United Kingdom. The nature of the Company's operations and its principal activities are set out in the Directors' Report on page 2. The Company's financial statements are presented in Sterling and all values are rounded to the nearest pound except where otherwise indicated.

These financials were prepared in accordance with applicable accounting standards and with the Companies Act 2006. A summary of the Company's principal accounting policies is set out below. These accounting policies have been applied consistently throughout the current year and preceding period to items considered material to the financial statements.

#### 1a Basis of preparation

These financials were prepared in accordance with Financial Reporting Standard 101 Reduced Disclosure Framework (FRS 101). The financial statements are prepared under the historical cost convention.

As permitted by FRS 101, the Company has taken advantage of the disclosure exemptions available in relation to business combinations, share-based payments, non-current assets held for sale, financial instruments, capital management, presentation of comparative information in respect of certain assets, presentation of a cash-flow statement, standards not yet effective, impairment of assets and related party transactions. Where required, equivalent disclosures for the exemption adopted are given in the Group accounts of BBC Commercial Holdings Limited.

#### 1b Going concern

After making enquiries, the Directors have a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future, and accordingly the going concern basis continues to be adopted in the preparation of the accounts.

#### 1c Debtors

Short term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

As each member of the tripartite agreement shares control and influence, the Directors do not consider there to be an ultimate controlling party.

The ordinary share is held in the name of BBC Studios Distribution Limited.
