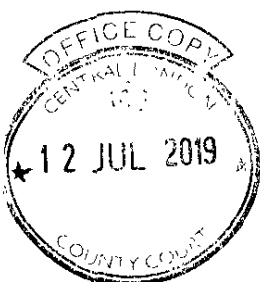
AND UPON the solicitors for the Claimants and for the Registrar of Companies (the Defendant) both consenting to this Order

(2) the name of the above named Lausanne Midco Limited be restored to the Register of Companies

(3) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii)

said Application in the agreed sum of £300-00
- (6) the hearing fixed for the 1st August 2019 at 2:00pm be vacated

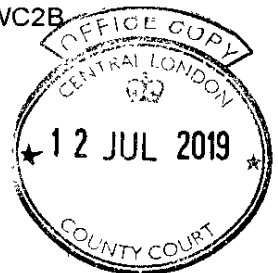
