### 1. Accounting policies

#### Authorisation of financial statements

The Company's financial statements for the year ended 31 December 2016 were approved and authorised for issue by the board of Directors on 28 April 2017 and the statement of financial position was signed on behalf of the Board by D J Kieran.

The principal accounting policies which the Directors have adopted are set out below.

#### **Basis of preparation**

The Company financial statements have been prepared in accordance with Financial Reporting Standard 101 Reduced Disclosure Framework ("FRS 101") as issued by the Financial Reporting Council as applied in accordance with the provisions of the Companies Act 2006. The accounts have been prepared under the historical cost convention and in accordance with applicable accounting standards.

As permitted by FRS 101, the Company has taken advantage of the disclosure exemptions available under that standard in relation to the presentation of a cash flow statement, standards not effective and related party transactions. Where required, equivalent disclosures are given in the Group accounts of URENCO Limited. The Group accounts of URENCO Limited are available to the public and can be obtained as set out in note 3.
