WINDING UP ORDER

UPON THE PETITION of The Secretary of State for Business, Innovation and Skills
presented to this Court on 3 December 2012

AND UPON HEARING Counsel for the Petitioner

AND UPON READING the evidence and a letter dated 11 February 2012 from the
Solicitors acting for the Administrator of Global Management Services Europe Ltd,
Mr Gordon Craig ('the Administrator') and a report from the Official Receiver dated
11 February 2013

AND UPON IT BEING RECORDED that the Administrator has confirmed that he will
immediately deliver up to the Official Receiver those records of Global Management
Services Europe Ltd which are currently held by the Administrator

AND UPON the Court being satisfied that the EC Regulation does not apply

IT IS ORDERED that Global Management Services Europe Ltd (in administration) be
wound up by this Court under the provisions of the Insolvency Act 1986.

AND IT IS ORDERED that

(1) pursuant to paragraph 82 of Schedule B1 of the Insolvency Act 1986, notwithstanding the winding up of Global Management Services Europe Ltd, the appointment of the Administrator shall continue until 11 59pm on 26 February 2012 so that the Administrator may carry out the following functions:

- (a) confirm closure of the Administration to all creditors;
- (b) advise Companies House that the Administration has come to an end,
- (c) prepare the final report in respect of the Administration,
- (d) finalise the position relating to the Administrator's account, in particular the payment of £2,400 due from Byrom & Keeley Financial Services

(2) whilst still in office the Administrator's powers shall be limited to those that are reasonably necessary to perform the aforesaid functions

AND IT IS FURTHER ORDERED that the costs of the Petitioner of the Petition be paid out of the assets of the Company.

AND IT IS FURTHER ORDERED that the Secretary of State hereby, under Section 399(6)(a) of the Insolvency Act 1986 appoints the Official Receiver at PIU – Manchester to be the Official Receiver in relation to the above insolvency proceedings.

AND IT IS FURTHER ORDERED that under rule 4.47 of the Insolvency Rules 1986 that the Official Receiver is relieved from his duty to issue a report to creditors and contributories in this matter.
