VOTING RIGHTS - ON A SHOW OF HANDS EACH HOLDER SHALL HAVE ONE VOTE AND ON A POLL EACH HOLDER SHALL HAVE ONE VOTE PER SHARE HELD THE VOTING RIGHTS ARE MORE PARTICULARLY DESCRIBED IN THE ARTICLES OF ASSOCIATION AND INCLUDE THE FOLLOWING PROVISION: "VOTING: LIMITS (1) FOR SO LONG AS THERE ARE MORE THAN FIVE MEMBERS OF THE COMPANY (DISREGARDING ANY MEMBERS WHO ARE GROUP UNDERTAKINGS OF A MEMBER ALREADY COUNTED TOWARDS THIS NUMBER), THE NUMBER OF VOTES ATTACHING TO THE SHARES HELD BY ANY MEMBER AND THEIR GROUP UNDERTAKINGS SHALL, UNLESS THE RELEVANT MEMBER NOTIFIES THE COMPANY IN WRITING OTHERWISE, BE RESTRICTED SO THAT THE AGGREGATE VOTING RIGHTS CONFERRED ON SUCH MEMBER AND THEIR GROUP UNDERTAKINGS SHALL NOT EXCEED 99 PER CENT. OF THE VOTING RIGHTS ATTACHING TO ALL SHARES IN THE CAPITAL OF THE COMPANY AFTER THE APPLICATION OF THIS RESTRICTION. (2) WHERE THE APPLICATION OF PARAGRAPH (1), REDUCES THE VOTING RIGHTS OF A MEMBER AND ONE OR MORE OF ITS GROUP UNDERTAKINGS THAT ARE ALSO MEMBERS, THE REDUCTION SHALL BE PRO-RATA TO THE NUMBER OF SHARES HELD BY THEM. (3) FOR SO LONG AS STANDARD CHARTERED IS A MEMBER OF THE COMPANY, THE NUMBER OF VOTES ATTACHING TO THE SHARES HELD BY STANDARD CHARTERED AND ITS GROUP UNDERTAKINGS SHALL, UNLESS IT NOTIFIES THE COMPANY IN WRITING OTHERWISE, BE RESTRICTED SO THAT THE AGGREGATE VOTING RIGHTS CONFERRED ON SUCH MEMBER AND ITS GROUP UNDERTAKINGS SHALL NOT EXCEED 99 PER CENT.
