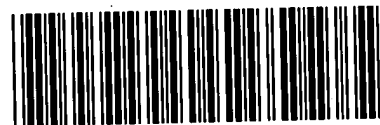



1 General information

The company is a private company limited by share capital incorporated in England and Wales.

2 Summary of significant accounting policies

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

Statement of compliance

The individual financial statements of Starr Care Limited have been prepared in accordance with Financial Reporting Standard 102 Section 1A, the Financial Reporting Standard applicable in the UK and the Republic of Ireland, and the Companies Act 2006.

Basis of preparation

The financial statements have been prepared under the historical cost convention.

The presentational currency of the financial statements is Pound Sterling, being the functional currency of the primary economic environment in which the company operates. Monetary amounts in these financial statements are rounded to the nearest Pound.

Name of parent of group

These financial statements are consolidated in the financial statements of Berkeley Home Health Holdco Limited. The financial statements of Berkeley Home Health Holdco Limited may be obtained from Companies House.

Trading status

The company was dormant and has not traded during the period and consequently has made neither a profit or loss in the period.

The company is a wholly owned subsidiary of Care Your Way Investments Limited, which is in turn a wholly owned subsidiary of Berkeley Home Health Limited. All of the companies are registered in England and Wales. The ultimate parent company is Berkeley Home Health Holdco Limited, a company registered in England and Wales. This company is controlled by August Equity Partners III GP Limited, a company registered in Scotland which is considered to have no single controlling party.
