BEFORE District Judge Goldberg sitting at The Business and Property Courts in Leeds, The Courthouse, 1 Oxford Row, Leeds, LS1 3BG

UPON the application for a block transfer order dated 25 May 2018

AND UPON READING the evidence filed

IT IS ORDERED that

1. Each of the County Court cases listed in Part 1 and 4 of the Schedule (attached to this Order) be transferred to the High Court of Justice, Chancery Division, Business and Property Courts in Leeds for the purpose only of making this Order.
2. Immediately upon this Order taking effect, the County Court cases listed in Parts 1 and 4 of the Schedule (attached to this Order) be transferred back to the County Court.
3. Thomas Bowes (the **Outgoing Officeholder**) be removed from office in respect of each of the cases listed in the Schedule (attached to this Order) (the **Block Transfer Cases**) from the date of this Order pursuant to Rule 12.37(2) of the Insolvency Rules 2016 (the **Rules**) without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the insolvency cases listed in Part 1 of the Schedule (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
4. Paul Robert Boyle, David Michael Clements and Anthony Murphy (the **Replacement Officeholders**) be appointed as replacement officeholders where applicable in respect of each of the Block Transfer Cases listed in Part 2, 3 and 4 of the Schedule from the date of this Order pursuant to Rule 12.37(3) of the Rules without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the insolvency cases listed in the Schedule (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
5. The creditors in each of the Block Transfer Cases listed in the Schedule be notified of this Order by way advertisement published in the London Gazette within 14 days of receipt of the sealed Order from the Court and at the time of the next statutory reporting required for each of the Block Transfer Cases.
6. Any creditor, or, in the case of any Members' Voluntary Liquidation, any member, in respect of any of the companies or persons listed in the Schedule who has an objection to this Order shall have 14 days from the date of the advertisement referred to at paragraph 5 to apply to Court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the Block Transfer Cases listed in the Schedule until further or other Order by the Court.
7. The Replacement Officeholder shall give notice to the Secretary of State (Insolvency Service), the Registrar of Companies in respect of the Liquidations and Administrations listed in the Schedule of the terms of this Order as soon as reasonably practicable.

8. The Outgoing Officeholder shall file a copy of this Order with each of the Courts listed in the Schedule where applicable.
9. Nothing in this Order shall release the Outgoing Officeholder from any obligation to give and file notices in respect of his removal under this Order in respect of the Block Transfer Cases listed in the Schedule.
10. The Outgoing Officeholder shall receive his release as Liquidator, Administrator or Trustee (as appropriate) 28 days after filing notice of his removal with the Registrar of Companies or the giving of notice to creditors in accordance with this Order in any other case in accordance with paragraph 5, save that such release may be subject to further Order in the event of an application by any creditor or member under paragraph 6 of this Order for the specific case subject to that application.
11. In any of the cases listed in the Schedule, the requirement for a progress report upon the Outgoing Officeholder ceasing to act in accordance with the Rules shall not apply.
12. Where there are joint office holders appointed on the cases listed in the Schedule, they will act jointly and severally in relation to all matters relating to the administration of the insolvency cases listed in the Schedule.
13. The costs of this Application (including VAT) shall be met by Harrisons Business Recovery and Insolvency Limited.
