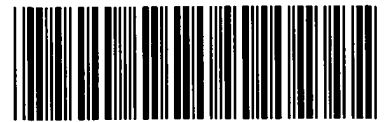

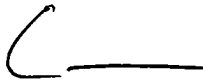

In accordance with Section 444 of the Companies Act 2006, the company has not traded during the year, and accordingly a profit and loss account has not been delivered.

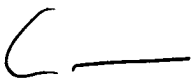
For the year ended 31 December 2016, the company was entitled to exemption from audit under Section 480 of the Companies Act 2006 relating to dormant companies.

Notes to the Financial Statements for the Year Ended 31 December 2016

1. General information

Hamptons Professional Limited ('the company') is a private company limited by share capital which is incorporated and domiciled in the UK.

2. Statement of compliance

The financial statements of Hamptons Professional Limited have been prepared in accordance with Financial Reporting Standard 102, 'The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland' ('FRS 102') Section 1A Small Entities, and the Companies Act 2006.

3. Summary of significant accounting policies

3.1 Basis of preparation

The financial statements have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities under the historical cost convention and in accordance with the Companies Act 2006.

These are the first financial statements of the company prepared in accordance with FRS 102 Section 1A Small Entities. The company's date of transition is 1 January 2015.

The transition to FRS 102 has not resulted in any changes to the figures that would have been reported under previous UK GAAP.

The presentation currency is £ sterling.

4. Parent and ultimate parent undertaking

The immediate parent undertaking is Countrywide Group plc. The ultimate parent undertaking and ultimate controlling party is Countrywide plc, a public limited company, which is listed on the London Stock Exchange and incorporated and domiciled in the United Kingdom. Countrywide plc is the parent undertaking of the only group of undertakings to consolidate these financial statements.
