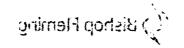

TRUSTEES' REPORT FOR THE YEAR ENDED 31 AUGUST 2021

The Trustees present their annual report together with the financial statements and auditors' report of the Charitable Company for the year ended 31 August 2021. The annual report serves the purpose of both a Trustees' report, and a Directors' report under company law.

The Trust operates a primary multi academy trust consisting of two schools for pupils aged 4 to 11 in Bristol. It has a total capacity of 630 across the Infant school and Junior school and had a total roll of 631 in the school's census on 7th October 2021. The MAT was formed in September 2019 with Elmlea Infant school with a pupil capacity of 270 joining Elmlea junior with a pupil capacity of 360 to form the Elmlea Schools' Multi Academy Trust.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Constitution

The Academy Trust was incorporated on 9th July 2019 and is a company limited by guarantee and an exempt charity. The charitable company's Memorandum and Articles of Association are the primary governing documents of the Trust. The Trustees of Elmlea Schools Trust are also the directors of the Charitable Company for the purposes of company law. The Charitable Company operates as Elmlea Schools' Trust.

Details of the Trustees who served throughout the year, and to the date the accounts are approved are included in the Reference and Administration Details.

Members' Liability

Each Trustee of the Charitable Company undertakes to contribute to the assets of the Company in the event of it being wound up while he/she is a Trustee, or within one year after he/she ceases to be a Trustee, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they cease to be a Trustee.

Trustees' Indemnities

The Academy is a member of the Department for Education's Risk Protection Arrangement (RPA) - a voluntary arrangement for academies as an alternative to commercial insurance. This provides unlimited cover.

Method of recruitment and appointment or election of Trustees

On 1 July 2019 the Members appointed Trustees from Trustees and Governors that served the predecessor schools to be Trustees of the newly formed Academy Trust. These Trustees were appointed for a term of office that would end when their original term at the predecessor school would have ended, thus ensuring a staggered re-election or replacement process. The Trust reviews its structure annually and undertakes a recruitment drive for forthcoming vacancies, recruiting ahead of vacancies occurring to ensure a period of training

The Board of Trustees has 12 members with additional Co-opted trustees and Local Governing Bodies.

Trustees are appointed for a four-year period. Subject to remaining eligible to be a particular type of Trustee, any Trustee can be re-appointed or re-elected.

When appointing new Trustees, the Board give consideration to the skills and experience mix of existing Trustees in order to ensure that the Board has the necessary skills to contribute fully to the Trusts ongoing development.

TRUSTEES' REPORT (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2021

Policies and Procedures adopted for the Induction and Training of Trustees

The Trust has a trustee recruitment, induction and training policy available from the Clerk to the Trustees.

The training and induction provided for new Trustees depends upon their existing experience. New Trustees are introduced to the trust schools through an informal meeting and tour with the Executive Headteacher and there is a chance to meet with staff and pupils. A mentoring system is also in place for new Trustees during the first year of appointment. The Trust arranges bespoke training events to keep Trustees and governors updated on relevant developments impacting their roles and responsibilities and / or to consider school strategy. In addition, the Trust subscribes to the National Governors Association and the Bristol Governor Development Service which provides an information service and training for members, trustees and governors.

Organisational Structure

The management structure consists of three levels: The Trustees, The Local Governing Body (LGB) and the senior management team. The aim of the management structure is to devolve responsibility and encourage involvement in decision making at all levels.

The Board of Trustees normally meets once a term, 6 times a year. The Board establishes an overall framework for the governance of the Academy and determines membership, terms of reference and procedures of Committees and other groups. It receives reports including policies from its Committee for ratification. It monitors the activities of the Committees through the minutes of their meetings. The Board may from time to time establish Working Groups to perform specific tasks over a limited timescale.

There are 5 committees as follows:

- Operations Committee this meets every term and is responsible for monitoring, evaluating and reviewing policy and performance in relation to financial management, budget setting, risk management, value for money compliance with reporting in line with regulatory requirements. It also acts as the safety committee for the rest of the school. It is responsible for the safeguarding and health and safety for the rest of the school
- Audit & Risk is a committee of the main Board of Trustees. Its purpose is to assist the Board in the fulfilment of its corporate governance duties in relation to risk management, internal control, General Data Protection Regulations and financial reporting.
- Joint Local Governing Body this meets every term to monitor, evaluate and review Academy policy, practice and performance in relation to curriculum planning, communications, target setting and assessment, examinations and all pastoral issues. Responsible for the link between the Trust and parents and the community.
- Staffing committee- meets termly to ensure that the responsibilities of the Board of Trustees in relation to all staff matters are fulfilled.
- Pay & Performance Committee responsible for Leadership, Staff pay and appraisals.

The following decisions are reserved to the Board of Trustees: to consider any proposals for changes to the status or constitution of the Academy and its committee structure, to appoint or remove the Chair/Co-Chair and / or Vice Chair, to appoint the Chief Executive Officer (CEO) / Executive Headteacher and Clerk to the Trustees, to approve the Annual Development Plans and budget.

The Trustees are responsible for strategic decision making about the direction of the Academy, capital expenditure and staff appointments. Trustees adopt an annual plan and budget, approve the statutory accounts and monitor the Academy's performance through, pupil data, budgets and other data.

The Academy has a leadership structure which consists of the Trustees, The Senior Executive and Leadership Team and Team leaders. The aim of the leadership structure is to devolve responsibility, and encourage involvement in decision making at all levels.

TRUSTEES' REPORT (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2021

In the year the Board of Trustees have delegated responsibility for day to day management of the schools' within the Academy Trust to the Executive Headteacher and Executive Leadership (ELT) and Senior Leadership Team (SLT). The SLT comprises the Executive Headteacher, Deputy Headteachers, Assistant Headteachers, Special Educational Needs and Disabilities Coordinator (SENDCO), the Early Years Lead, the Director of Finance and Operations and the Business Manager. The SLT implement the policies laid down by the Trustees and report back to them on performance.

The Chief Executive Officer is the Accounting Officer.

Arrangements for setting pay and remuneration of key management personnel.

The Board of Trustees and the senior leadership team comprise the key management personnel of the Academy Trust in charge of directing and controlling, running and operating the Trust on a day to day basis. All Trustees give their time freely and no Trustee received remuneration in the year.

Details of Trustees' expenses and related party transactions are disclosed in the notes to the accounts.

The pay of key management personnel is reviewed annually in accordance with the Academy's Pay and A Policy.

Trade union facility time

There were no relevant union officials for the year ended 31 August 2021.

Related Parties and other Connected Charities and Organisations.

There are no related parties which either control or significantly influence the decisions and operations of Elmlea Schools' Trust.

Significant connected parties are:

- The Elmlea Junior School Parent Teacher Association (PTA)
- The Elmlea Infant School Association (EISA)

The Trust has strong collaborative links with local school networks including the NW24 and a local Business Manager Partnership.

OBJECTIVES AND ACTIVITIES

Objects and Aims

The principal object and activity of the Trust is to advance for the public benefit education in the United Kingdom, in particular by establishing, maintaining, carrying on, managing and developing the schools, offering a broad range of curriculum for pupils of different abilities.

The vision for the Trust is focused upon personal development and well-being of the school community as the solid foundation on which learning becomes more effective. The Trust is currently undergoing a consultation process on an appropriate motto to adopt.

TRUSTEES' REPORT (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2021

Objectives, Strategies and Activities

The aims of the Academy during this year ended 31 August 2021 are summarised below:

- Coordinate to raise the standard of educational attainment and achievement of all pupils.
- To ensure that every child makes at least "Expected" progress and maximise the number of pupils achieving "Age Related Expectations" in Reading, Writing and Maths
- As a Trust with high attaining children on entry from KS1, focus on maximising the number of pupils achieving higher standardised scores in Reading and Maths
- Support more pupils to achieve "Greater Depth" (i.e. above expected standard) in Writing
- Continue to provide, review and develop a broad and balanced curriculum which anticipates and matches the needs for future society
- Provide a wide range of extra-curricular activities which complements the core curriculum
- Develop pupils as effective independent and self-motivated learners
- Develop the Academy site so that it enables pupils to achieve their full potential
- Ensure that every child enjoys the same high quality of education in terms of resourcing, tuition and care
- Maintain close links with the local community
- Continue to monitor, review and evaluate effectiveness of organisational structure and systems
- Provide value for money for the funds expected
- Comply with all appropriate statutory and curriculum requirements
- Develop the Academy's capacity to manage change, and
- Conduct the Academy's business in accordance with the highest standards of integrity, probity and openness.

OBJECTIVES, STRATEGIES AND ACTIVITIES

Strategic priorities are outlined in our School Development Plan for the academic year which is available from the school office.

At Elmlea Schools' Trust we have a key priority for each area of development. Although lockdown due to COVID proved to be in some aspects an accelerant towards achieving our objectives, it did however create barriers to success in other areas.

Leadership and Management

Develop and build leadership strength and capacity across schools at all levels.

As a newly formed Trust in our second year we prioritised leadership at all levels from senior leaders to subject leaders.

Senior Leaders – we started meeting as a joint senior leadership team to accelerate the consistent joined approach of our schools going forward. This created an opportunity for all our senior leadership (SLT) members to develop a Trust- wide strategic view, as well as develop a working knowledge of each staff team from EYFS, KS1 through to KS2. This has led to leaders with a clear view of the whole Trust, the areas for development in both schools and the strengths and areas for development specific to each phase.

Each SLT member completed an individual psychometric profile to better understand their strengths and areas for development and received an individual coaching session to reflect on the outcomes from this profile.

Consequently, we have senior leaders who are developing with a greater understanding of their own strengths and area for development in their leadership capacity.

TRUSTEES' REPORT (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2021

Subject leaders

All teachers unless they are newly qualified are Subject leaders – who were led and developed by our highly experienced Elmlea curriculum team. Across the year there were opportunities to review their curriculum in light of our curriculum values as well as monitor their own subject for further development. Each subject leader had an opportunity if requested to lead whole staff continuing professional development (CPD) via the staff meetings and CPD opportunities for each subject were available where relevant. Consequently, we are developing subject leaders with confidence and knowledge to lead their subject to ensure an outstanding curriculum provision.

Quality of Education

Following the disruption due to COVID the objective is to ensure all children are at least back on track and potentially exceeding their attainment expectations by the end of Term 6.

As well as offering an outstanding provision of education, this year we were able to complement this with additional support via the catch-up premium. We used the premium to employ additional support staff and teaching hours to augment our provision. Unfortunately, the second lockdown slowed progress and our targets for the children had to be adjusted. Our testing in Term 6 showed areas of strength across year groups as well as key areas to build on with regards to catch up for the new academic year.

Behaviour and Attitude

Principles of "Becoming Better Learners" established for EYFS and KS1 and further embedded for KS2 to enable children to become independent, resilient and resourceful learners.

The principles with regards to building better learners was effectively introduced in the Infant School and we were able to use online assemblies during lockdown to reinforce this approach which also served to explain the understanding to parents as well.

By the end of the academic year all children understood core aspects of "purple learning" as it became known and for our older children it really supported independent learning.

Personal development

Ensure all children and staff have a range of strategies, they can use to support their mental health and wellbeing

Staff mental health and wellbeing

A wellbeing committee was established to consider staff wellbeing in greater detail with colleague representation from across all teams. Their key role has played a large part in driving the agenda for areas for staff wellbeing and a staff survey drawn up by the committee, completed in the summer term continues to drive the focus. All staff received weekly check ins with their line manager during lockdown to support their own wellbeing and a range of wellbeing webinars to develop their own wellbeing strategics was signposted.

Consequently, we have a staff team who have had opportunities to develop strategies to support each other and themselves with mental health and wellbeing. The appointment of a mental health lead for staff will be a priority in the new academic year.

TRUSTEES' REPORT (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2021

Children's mental health and wellbeing

From the start of the year following on from last year's focus on wellbeing we started with a two-week induction with a focus on wellbeing this then continued with regular wellbeing sessions across each week. The children were taught specific techniques to support their wellbeing and these were then reviewed at the start of every new term to ensure they were remembered. In a review with governors the children spoke movingly and powerfully about how their teachers support them with their own mental health through strategies they have been taught but also about how they support each other.

Public Benefit

The Trustees confirm that they have complied with the duty in Section 17(5) of the Charities Act 2011 to have due regard to the Charity Commissioner's general guidance on public benefit in exercising their powers or duties. They have referred to this guidance when reviewing the Academy's aims and objectives and in planning its future activities.

The Academy Trust aims to advance for the public benefit, education in the surrounding area and so is an active member of the local school's networks, working collaboratively to share best practice across a broad range of teaching and learning as well as school business themes.

The Academy Trust provides facilities for recreational and other leisure occupation for the community at large in the interests of social welfare and with the interest of improving the life of the said community.

STRATEGIC REPORT

ACHIEVEMENTS AND PERFORMANCE

Covid-19

As elsewhere, COVID-19 had a significant impact on our schools and communities in the past year. The school remained open to key worker and vulnerable children during the lockdown period. We underwent a thorough risk assessment process in advance of full opening and as a Trust we have worked hard to support staff.

Elmlea Schools' Trust comprising both Elmlea Infant School and Elmlea Junior School, continues to provide an outstanding education. Both schools remained open throughout the last academic year and throughout lockdown continued to provide both online learning provisions and in school childcare for vulnerable children and children of key workers.

Using Catch up funding we were able to target children whose progress had been adversely affected by both lockdowns and reported strong data improvement for the children identified as well as whole school data being strong.

The school continued to ensure pupil wellbeing was at the forefront of our provision and we ensured the focus on our Elmlea curriculum continued to be both board and balanced throughout the year.

Under the aims of the Trust, both schools have continued to develop our partnership and by working alongside each other have achieved great strides in terms of our organisational systems being consistent across the Trust.

Our aim for the coming year is greater consistency in terms of our educational provision across the Trust. Without Covid restrictions in place it will be much easier to facilitate as all staff and children can move across the site to grow together.

TRUSTEES' REPORT (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2021

Key Performance Indicators

The main financial performance indicator is the level of free reserves held at the Balance Sheet date of £324,836.

As funding is based on pupil numbers this is also a key performance indicator and is central to the school's capacity to deliver its development plans. The schools are at full capacity of approximately 270 for the Infant school and 360 for the Junior school, making a total of 630 across the two schools throughout the academic year. The schools are oversubscribed and have a waiting list for a number of year groups.

Going Concern

After making appropriate enquiries, the Board of Trustees has a reasonable expectation that the Trust has adequate resources to continue in operational existence for the foreseeable future. For this reason, it continues to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Statement of Accounting Policies.

FINANCIAL REVIEW

Most of the Academy's income is obtained from the DfE via the ESFA in the form of recurrent grants, the use of which is restricted to particular purposes. The grants received from the DfE during the year ended 31 August 2021 and the associated expenditure are shown as Restricted Funds in the Statement of Financial Activities.

The Academy also receives grants for fixed assets from the DfE which are shown in the Statement of Financial Activities as restricted income in the Fixed Asset Fund. The Restricted Fixed Asset Fund balance is reduced by annual depreciation charges over the useful life of the assets concerned, as defined in the Academy's accounting policies.

During the year ended 31 August 2021, the Academy received total income of £2,880,757 and incurred total expenditure of £2,945,193. The excess of expenditure over income for the year was £64,436.

At 31 August 2021 the net book value of fixed assets was £4,761,680 and movements in tangible fixed assets are shown in note 14 to the financial statements. The assets were used exclusively for providing education and the associated support services to the pupils of the Academy.

The Academy has taken on the deficit in the Local Government Pension Scheme in respect of its non-teaching staff transferred on conversion. The deficit is incorporated within the Statement of Financial Activity with details in Note 21 to the financial statements. This has been underwritten by the Government from 18th July 2013.

TRUSTEES' REPORT (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2021

The Financial Management Policy lays out the framework for financial management, including financial responsibilities and delegated authority levels is reviewed at least annually. This incorporates the Academy's guiding principles in relation to Investments, Reserves and Depreciation.

Reserves Policy

The Trustees review the reserve levels of the Academy annually. This review encompasses the nature of income and expenditure streams, the need to match income with commitments and the nature of reserves. The Trustees take into consideration the future plans of the Academy, the uncertainty over future income streams and other key risks identified during the risk review.

The Trustees believe that they should maintain reserves to cover reasonably foreseeable eventualities and or capital expenditure. These reserves should be approximately one month of normal operating expenditure (approximately £250,000) unless there are exceptional circumstances e.g. saving for a large capital project or retaining funds for anticipated drop in income. At the year end the total reserves were £3,176,359 of which £2,851,523 is invested in fixed assets or held in restricted funds (excluding GAG). Free reserves at year end were £324,836. The Academy is committed to a capital and premises plan to reduce the level of reserves in order to continue to improve the education environment in a managed programme of works.

The defined benefit pension scheme reserve has a negative balance. The effect of the deficit position of the pension scheme is that the Academy Trust is paying higher employers' pension contributions over a period of years. The higher employers' pension contributions will be met from the Academy Trust's budgeted annual income. Whilst the deficit will not be immediately eliminated, there should be no actual cash flow deficit on the fund, nor any direct impact on the free reserves of the Academy Trust.

Investment Policy

Any cash not required for operating expenses is placed on deposit at the most favourable rate available. Day to day management of the surplus funds is delegated to the Executive Headteacher and the Director of Finance and Operations within strict guidelines approved by the Board of Trustees.

PRINCIPAL RISKS AND UNCERTAINTIES

The Board of Trustees has reviewed the major risks to which the Academy Trust is exposed together with the operating, financial and compliance controls that have been implemented to mitigate these risks. This is managed through close monitoring and updating of the Academy's Risk Register. The Risk Register is reinforced by a formal annual review led by the Chair of the Audit Committee.

The principal risks and uncertainties facing the Academy are as follows:

Financial – the Academy is reliant on continued government funding through the EFA. In the last year 98% of the Academy's incoming resources were ultimately government funded. Impending changes to the governments funding strategy for schools nationally, brings a significant degree of uncertainty around future funding levels.

The Trustees examine financial health regularly, by means of update reports at all Board and Operations committee meetings. The Trustees also review the financial key performance indicators (KPI's), the level of reserves and cash flow forecasts to preserve the quality of provision and long-term sustainability, through turbulent times.

The Board of Trustees recognises that the defined benefit pension scheme (Local Government Pension Scheme), which is set out in Note 21 to the financial statements, represents a significant and increasing potential liability. However, the Trustees consider that the Trust is able to meet its known contribution commitments for the foreseeable future and so the risk from this liability is minimised.

TRUSTEES' REPORT (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2021

Reputational – the ongoing success of the Trust is dependent on continuing to attract applicants in sufficient numbers by maintaining the highest educational standards. To guard against any decline in performance, the Trustees ensure that pupils' academic progress and attainment are closely monitored and reviewed, and that appropriate high- quality provision is in place.

Safeguarding and child protection – the Trustees continue to ensure that the highest standards are maintained in the aspects of Safeguarding. Clear policies and procedures are in place and appropriate regular training is provided, so there is a high level of awareness throughout the school community.

Staffing – the success of the Trust is reliant upon the quality of its staff and so the Trustees monitor and review policies and procedures to ensure continued development and training of staff as well as ensuring there is clear succession planning.

Further risks that are managed through the risk register include:

- Failures in governance and/or management
- Fraud and mismanagement of Funds
- Staffing in particular the recruitment and retention of high- quality staff

The Trustees have assessed the major risks to which the Academy is exposed, in particular those relating to its finances, teaching, facilities and other operational areas. The Trustees have implemented a number of systems to assess and minimise those risks, including internal controls described elsewhere. Where significant financial risk still remains, they have ensured they have adequate insurance cover.

FUNDRAISING

The Trust undertakes limited amounts of fund raising. The majority of the fund-raising activities are undertaken by two parent teacher associations who raise funds by holding a number of functions during the school year, where they are able to raise about £20k per annum. The schools work closely with these organisations to ensure that the activities are consistent with the schools aims and objectives and comply with all appropriate guidelines. These funds are spent on areas of the school which are identified through consultation with staff and the PTA.

Parents also donate annually to the school for additional activities that the children can undertake, these funds are also used to buy additional resources for use within the school. Gift aid is claimed for these donations.

PLANS FOR FUTURE PERIODS

Elmlea Schools' Trust continues to strive to provide outstanding education and improve the levels of performance of its pupils at all levels. Our aim to provide an outstanding education is underpinned by continuing to attract and support high quality teachers and support staff in order to deliver our objectives.

We continue to work with partner schools to improve the educational opportunities for pupils in the wider community.

We have invested in improving the buildings, mainly investing in improvements to the Infant school building which had seen a lack of investment as a maintained school.

For the financial year ending 31st August 2021, the Trust had a one- year development plan to improve four core areas of governance, and we are now developing a three- year development plan which will detail our plans for the future.

AUDITOR

In so far as the Trustees are aware:

- there is no relevant audit information of which the Charitable Company's auditor is unaware; and

REVIEW OF VALUE FOR MONEY

As Accounting Officer, the Chief Executive Officer has responsibility for ensuring that the Academy Trust delivers good value in the use of public resources. The Accounting Officer understands that value for money refers to the educational and wider societal outcomes achieved in return for the taxpayer resources received The Accounting Officer considers how the Trust's use of its resources has provided good value for money during each academic year, and reports to the Board of Trustees where value for money can be improved, including the use of benchmarking data where appropriate. The Accounting Officer for the Academy Trust has delivered improved value for money during the year by moving to one Catering provider for the Trust and reviewing absence insurance.

Developing Capacity and review of staff structure

The staff structures of the Trust are kept under review by the CEO with opportunities for reshaping taken so that the Trust is well placed to deliver improvement plans and gain efficiencies. A leadership training and support programme is in place to continue to offer outstanding leadership and management within the Trust. Staff are employed across the Trust to enable school leadership to have more flexibility in deploying staff resources across the two schools.

Financial Procedures including controls and managing risks

Robust financial governance and budget management including ongoing review and improvements of controls and managing risk. Annually the Trust identifies the areas of focus of internal audits which are followed up by increasing control measures where improvement is recommended.

A full review of the Risk Register was undertaken during July 2021.

Value for money purchasing

The Trust Finance Management standards policy and procedures are reviewed annually to reflect any changes to the Academies Financial Handbook, in the value for money purchasing setting out procedures for accepting best value quotes, noting that this is not necessarily the cheapest quote.

Following the formation of the MAT in September 2019, a number of large value contracts have been reviewed and re-tendered to ensure best value by using DfE recommended frameworks which provide opportunities for efficiency, group procurement and best practice. Contract renewals in the academic year included Catering and Utilities.

THE PURPOSE OF THE SYSTEM OF INTERNAL CONTROL

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives. It can, therefore, only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an ongoing process designed to identify and prioritise the risks the achievement of Academy Trust policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place in Elmica Schools' Trust for the period from 1 September 2020 to 31 August 2021 and up to the date of approval of the annual report and financial statements.

GOVERNANCE STATEMENT (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2021

CAPACITY TO HANDLE RISK

The Board of Trustees has reviewed the key risks to which the Academy Trust is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The Board of Trustees is of the view that there is a formal ongoing process for identifying, evaluating and managing the Trust's significant risks that have been in place for the period from 1 September 2020 to 31 August 2021 and up to the date of approval of the annual report and financial statements. This process is regularly reviewed by the Board of Trustees.

THE RISK AND CONTROL FRAMEWORK

The Trust's system of internal financial control is based on a framework of regular management information and administrative procedures including the segregation of duties and a system of delegation and accountability. In particular it includes:

- Comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the Board of Trustees.
- Regular reviews by the Operations Committee of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programme
- Setting targets to measure financial and other performance
- Clearly defined purchasing (asset purchase or capital investment) guidelines
- Identification and management of risks

The Board of Trustees has considered the need for a specific internal audit function and has decided not to appoint an internal auditor. However, the Trustees have appointed Audit West to carry out a programme of internal checks.

Audit West's role includes giving advice on financial matters and performing a range of checks on the Academy Trust's financial systems. In particular the checks carried out in the current period included:

- Governance
- Business Continuity and Risk Management
- Value for Money
- Contracts and Leases
- Cyber Security

After each visit Audit West provides reports to the Board of Trustees via the Audit Committee detailing the work performed and any areas of weakness.

The reviewer has delivered the schedule of work as planned, with 4 out of 5 visits being completed remotely due to COVID-19. No material control issues were identified.

REVIEW OF EFFECTIVENESS

As Accounting Officer the Chief Executive Officer has responsibility for reviewing the effectiveness of the system of internal control. During the year in question the review has been informed by:

- The work of the internal reviewer
- The work of the external auditor
- The financial management and governance self-assessment process
- The work of the executive managers within the Trust who have responsibility for the development and maintenance of the internal control framework
- The work of Audit West

- how the academy trust ensured it met its obligations to its principal regulator, the Secretary of State for Education; and
- the matters discussed among the audit engagement team and involving relevant internal Academy specialists regarding how and where fraud might occur in the financial statements and any potential indicators of fraud.

As a result of these procedures, we considered the opportunities and incentives that may exist within the organisation for fraud, which included incorrect recognition of revenue, management override of controls using manual journal entries, procurement and payroll. We identified the greatest potential for fraud as incorrect recognition of revenue and management override using manual journal entries.

In common with all audits under ISAs (UK), we are also required to perform specific procedures to respond to the risk of management override. We also obtained an understanding of the legal and regulatory frameworks that the academy trust operates in, focusing on provisions of those laws and regulations that had a direct effect on the determination of material amounts and disclosures in the financial statements. The key laws and regulations we considered in this context included the Academies Accounts Direction, Academies Financial Handbook, UK Companies Act and tax legislation.

In addition, we considered provisions of other laws and regulations that do not have a direct effect on the financial statements but compliance with which may be fundamental to the academy trust's ability to operate or to avoid a material penalty. These included safeguarding regulations, data protection regulations, occupational health and safety regulations, education and inspections legislation, building legislation and employment legislation.

Our responsibilities for this engagement are established in the United Kingdom by our profession's ethical guidance and are to obtain limited assurance and report in accordance with our engagement letter and the requirements of the Academies Accounts Direction 2020 to 2021. We report to you whether anything has come to our attention in carrying out our work which suggests that in all material respects, expenditure disbursed and income received during the year 1 September 2020 to 31 August 2021 have not been applied to purposes intended by Parliament or that the financial transactions do not conform to the authorities which govern them.

APPROACH

We conducted our engagement in accordance with the Framework and Guide for External Auditors and Reporting Accountant of Academy Trusts issued by ESFA. We performed a limited assurance engagement as defined in our engagement letter.

The objective of a limited assurance engagement is to perform such procedures as to obtain information and explanations in order to provide us with sufficient appropriate evidence to express a negative conclusion on regularity.

A limited assurance engagement is more limited in scope than a reasonable assurance engagement and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in a reasonable assurance engagement. Accordingly, we do not express a positive opinion.

Our engagement includes examination, on a test basis, of evidence relevant to the regularity and propriety of the academy trust's income and expenditure.

Our work on regularity included a review of the internal controls policies and procedures that have been implemented and an assessment of their design and effectiveness to understand how the academy complied with the framework of authorities. We also reviewed the reports commissions ed the Trustees to assess the internal controls throughout the year.

We performed detailed testing based on our assessment of the risk of material irregularity, impropriety and non-compliance. This work was integrated with our audit on the financial statements where appropriate and included analytical review and detailed substantive testing of transactions.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 AUGUST 2021

1. ACCOUNTING POLICIES

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgements and key sources of estimation uncertainty, is set out below.

1.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements of the academy trust, which is a public benefit entity under FRS 102, have been prepared under the historic cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)), the Academies Accounts Direction 2020 to 2021 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

1.2 GOING CONCERN

The Trustees assess whether the use of going concern is appropriate i.e. whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the academy trust to continue as a going concern. The Trustees make this assessment in respect of a period of at least one year from the date of authorisation for issue of the financial statements and have concluded that the academy trust has adequate resources to continue in operational existence for the foreseeable future and there are no material uncertainties about the academy trust's ability to continue as a going concern, thus they continue to adopt the going concern basis of accounting in preparing the financial statements.

1.3 FUND ACCOUNTING

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the academy trust at the discretion of the Trustees.

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by the funders where the asset acquired or created is held for a specific purpose.

Restricted general funds comprise all other restricted funds received with restrictions imposed by the funder/donor and include grants from the Department for Education Group.

Transfers are made between restricted funds and restricted fixed asset funds where restricted funds are used to purchase fixed assets.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 AUGUST 2021

1. ACCOUNTING POLICIES (continued)

1.4 INCOME

All incoming resources are recognised when the academy trust has entitlement to the funds, the receipt is probable and the amount can be measured reliably.

Grants

General Annual Grant is recognised in full in the Statement of Financial Activities in the year for which it is receivable and any abatement in respect of the year is deducted from income and recognised as a liability.

Capital grants are recognised in full when there is an unconditional entitlement to the grant. Unspent amounts of capital grants are reflected in the Balance Sheet in the restricted fixed asset fund. Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended.

Donations

Donations are recognised on a receivable basis (where there are no performance-related conditions) where the receipt is probable and the amount can be reliably measured.

Other income

Other income, including the hire of facilities, is recognised in the year it is receivable and to the extent the academy trust has provided the goods or services.

• Transfer on conversion

Where assets and liabilities are received by the academy trust on conversion to an academy, the transferred assets are measured at fair value and recognised in the Balance Sheet at the point when the risks and rewards of ownership pass to the academy trust. An equal amount of income is recognised as a transfer on conversion within 'Income from Donations and Capital Grants' to the net assets received.

1.5 EXPENDITURE

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably.

Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Charitable activities

These are costs incurred on the academy trust's educational operations, including support costs and costs relating to the governance of the academy trust apportioned to charitable activities.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 AUGUST 2021

ACCOUNTING POLICIES (continued)

1.6 TANGIBLE FIXED ASSETS

Assets costing £1,000 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the Balance Sheet at cost and depreciated over their expected useful economic life. Where there are specific conditions attached to the funding requiring the continued use of the asset, the related grants are credited to a restricted fixed asset fund in the Statement of Financial Activities and carried forward in the Balance Sheet. Depreciation on the relevant assets is charged directly to the restricted fixed asset fund in the Statement of Financial Activities. Where tangible fixed assets have been acquired with unrestricted funds, depreciation on such assets is charged to the unrestricted fund.

On conversion the Academy was granted a 125 year lease from the Local Authority for the land and buildings previously occupied by the local authority school. On conversion the long term leasehold property was recognised as a donation from the Local Authority and was valued using the depreciated replacement cost method.

Depreciation is provided on all tangible fixed assets other than freehold land and assets under construction, at rates calculated to write off the cost of each asset, over its expected useful life, on the following bases:

Assets in the course of construction are included at cost. Depreciation on these assets is not charged until they are brought into use.

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of Financial Activities.

1.7 DEBTORS

Trade and other debtors with no stated interest rate and due within one year are recorded at the amount of the cash or other consideration expected to be received. Prepayments are valued at the amount paid.

1.8 CASH AT BANK AND IN HAND

Cash at bank and in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account and cash on deposit that has a notice period of less than 30 days.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 AUGUST 2021

1. ACCOUNTING POLICIES (continued)

1.9 LIABILITIES

Liabilities are recognised when there is an obligation at the Balance Sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the academy trust anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

1.10 FINANCIAL INSTRUMENTS

The academy trust only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the academy trust and their measurement bases are as follows:

Financial assets - trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost as detailed in note 15. Prepayments are not financial instruments. Amounts due to the academy trust's wholly owned subsidiary are held at face value less any impairment. Cash at bank is classified as a basic financial instrument and is measured at face value.

Cash at bank is classified as a basic financial instrument and is measured at face value.

Financial liabilities - trade creditors, accruals and other creditors are financial instruments, and are measured at amortised cost as detailed in notes 16 and 17. Taxation and social security are not included in the financial instruments disclosure definition. Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instrument. Amounts due to the academy trust's wholly owned subsidiary are held at face value less any impairment.

1.11 TAXATION

The academy trust is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes.

Accordingly, the academy trust is potentially exempt from taxation in respect of income or capital gains received within categories covered by Part 11, chapter 3 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

1.12 OPERATING LEASES

Rentals paid under operating leases are charged to the Statement of Financial Activities on a straight line basis over the lease term.

1.13 PENSIONS

Retirement benefits to employees of the academy trust are provided by the Teachers' Pension Scheme ("TPS") and the Local Government Pension Scheme ("LGPS"). These are defined benefit schemes.

The TPS is an unfunded scheme and contributions are calculated so as to spread the cost of pensions over employees' working lives with the academy trust in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary on the basis of quadrennial valuations using a prospective unit credit method. TPS is an unfunded multi-employer scheme with no underlying assets to assign between employers. Consequently, the TPS is treated as a defined contribution scheme for accounting purposes and the contributions recognised in the period to which they relate.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 AUGUST 2021

1. ACCOUNTING POLICIES (continued)

1.13 PENSIONS (CONTINUED)

The LGPS is a funded multi-employer scheme and the assets are held separately from those of the academy trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each Balance Sheet date. The amounts charged to operating surplus are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the Statement of Financial Activities and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses.

Actuarial gains and losses are recognised immediately in other recognised gains and losses.

2. CRITICAL ACCOUNTING ESTIMATES AND AREAS OF JUDGEMENT

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and assumptions:

The academy trust trust makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost or income for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 25, will impact the carrying amount of the pension liability. Furthermore a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2019 has been used by the actuary in valuing the pensions liability at 31 August 2021. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

Critical areas of judgement:

The Academy obtains use of fixed assets as a lessee. The classification of such leases as operating or finance lease requires the Academy to determine, based on an evaluation of the terms and conditions of the arrangements, whether it retains or acquires the significant risks and rewards of ownership of these assets and accordingly whether the lease requires an asset and liability to be recognised in the Balance Sheet.

Following the reclassification in the Academies Accounts Direction 2020/21 of some grants received from the Department for Education and ESFA, the academy trust's funding for Teachers Pay and Pension, Universal Infant Free School Meals and Pupil Premium is no longer reported under the Other DfE Group grants heading, but as separate lines under the Other DfE/ESFA grants heading. The prior year numbers have been reclassified.

The Trust received £50,560 of funding for catch-up premium and costs incurred in respect to this funding totaled £28,366, with the remaining £22,194 to be spent in 2021/22.

The specific purposes for which the funds are to be applied are as follows:

The General Annual Grant (GAG) - This represents funding received from the ESFA during the period in order to fund the continuing activities of the school.

Teachers pay and pension grant - funding from the ESFA to cover addition teacher salary and pension costs

Pupil Premium - This represents funding received from the ESFA for children that qualify for free school meals to enable the Academy to address the current underlying inequalities between those children and their wealthier peers.

UIFSM (Universal Infant Free School Meals) - This represents funding from the ESFA to cover the cost of providing free school meals to all pupils in reception, year 1 and year 2.

Other ESFA grants - this represents grant funding from the ESFA in relation to PE and sports premium and rates relief. PE and sports premium is to fund improvements to the provision of PE and sport, for the benefit of primary-aged pupils to encourage them to develop healthier lifesyles. Rates relief is the reimbursement of the cost of business rates by the ESFA.

Local authority grants - represents high needs funding which represents funding received from the local authority to cater for the children with statements of special educational needs. Also represents pupil premium received from the local authority.

Covid catch-up premium - represents funding from the ESFA to support children and young people to catch up on missed learning caused by Covid-19.

Other DfE/ESFA covid funding - this represents funding to cover additional costs incurred by he Trust to manage the impacts of the Covid-19 pandemic

Donations largely represent income received from the Junior School Parent Teacher Association to spend on specific educational resources and income contributed towards educational trips.

The pension fund represents the Local Government Pension Scheme deficit.

FIXED ASSET FUNDS

Fixed assets transferred on conversion represent the building and equipment donated to the school from Bristol City Council on conversion to an Academy.

Fixed assets purchased from General Annual Grant represents amounts spent on fixed assets from the GAG funding received from the ESFA.

Fixed assets purchased from donations represent amounts donated to be spent on specific fixed asset additions.

OTHER INFORMATION

Under the funding agreement with the Secretary of State, the academy trust was not subject to a limit on the amount of GAG it could carry forward at 31 August 2021.

25. **PENSION COMMITMENTS**

The academy trust's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff; and the Local Government Pension Scheme (LGPS) for non-teaching staff, which is managed by Avon Pension Fund. Both are multi-employer defined benefit schemes.

The latest actuarial valuation of the TPS related to the period ended 31 March 2016 and of the LGPS 31 March 2019.

There were no outstanding or prepaid contributions at either the beginning or the end of the financial year.

TEACHERS' PENSION SCHEME

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for full-time teachers in academies. All teachers have the option to opt-out of the TPS following enrolment.

The TPS is an unfunded scheme to which both the member and employer makes contributions, as a percentage of salary - these contributions are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 AUGUST 2021

25. PENSION COMMITMENTS (CONTINUED)

VALUATION OF THE TEACHERS' PENSION SCHEME

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury every 4 years. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2016. The valuation report was published by the Department for Education on 5 March 2019. The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 23.68% of pensionable pay (including a 0.08% administration levv)
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218,100 million and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £196,100 million, giving a notional past service deficit of £22,000 million
- the SCAPE rate, set by HMT, is used to determine the notional investment return. The current SCAPE rate is 2.4% above the rate of CPI, assumed real rate of return is 2.4% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.2%. The assumed nominal rate of return including earnings growth is 4.45%.

The next valuation result is due to be implemented from 1 April 2023.

The employer's pension costs paid to TPS in the year amounted to £258,378 (2020 - £254,797).

A copy of the valuation report and supporting documentation is on the Teachers' Pensions website (https://www.teacherspensions.co.uk/news/employers/2019/04/teachers-pensions-valuation-report.aspx).

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The academy trust has accounted for its contributions to the scheme as if it were a defined contribution scheme. The academy trust has set out above the information available on the scheme.

LOCAL GOVERNMENT PENSION SCHEME

The LGPS is a funded defined benefit pension scheme, with the assets held in separate trustee-administered funds. The total contribution made for the year ended 31 August 2021 was £142,000 (2020 - £218,000), of which employer's contributions totalled £108,000 (2020 - £185,000) and employees' contributions totalled £ 34,000 (2020 - £33,000). The agreed contribution rates for future years are 20.8 per cent for employers and 5.5 - 12.5 per cent for employees.

As described in note 1.13 the LGPS obligation relates to the employees of the academy trust, who were the employees transferred as part of the conversion from the maintained school and new employees who were eligible to, and did, join the Scheme in the year. The obligation in respect of employees who transferred on conversion represents their cumulative service at both the predecessor school and the academy trust at the balance sheet date.

Parliament has agreed, at the request of the Secretary of State for Education, to a guarantee that, in the event of academy closure, outstanding Local Government Pension Scheme liabilities would be met by the Department for Education. The guarantee came into force on 18 July 2013.
