



**ORDER**

**UPON** the Application of the Applicants dated 15 April 2020 (“the **Application**”)

**AND UPON** reading the Witness Statement of Alec D Pillmoor dated 15 April 2020

**IT IS HEREBY ORDERED THAT**

- 1 Robert Armstrong, the Respondent, (**Outgoing Officeholder**) be removed from office in respect of each of the cases listed in the Schedules hereto (marked

Schedule 1, Schedule 2, and Schedule 3) (**block transfer cases**) from the date of this order.

- 2 Alec D Pillmoor be appointed as replacement officeholder in respect of each of the block transfer cases listed in Schedule 1.
- 3 Adrian David Allen be appointed as replacement officeholder in respect of each of the block transfer cases listed in each of Schedule 2 and Schedule 3.
- 4 In respect of each appointment made under paragraphs 2 and 3 above the functions of the officeholders may be exercised by any or all of the persons appointed.
- 5 The Outgoing Officeholder shall be released from all liability pursuant to the relevant sections of the Insolvency Act 1986 in respect of his acts and omissions and otherwise in respect of his conduct in relation to the block transfer cases upon application to the Secretary of State.
- 6 The creditors in each of the block transfer cases be notified of this order by one composite advertisement placed in the London Gazette within 28 days of receipt of the sealed court order.
- 7 Any creditor or other interested person who has an objection to this order shall have 28 days (or such extended or alternative period as may be agreed in writing by the relevant officeholders) from the date of the advertisement to apply to this court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases until further or other order by the court.
- 8 The costs of and occasioned by this Application (including VAT) shall be met by RSM Restructuring Advisory LLP without recourse directly or indirectly to the estates listed in the Schedules hereto.
- 9 In respect of each of the block transfer cases the next routine report due to creditors shall contain reference to and explanation of the effect of this order and the liberty to apply provision below.
- 10 There be liberty to any of the parties hereto and to any interested party to apply to set aside or vary the terms of this order.
