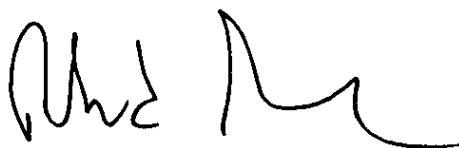

During the period the Company did not trade, received no income and incurred no expenditure. Consequently, the Company made neither a profit nor a loss and has no recognised gains in the period.

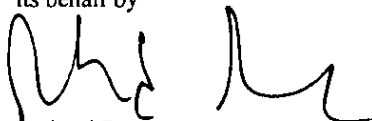
