Articles of Association are based on a model form of articles agreed for an Academy Trust by the Department for Education ("DfE") and Charity Commission. The school company is required by DfE policy to adopt model articles which use the term Academy Trust throughout. The proposed name of the Academy Trust, with inclusion of the word Trust, is therefore consistent with model articles and DfE policy.

Please find below justification for use of the word "Trust":

1. Company limited by guarantee

The company is a company limited by guarantee as evidenced by the Articles. The Articles are drafted specifically for a company limited by guarantee.

2. Non-profit distribution clause

This can be found at Article 9 which states how the company's property should be applied on dissolution.

3. The name should reflect the nature of the Trust

The name reflects that it is a company established to manage academy schools.

4. The promoters should be of high standing in the field

East Bergholt High School is already an established company and the promoters are current Directors of that existing company.
