PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

The Company is mandated by Kirkby Lonsdale Town Council to manage or facilitate a visitor information and gift shop, a weekly Charter Market and two public toilets sites. It also involves itself with the provision of seasonal events in the town, including the Christmas Market and Fair, and supports and assists other organisations to stage town-wide events or mark significant anniversaries, such as the late Queen's Jubilee celebrations. The effects of Covid still linger, but the town has shown remarkable resilience and continues to be an attractive destination for visitors, with businesses reporting a slight, but noticeable, increase in footfall. Personnel changes have affected the Company, and a new shop manager has made an impact. Rather than employ an events manager (previously described as a Town Manager) it was decided to hire on a short-term contract with the task of concentrating on building on the success of the Christmas Market and Fair, which has become a local 'must visit' attraction each December over the past few years.

We benefit from enthusiastic support from a group of volunteers who staff the Company shop. Some of the volunteers have been trained to conduct town walking tours, and these tours are reasonably well supported by visitors.

The weekly Charter Market, held on a Thursday, is healthy and is managed on the Company's behalf by a local Co-operative. This generates a commitment to make the venture a success, and it is pleasing to know there is actually a waiting list of potential traders wishing to come to this weekly event.

We believe our Vault attraction is unique. It features a series of locally and professionally-made short films telling of some of town's more memorable historical events, or the town's local characters. They are screened, at no charge, in what was a bank vault, now converted to house a projector and sound system. We plan to commission a further series of four such films in the coming year.

Our Board of seven members, representing the local community, meets monthly. Its main concern is our finances. The Company relies heavily on grant support, despite having income from rental properties and shop sales. Public toilets are a drain on finances, yet cannot be ignored in a tourist town such as Kirkby Lonsdale.

We nevertheless remain optimistic that we are making a positive contribution to the economic viability of the town and will continue to work with others in the community to achieve our goals.

We maintain regular contact with a variety of local organisations and groups, including the Town Council, our churches, a new Community Hub, the new Westmorland and Furness Council, our Civic Society and Chamber of Trade. The Community Hub, formed during Covid to meet the needs of the lonely and isolated, has expanded to what is now the Community Support Group, bringing together a wider representation of the community to influence positive developments which will benefit our community. We are pleased to be part of that Group.

We use social media, websites, the local printed parish newsletter, Around Kirkby Lonsdale, to publicise our activities. This has alerted us to the advantage of having just one central website for the town, so we plan to work to influence the merging of these disparate websites to form a new, one-for-all website which will benefit all.

Our Board members maintain strong, yet informal, links with our local community through membership of other organisations.
