"Declared Default" means an Event of Default in respect of which any notice has been served by the Agent in accordance with clause 23 20 (Acceleration) of the Facility Agreement,

"Facility Agreement" means the £502,085,000 facility agreement originally dated 30 June 2014 (as amended from time to time including amended and restated on 8 October 2014. 4 November 2014 and 3 February 2015) between (amongst others) FC Skyfall Lower Midco Ltd, the Chargor, the Lenders and the Security Agent,

"Secured Obligations" means all present and future obligations and liabilities (whether actual or contingent and whether owed jointly or severally and whether as principal or surety or in any other capacity whatsoever) of the Chargor to any Secured Party under any Finance Document,

"Secured Party" means each Secured Party (as defined in the Facility Agreement), and

"Security" means any security interest created, evidenced or conferred by or under this Instrument,

"Security Rights" means the Security rights contemplated by this Instrument, and

the "Security Subjects" means the tenant's interest in the lease between HCP UK Investments (Jersey), Ltd and Libra Careco CH3 Propco Limited of ALL and WHOLE the subjects known as Springfield Bank Nursing Home, Cockpen Crescent, Bonnyrigg Midlothian EH19 3PN the heritable title to which is registered in the Land Register of Scotland under Title Number MID82713 and which lease is to be registered in the Land Register of Scotland on or around the date hereof together with (One) the whole buildings and erections thereon (Two) the fittings and fixtures therein and thereon (Three) the parts, privileges and pertinents thereof (Four) the whole rights common, mutual and exclusive efferring thereto and (Five) the Chargor's whole right, title and interest, present and future, therein and thereto

Without double counting any amount recovered under any other indemnity or similar provision of any other Finance Documents, the Chargor must
