**1. ACCOUNTING POLICIES****Accounting convention**

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015).

The company had a net asset deficit at 29 February 2016 of £1,273. The director and shareholders will continue to provide support funding with any such funding as is required to enable the company to meet its debts and liabilities as they fall due.

**Turnover**

Turnover represents net invoiced sales of goods, excluding value added tax.

**Deferred tax**

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.
