ORDINARY RESOLUTION

- 1. THAT in accordance with section 551 of the Act, the Company's directors be generally and unconditionally authorised to issue 2,000,000 £1.00 unsecured convertible loan notes of the Company pursuant to a convertible loan agreement with UKTV Limited ("CLA") and allot, or grant rights to subscribe for, up to 1,500 ordinary shares of £0.01 on the conversion of such loan notes into shares, each provided that this authority shall, unless renewed, varied or revoked by the Company:

 - b. be limited to the allotment of equity securities (as defined in section 560 of the Act) allotted pursuant to an exercise of rights under the CLA.

SPECIAL RESOLUTION

2. THAT the Company's directors be generally empowered to allot equity securities (as defined in section 560 of the Act) pursuant to the authority conferred by resolution 1, as if article 13 of the Company's articles of association did not apply to any such allotment.
