AND UPON the Claimant undertaking that:-


(A) the Company will not carry on business or operate in any way other

(B) he will notify the Registrar of Companies immediately on the conclusion of the actions



AND UPON the Claimant and the solicitor for the Registrar of Companies (the Defendant) both consenting to this Order


IT IS ORDERED THAT:

(1) the name of the above named Your Local (UK) Ltd be restored to the Register of Companies

(2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 07763482 Ltd



(3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off



(4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"

(5) the Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300-00
