#### 1. ACCOUNTING POLICIES

#### Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

## Stock and work in progress

Stock and work in progress is valued at the lower of cost and net realisable value.

#### **Deferred tax**

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

836,720 Ordinary shares of £1 each were allotted and fully paid for cash at par during the year.

At a Board Meeting held on 20 August 2013 it was confirmed that the company had achieved its minimum capital requirement of £1 million in order to stage the musical at Leicester. Accordingly,  $645,000 \pm 1$  ordinary shares were issued to investors together with 27,600 additional £1 ordinary shares issued as compensation to investors for the loss of use of their money during the period until 31 December 2012 and this has been treated in the accounts for the year ended 31 March 2014 as finance costs.

Further £1 ordinary shares were also issued to additional investors, being 60,000 on 23 September 2013, 75,000 on 24 October 2013 and 29,120 on 14 November 2013.
