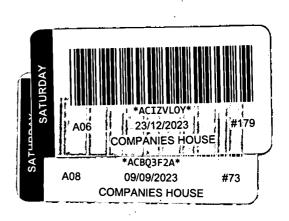

PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

Northaw Transition CIC's major project is Northaw Community Orchard. This is a public space, owned by Welwyn Hatfield Borough Council, leased to Northaw and Cuffley Parish Council and sub-let by them to Northaw Transition CIC to manage. The orchard has **benefited the local community by** giving them the opportunity to improve their health and wellbeing and increase their knowledge of conservation and fruit production. It has created a community spirit around the orchard and brings residents and local groups together. Some of the ways we have involved the community in the orchard project in 2022 are listed below:

Activities

- 1. The orchard was created on two fields which were previously inaccessible to the public, one of which is a Local Wildlife Site. Pedestrian access is available to the community 24/7, paths have been created and picnic tables and benches provided. Interpretation boards give information about the site and the wildlife found there.
- 2. **Volunteers from within the community** assisted with tasks such as mowing, weeding, clearance, hay raking, harvesting and planting willow, watering, mulching, staking trees, pruning and raising and taking down our yurt. Group work parties took place monthly through the year. Volunteering also continued on an individual basis throughout. 542 person hours of volunteering were recorded.
- 3. 1st Northaw Scouts adjoin the site and we are able to use the facilities of the Scout site in exchange for mowing their field regularly with our tractor.
- 4. We have held a variety of events through the year. A Wassail in January, an Orchard Fayre in July (where other community organisations were represented including Cuffley Community Library and the RSPB) and an Apple Day in October were held. All these events were well attended by the local community and were joyful and successful occasions.
- 5. **Other events** included a visit of the SE Herts Beekeepers Association to view our beehives, a family picnic and a bat identification workshop starting from the orchard and led by orchard volunteers.

Supporting small local businesses and crafts

As a public space the orchard is a resource which has been used by small local businesses especially for educational and wellbeing purposes. In 2022, we hosted the following businesses, social enterprises and crafts people in the orchard and in our orchard yurt:

- A local artist continued work on a willow sculpture and arbor in the orchard which also involved cob-making workshops by volunteers
- A Family Forest School met every month and provided educational activities for 3- 11 year-olds
- A local business provided retreats for physical, mental and spiritual wellbeing with overnight stays
- A local meditation and yoga group
- A local photographer uses the orchard and the yurt for shoots
- At our Orchard Fayre, local businesses attended and manned stands
- We also run a small community garden in the village. This year we have arranged with the pre-school which adjoins for the children to use the community garden.

Our stakeholders in this period were: Welwyn Hatfield Borough Council (the landowners), Northaw and Cuffley Parish Council (our landlords), local residents including those whose houses back onto the site, other community groups, local small businesses and social enterprises and volunteers.

We have **consulted our stakeholders** in the following way:

- Feedback and suggestions were obtained from attendees at our events including at our AGM, from local residents and from volunteers. We also provided contact details directly to residents adjacent to the field.
- 2. We have a dedicated website which includes an opportunity to contact us with comments and suggestions.
- 3. We provided an article in each quarterly edition of the parish magazine, 'Update' with news of progress in the orchard and contact details.
- 4. We regularly contacted people interested in the orchard through an active email contacts list of 160+ people. We received feedback and suggestions.
- 5. We also have a Facebook page for the orchard.
- 6. We leafleted the whole village to publicise the Orchard Fayre and Apple Day.
