**1 Statutory information**

RADUCEZAR LTD is a private company, limited by shares, registered in England and Wales, registration number 07811955. The registered office is 53 RING WAY, NORTHAMPTON, NORTHAMPTONSHIRE, NN4 8SH.

**2 Compliance with accounting standards**

The accounts have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities. There were no material departures from that standard.

**3 Accounting policies**

These financial statements for the year ended 16 October 2017 are the first financial statements that comply with FRS 102 Section 1A Small Entities. The date of transition is 17 October 2015.

The transition to FRS 102 Section 1A Small Entities has resulted in a small number of changes in accounting policies to those used previously.

***Basis of preparation***

The accounts have been prepared under the historical cost convention as modified by the revaluation of certain fixed assets.
