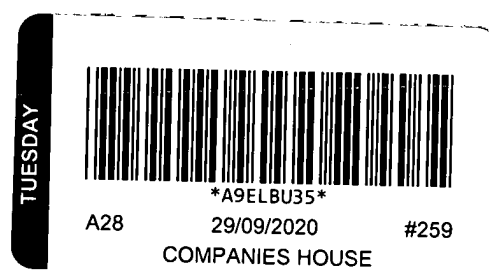


Directors' responsibilities:

1. Basis of accounting

The accounts have been prepared on the historical cost basis of accounting.

2. Dormant Status

The Company was dormant throughout the period ended 31 December 2019. The company has not traded during the period. During this period, the company received no income and incurred no expenditure and therefore made neither profit nor loss.

The board elected to apply FRS102 transitional relief applicable to dormant companies of retaining its accounting policies for the balance sheet – reported assets, liabilities and equity until such a time in the future when it does undertake a new transaction or there is a change in the balances.

The Company did not trade during the period and has made neither a profit nor a loss. No Profit and Loss Account has been prepared. As a result, reserves have not moved.
