

PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

The Company uses canal boats as our main engagement tool. It is entirely staffed by volunteers, the majority of whom by design, have progressed through the project. During the current year we have had 2 major Lottery funded streams, IGNITE (14-19 yrs of age outside of mainstream education) and Float Your Boat (Over 50 yrs at risk of social isolation). The majority of benficaries on both programmes are struggling with health, confidence or educational needs and thereby respond very positively to the environment on and around the boat.

"I was unfortunate enough to suffer a period of mental illness in the Autumn of 2018 but remarkably lucky to be pointed in the direction of the men's group run by Canal Connections. The proximity of the water, the warm camaraderie of my crew mates and the serenity that spending any amount of time on the Nation's waterways bring, did much to aid my recovery." 59 yr old Senior Executive with International Company on long term sick leave.

With the older peoples group we developed a regular cohort of 15 benficaries who attended on a weekly basis over the year. 5 progressed to be skippers, whilst other preferred to be crew, but they delivered trips to over 1000 people at events and delivered respite courses to over 12 partner groups covering a wide geographical and ethnic mix.

Within the IGNITE group we delivered 3 x 10 week courses to cohorts of 6 young people as an alternative education provision. We delivered 2 out of school holiday activities to families and delivered a consultation course for North Yorks Youth Service thereby extending our area of operation. Arising out of this course we developed a new 'Reflections' Course designed to create a progression route for trainees. This was delivered by a pilot Development Team consisting of young and old beneficiaries from both programmes and resulted in the 4 trainees wanting to support a new cohort, whilst developing their own skills. The intention was for the trainees to work towards supporting the delivery of a 1 week consultation cruise for the University of Leeds to explore peoples views towards environmental transition over the next 10 years.

Unfortunately the pandemic crisis suspended all operations from the middle of March. Our immediate concern was to support our partners in the community and provide hope that we would be there for them as we come out of the crisis. This initial support was restricted to a donation to assist the major change in their adaption to community needs.

The Board is made up of stakeholders from the Academic, Community and Corporate partners together with long term volunteers. Whilst there has no been no formal consultation there has been constant feedback from partner organisation with direct contact with beneficiaries. We have responded positively to that feedback, adapting our delivery as necessary. We have also created a Development Team made up entirely of beneficiaries from both programmes which whilst in early stages is providing a solid foundation for the future. It is particularly encouraging that both funded programmes are experiential research providing the opportunity to learn and share from other delivery partners. This together with the lessons learned on our involvement with AHRC projects – mainly Hydro Citizenship – supports our beneficiaries development and involvement.
