The Company uses canal boats as our main engagement tool. It is entirely staffed by volunteers, the majority of whom.by design, have progressed through the project. During the current year we have had 2 major Lottery funded streams, IGNITE (14-19 yrs of age outside of mainstream education) and Float Your Boat (Over 50yrs at risk of social isolation). The majority of beneficiaries on both programmes are struggling with health, confidence or educational needs and thereby respond very positively to the environment on and around the boat.

The loosening of restrictions had 2 impacts. Firstly we were able to recover 2 of our boats from a boatyard where they had been in lockdown. Refurbishment which had been paid for had not been completed leaving them in an unserviceable condition. 1 boat was disposed of whilst the other underwent a 'refurbishment' by volunteers who refused to be disheartened by this malicious setback. Attempts to recover the outstanding money from the boatyard are in process.

Secondly the reduced fleet and heightened anxiety by some of our clients affected their ability to return to the project The acquisition of the former Lock Keepers House to create a Hydro Citizen Exploration Hub has added to our delivery offering. It has acted as a catalyst for returning volunteers to carry out work on both the boat and the hub. It has extended our offering and our reach to vulnerable adults with the delivery of a new programme of pre-apprenticeship resulting in positive outcomes for 32 young people, including employment and apprenticeship offerings. A limited number not ready for the work place have continued their development by working with craftsmen and volunteers to refurbish the boat and hub. An 18 month contract was provided by Yorkshire Water to deliver a creative community engagement to deomsonstrate the potential of their site for health and well being. This is resulting from the commission we produced last year for University of Leeds.

We are also successful in participating in a 12 month School for Social Entrepreneurs Heritage Trade Up Programme. (If applicable, please just state "A social audit report covering these points is attached").

The Board is made up of stakeholders from the Academic, Community and Corporate partners together with long term volunteers. The 'consultation' has continued with responding to the constant feedback from partner organisation with direct contact with beneficiaries. Additionally, the evidence gathered from our involvement in the action-based research projects over the previous years together with current involvement has led to the creation of distinct programmes responding to the needs of the communities and individuals we work with.

We have built on the foundations of the development team which created working groups covering I.T., training, pastoral care, who have fed directly into the Board. The team is made up of beneficiaries who progressed to volunteers from over 20 years ago who have brought their experiences to influence the current provision.

This has led to appointment of the development team leader as a paid employee. Additionally other members are employed on contract to deliver specific programmes. 2 othor members are to be invited to sit on the Board in order to create a more formal and influential role for the development team.

It is particularly encouraging that both funded programmes are experiential research providing the opportunity to learn and share from other delivery partners. This together with the lessons learned on our involvement with AHRC projects – mainly Hydro Citizenship – supports our beneficiaries' development and involvement.
