My Social Enterprise assists people who are experiencing homelessness to move into supported and unsupported accommodation this year we have assisted over 35 clients to move into supported accomodation through our partnership with the London Housing Trust

We also provide work experience and training for those clients who are in tempory and supported accommodation This year we have recieved £30,000 income from training fees relating to this service from Helping Hand Housing Services Ltd (HHHS)

We have provided 40 client with over £29,000 of expense payments to support their voluntary work This provided approximately 1000 days of vountary work experience with London Housing Trust (LHT) The surveys that have been returned show a 95% satisfaction rate as of the end of the year

We encourage the volunteers to use the facilityes at LHT to obtain signposting and oportunities for further work experience through the buinsess in the community scheme, who LHT are a partner
