PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

HOCCIC activities were supported by the following grants:

Postcode Local funded Habitats At Highbury – a programme which enabled the community to help create habitats in the Orchard, and culminated in the production of an environmental plan.

Active Citizens Fund and Awards for All 2019 contributed to A Young People's Forest School – a youth work and bushcraft programme for young people 10-16 years.

Tescos Groundworks supported our Woodland Play programme for young families.

Other funds were raised through sales of services and products, and donations. In May 2019, we suffered a large fire, an arson attack, which destroyed nearly all of our Resource Base. Our ability to provide services to schools and others was immediately set back, while we dealt with the devastating aftermath.

However, there was an outpouring of donations from individuals and businesses. These have in part been set aside for the construction of a more robust building. Funds set aside for this are reflected in the large amount <u>deferred till next year</u> in our 2019 Accounts.

Business promotion continued through several avenues: word of mouth, face to face and a regular news bulletin; posters and fliers distributed locally; and social media such as Facebook, Twitter, and our website.

Orchard events such as the Wassail (January), Summer Solstice (June), Highbury Harvest (October) and Winter Solstice (December) took place as usual. Highbury Harvest 2019 was our largest event yet and an effective fundraiser. We collaborated with a group of dog lovers to provide a festival for dogs on the day following the Harvest festival.

HOCCIC is a regular member of the Highbury Stakeholders Group that meets with other organisations active on the Highbury Estate, and led by Chamberlain Highbury trust. This enables us to produce a protocol about activities common to all of us, move forward in harmony and discuss issues that come up.

We consult with our community on a regular basis at sessions and workshops, through discussion groups facilitated by a Talking-Listening Stick, and, for young children, a Floor Book which enables them to tell us what they are thinking via mark-making. We also encourage interaction with our bulletins and Facebook comments by creating links to our email address and website, and by asking for comments.

Following the arson attack in May this year, we set up a separate Facebook page, where people were able to express their feelings about the Fire, and make suggestions for healing responses (a new garden, healing events and workshops).

- People tell us they like to see the changes and developments in the garden over the seasons, and to know that we use the harvest to create bespoke produce. The Rhubarb cordial is popular, but we had a smaller yield of apples this year.
- Families enjoy the games and activities that connect their little ones to nature. Sessions
 give the children confidence to play with a mud kitchen, trail making and helping to build a
 campfire. It entices them to be active outdoors in cold weather.
- A small group of young people have attended new sessions on Bushcraft especially for them. Alongside this, we collaborated with Youth Work Europe to engage with young people in the area and discover their needs. There has been a reduction in youth services which leaves their energies undirected. There is a small but vocal cohort of young people who are concerned about Climate Change, with whom we want to work more closely.
- The well-being group enjoy the mix of the wild and cultivated landscape and the opportunity to contribute to its upkeep. For some, this is a way of giving back into a community which supports them emotionally. The opportunity to meet other people, and to work as a team are also strong reasons for attending. We were pleased to work collaboratively with General Public's art project The Pomology Project, which explored outdoor arts and crafts relating to the traditional orchard celebration of Wassail. This stimulus provided an additional boost to the well-being group, Stick Around, and we have agreed to work with General Public again.

In 2019, we have once more broadened the membership of our Board and team meetings and now have a wider representation of the community contributing to them.


