The directors present their annual report and the financial statements for the year ended 31 December 2018.

Principal activity

PEF Trading Limited was incorporated on 13 February 2012 with the company's principal activity being the provision of resources in support of the ThinkForward programme. These activities were completed in 2015. The Directors will consider other similar trading activities as the opportunity arises.

Results

The directors report a net loss for the financial year of £323 (2017: £30). There has been no trading activity during the period and all expenses relate to bank charges.

Future prospects and going concern

The directors have reviewed the performance and financial forecasts of the business on a regular basis.

During 2015 the secondment agreement with ThinkForward Social Impact (1) Limited was completed and there have been no further activities undertaken since. On this basis the Directors have not prepared the financial statements on a going concern basis for the year ending 31 December 2018.

1 Accounting policies

1.1 Basis of preparation

The accounts have been prepared in accordance with applicable United Kingdom accounting standards and the Companies Act 2006.

The accounts have been prepared under the historical cost convention. During 2015 the secondment agreement with ThinkForward Social Impact (1) Limited was completed and there have been no further activities undertaken since. On this basis the Directors have not prepared the financial statements on a going concern basis for the year ending 31 December 2018. No adjustments were necessary as to the amounts at which the remaining net assets are included in these financial statements.

1.2 Turnover

Turnover is stated net of VAT and trade discounts.

1.3 Expenditure

Expenditure is recognised on an accruals basis, inclusive of value added tax.

1.4 Cash flow statement

The company has taken advantage of the exemption covered by FRS 1 not to prepare a cash flow statement.

There are no staff employed by PEF Trading Limited.
